TEA REMARKS

Dr. Abe Saavedra, TEA Monitor: Thank you. Thank you for accommodating my schedule. I was traveling today, the flight was delayed and I really apologize for being late this evening. As you know, I have been a TEA Monitor for the last 2 years here at South San and unfortunately the appointment of the Monitor has not brought the requisite change that your students need and deserve in the areas of Board Governance, financial stability in the district, as well as improvement of academic programs. You have received the appointment letter, changing my appointment from Monitor to Conservator and vesterday I believe you received the 47page final report from TEA. That was not a pretty sight. I intend to spend more time in the district, working with Mr. Yzaguirre and his staff and I am also looking forward to continuing to work with you the Board in my new role as Conservator. I see a successful appointment of a Conservator, as appointment where no directive is issued by the Conservator, at all. If nothing else, I'm just here I guess to keep everybody in bounds and not let you get out of bounds. And so if you don't get out of bounds, there won't be no directives issued, and I think that would be a successful appointment. And it's within your power, your authority, for that to happen. I've been informed of the fiasco that occurred earlier today and I think without having looked at the video yet, I think you handled it correctly. Everyone needs to understand that these public meetings will be conducted with the proper decorum, and order, and respect. And you Mr. Superintendent, the district, you have the resources to maintain order and I think you did that earlier today and I commend you for it. I am hopeful that this Board will be the Board that finally turns the wheel, turns the page to a different South San. All you Principals are here, first of all congratulations, I understand its Principals month, congratulations folks. I can tell you all of your employees, your community, wants a better school district. They want a better image for their school district than what they have had. And in spite of what happened earlier this evening, I think you are on the right track. I think you delivered a strong message that you're not going to put up with that type of behavior. And so before I sit down I would like to remind the Board that you still have major financial deficits that have continued your budget. I know y'all have talked about it already and as the report stated, you also have major inequities. The services to students are not the same. You have a responsibility to do something about that and I would encourage you to do that. One of the things that the appointment letter addressed was that there needs to be a needs assessment in the areas of Board Governance, Academics, and Finances. I have already talked to Mr. Yzaguirre and the staff, we will be working on that. I really think that quite frankly as well as these schools have done, that major article a few weeks ago, front page on a Sunday, you know very few districts get that kind of coverage on a positive note but you did. As well as they have done, they can do better, with better resources, better support and again you have the authority and the power and the resources to be able to accomplish that so if you don't do it for anyone else do it for these students. You have a responsibility. Ignore the adults that are here for other reasons and you do what you need to do. And with that I will sit down. Thank you.
