### TEA MONITOR REMARKS/REPORT

Dr. Abe Saavedra, TEA Monitor: Thank you, thank you Mr. Lopez and good evening members of the Board. First I apologize for not being able to be with you this evening other than on the screen. I'm traveling, and my wife and I are traveling, and are out of town and will not return until next week. But I do want to commend the Board, the August Monitors Report I believe was probably one of the most positive reports that this Board has received since my appointment almost 2 years ago, so I would encourage you to continue the good work that you've been doing. And agreeing

with Mr. Rodriguez, continue to do the right things that are right for children. I encourage you to do the right things. Also, my last comment is to remind you that you still continue with a deficit and that deficit will never go away until the Board acts on specific recommendations to be able to bring the budget back within the revenue that comes in. So I encourage you to continue to work on that. Those are all of my remarks, and I thank you for the opportunity. Thank you.

### SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)

Henry Yzaguirre, Superintendent of Schools, addressed the Board and audience thanking the parents for the great attendance in the recent month. He stated that our attendance is going up. He spoke on the states accountability rating, which is how the state grades us, stating we were supposed to be given the ratings on September 26<sup>th</sup> but now it will be released towards the end of October. He stated that we would be in the Express News because our Domain 1 (student achievement scores) made a lot of progress. He added that we met with a reporter last week. He stated that we are seeking a demographer to get accurate community data. He stated that our state implemented campus security audits will be starting this week and will be year round. He informed that a new radio system was rolled out between campuses and departments. He highlighted the child nutrition program as they had an administrative review through the Texas Ag Dept., and the report shows no findings. He said it is not an easy audit, and he thanked Mrs. Rice and her team for their hard work. He stated that we received a \$70,000 donation for West Campus HS.
