The district pursued two avenues to fill the vacancies of the Cafeteria Manager and Assistant Manager. The first, to post the position for qualified applicants; and second, to pursue bids from food service management companies by soliciting a Request for Proposals (RFPs). The posting garnered four candidates, with only one holding the requirements for the position. The candidate turned down the position due to financial restraints. Two bids were received from food service management companies. An administrative team scored the bids per the RFPs criteria. Chartwells was selected as the most responsive bid to the RFPs.
