What Does This Mean?

Under the authority of the Safe Drinking Water Act, the U.S Environmental Protection Agency (EPA) Established the action level for lead in drinking water at 15 ug/l. this means PWS's must ensure that water from taps used for human consumption do not exceed this level at the 90% of the sites sampled (90th percentile value) . the action is the concentration of a contaminant which if exceeded, triggers Treatments or other requirements which a PWS must follow. Because lead may pose serious health Risks, the EPA has established a Maximum Contaminant Level Goal (MCLG) of zero for lead. The MCLG is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLG,s allow for a margin of safety.

What Can I Do To Reduce Exposure To Lead IF found in my drinking water

- Run your water to flush out lead. If water has not been used for several hours
 Run water for thirty seconds to two minutes before using it for drinking or cooking.
 This helps flush any lead in the water that may have leached from plumbing.
- Use cold water for cooking and preparing baby formula. Do not cook with, drink
- Water, or make baby formula from hot water tap. Lead dissolves more easily in hot water
- Do not boil water to remove lead. Boiling water will not reduce lead.

What are the Health Effects of Lead

Lead can cause serious health problems if too much enters your body from drinking water Or other sources. It can cause damage to the brain and kidneys and can interfere with the production of red blood cells that carry oxygen to all parts of your body. The greatest risk lead exposure is to infants, Young children, and pregnant women. Scientist have linked the effects on the brain with lower IQ in children. Adults with kidney problems and high blood pressure can be affected by low levels of lead more than healthy adults. Lead is stored in bones and it can be released later in life. During pregnancy The child receives lead from the mother's bones which may affect brain development.
