I understand that online courses require students to be self-disciplined and to work independently in order to be successful in the course.		
I understand that the student is responsible for following and keeping up with the online course syllabus and pacing guide as provided by the online teacher.

I understand that internships, jobs, and extracurriculars may be affected by not maintaining the virtual privilege and are not excused absences from attending in person when you are not in good standing.		
I understand that because of liability issues, students who have virtual lab 1st period may NOT ride the bus to school and then leave campus.		
I understand that because of liability issues, students who have virtual lab 8th period may NOT leave campus and return to ride the bus home.		

I understand that students with 8th period virtual lab or all virtual labs at the end of the day may not return to campus once they have left.		
I understand that students with 1st period virtual lab must not be late to 2nd period.		
I understand that on Block Days, the same leave early/arrive late rules apply for ONLY 1st and 8th period. 2nd and 7th students do not have that privilege. If you arrive late or leave early those days, you will need a parent note and it will not be excused unless for a reason listed in the attendance policy.		
I understand that I must obtain an Off-Campus Pass in order to leave early or arrive late.		
I understand that the Off-Campus Pass may be revoked if not in good standing or at IA's Administration's discretion.
