# **DISCUSSION**

- 5. Superintendent's Report
  - 5.1. Communications/Recognitions
    - 5.1.1 Dr. Sever handed out the Open House Schedules and let the Board know site maps will be printed soon once staff arrives back.

- 5.1.2 Board members signed up to attend two site visits each throughout the year with Dr. Sever.
- 5.1.3 Mrs. Carender, Rafer ELA teacher, will be moving to the ELA Intervention position. Interviews for 8<sup>th</sup> grade ELA will be this week.
- 5.1.4 Over the 4<sup>th</sup> of July holiday, our neighbors at the Kingsburg Care Center had to evacuate after a power outage left them with no air conditioning. Thank you to our staff who jumped into action to ensure they had a cool, safe place to go. The Rafer gym was quickly turned into a triage center as the Kingsburg CERT Team and Kingsburg Care Staff transported patients across the street and eventually to other local facilities.
- 5.1.5 The next EdCare Board meeting is tomorrow. There is an anticipated increase of 6.29% for medical and 12% for dental insurance. We have asked Mr. Rodriguez to review the budget to see if it is possible to increase the District cap for insurance to absorb this increase for staff. This item will be brought to the Board at the next available meeting. The only change in insurance will be an enhancement to the vision plan.

# 6. Assistant Superintendent's Report

- 6.1. Beyond the Bell Summer Program- Students enjoyed a June and July full of engaging activities and adventures. Activities varied by grade and included numerous swimming trips to the Crandell Swim Complex for public swimming, an unforgettable day at Yosemite Sugar Pine Railroad, and movie outings to see Inside Out 2 and Despicable Me 4. Our students also had the chance to experience the magic of Peter Pan on Broadway in Hollywood and cheer on their favorite team at a Dodgers vs. Giants game at Dodgers Stadium. One Hundred 4th-7th graders had fun hiking the Bob Jones Trail at Avila Beach. Younger students explored the Zoo, and Adventure Park, and Urban Air Trampoline Park. We enjoyed local activities like Farm Day Friday at Spirit Horse and Pelican's snow cones. We were also excited to partner with the City of Kingsburg to provide Red Cross swim lessons for 166 TK-2nd grade students. We also held CPR/First Aid training for 65 students. Both of these programs were due to the generosity of a grant from the Tri County Health Care District. The summer wrapped up with festive closing ceremonies at Rafer with Rick Alonzo Painting and teaching students about persevering and being resilient.
- 6.2. Another highlight was the introduction of the "Parents Coffee Break" during the June session of Summer School. Parents and guardians were invited to drop by the Roosevelt Auditorium after dropping off their students at Roosevelt or Rafer. They enjoyed coffee and breakfast goodies while meeting special guests, including principals, the School Resource Officer, the district nurse, the Director of Student Services, KCAPS, City Council Members, Spirit Horse staff, and more. Parents received valuable information about the upcoming school year, school site details, and summer community activities. Daily giveaways included backpacks, school supplies, art supplies, books, and crafts, making each day special for those who attended.
- 6.3. To go along with our July theme of "Kingsburg Summer Olympics" we partnered with the Kingsburg Library and 32 downtown businesses. We developed a "scavenger hunt" type game. We requested videos from current and retired Olympic, Paralympic, and professional athletes. They created videos specific for our community. There are 32 posters downtown with QR codes to the videos. Get your scorecard and map at the library. When you complete the score card you will get a lanyard with sports keychains. It is exciting to see the community walking downtown and playing this game. We are excited that 9 of the videos are from current Olympic athletes who competing in Paris.
- 6.4. Mr. Stovall shared summer school data showing improved in most grade levels.
- 6.5. Thank you to Mrs. North, Ms. MacAdam, all the teachers, paras, principals, and food services employees who worked to make this all possible.

# 7. Chief Business Official's Report

7.1. Projects Update

- 7.1.1 The Reagan awnings have been painted. Banner Pest Control will put foam between the awnings and the building to avoid birds.
- 7.1.2 There was a chiller leak at Lincoln that has been repaired.
- 7.1.3 <sup>1</sup>HVAC work at Washington and Lincoln is progressing and will be completed before the start of school.
- 7.1.4 Classrooms have been modernized at Washington and Lincoln.
- 7.1.5 The Roosevelt office has new tack boards and carpet.
- 7.1.6 The tech offices are still in progress but are expected to be completed soon.
- 7.1.7 The Roosevelt office furniture is on its way.
- 7.1.8 We are working with Beynon to get a finalized estimate for painting the basketball courts at Rafer. We hope to have them done before school starts.
- 7.1.9 The gym sign at Rafer will be completed before school starts.
- 7.1.10 The grounds team is continuing to beautify our campuses and get things ready for staff and students.
- 7.1.11 Our custodial teams are continuously deep cleaning classrooms and preparing schools for staff and students.
- 7.1.12 The attendance audit is complete, and we look forward to the financial component in October.
- 7.1.13 The prep work for the intervention building at Reagan will be going out to bid on July 25.
