**Purpose of Position:** Provides specialized expertise, support and coaching for classroom teachers in assisting with the full implementation of Common Core State Standards, the District's core instructional program, and the California Standards for the Teaching Profession (CSTPs).

#### **Essential Functions:**

- Provides support and assistance to classroom teacher with an emphasis in a specialized area such as, elementary, secondary, or special education, with the full and skillful implementation of the Common Core State Standards and the District's core instructional program, support materials and instructional strategies, and California Standards for the Teaching Profession;
- Assists teachers with building and maintaining an engaging classroom environment focused on the content and learning strategies embedded within lessons:
- Assists teachers with developing effective classroom management strategies that include positive behavioral supports;
- Utilizes transformational coaching to facilitate and empower teachers' personal and professional goals;
- Serves as a resource in identifying appropriate instructional strategies and interventions to improve student achievement for all students, including students with diverse learning needs;
- May model instructional and/or behavior management strategies;
- Conducts site visitations and collects observational data to support development of teachers' professional goals;
- Designs and delivers professional development for staff support, including New Educator Orientation
- Participates in ongoing professional learning to stay current with coaching practices;
- Collaborates with other instructional coaches, program specialists, and instructional leaders;
