#### SUBJECT: PUBLIC EXPRESSION AT MEETINGS

All meetings of the Board shall be conducted public, and the public has the right to attend all such meetings. Public expression at such meetings shall be encouraged and a specific portion of the agenda shall provide for this privilege of the floor. At its discretion, the Board may invite visitors to its meetings to participate in the Board's discussion of matters on the agenda.

Guidelines for Public Participation

Community residents having questions or concerns regarding the day to day activities of the operation of the schools and the district are encouraged to contact the persons charged with immediate responsibility for the activity or issue that gives rise to their questions or concerns. These contacts can be by written correspondence, telephone or scheduled meetings. The persons to contact include teachers, counselors, supervisors, building administrators, and district office personnel. It is always best to make contact first with school or district personnel most closely associated with the activity or concern in question.

If that first contact results in an unsatisfactory response to the issue at hand, then it should be brought to the next highest level of authority. If the issue is finally brought to the attention of the Superintendent of Schools, and it remains unresolved, it would be appropriate to bring the matter to the attention of the Board of Education in any one of several ways:

- a)Letter addressed to the Board, 13 Beckwith Ave., Scottsville, 14546;
- b)Telephone a Board member;
- c)E-mail a Board member;

d)Attend a Board meeting and present the concern in keeping with the procedures set forth below. Community residents or parents/guardians should be mindful that Board members acting individually lack the authority to resolve problems or concerns. However, in conjunction with the other members of the Board, they collectively supervise the Superintendent in his/her role as chief school executive. Continued POLICY32202of 2Community RelationsSUBJECT:PUBLIC EXPRESSION AT MEETINGS (Cont'd.) Procedures for Public Participation at Board MeetingsThe Board will set aside a period of time for public comment or question by district residents or parents/quardians at the start of each regularly scheduled meeting. Ideally, that period of time will not exceed a total of thirty (30) minutes. Once this segment of the Board meeting has been completed, the public may not ask questions or make comments to the Board of Education for the remainder of the meeting, unless permittedby a majority of the Board. This public participation time is intended for use by district parents and taxpayers to allow them to communicate with the persons elected to represent them on the Board. The comments or questions should concern matters included on the agenda for that meeting or matters that the residentor parent/guardian has brought to the attention of the school or district officials in accordance with the guidelines set forth above. The Board President will allocate time to individuals according to the number of persons seeking to speak, and each speaker will be expected to abide by the time constraints. Speakers are expected to identify themselves by name and address. If a group of people share the same question or concern, they should select a representative spokesperson to speak on behalf of the group and that person should so identify him or herself before addressing the Board. Any person reading from a written statement will be expected to submit a copy of that statement to the board. Speakers will adhere to the Districts Code of Character, Conduct, and Support. Speakers will not use individual employees or students names when making public comments. These guidelines and procedures set forth above are intended to ensure that the Board of Education can have effective communications with the district's residents and taxpayers, while insuring that the Board has adequate time to conduct the district's business as set forth in the agenda for each

meeting. It would be inappropriate and unacceptable for members of the attending public to disregard these guidelines and procedures, thereby preventing the Board from conducting the business it must complete for the benefit of the students and community. Therefore, the Board respectfully requests the cooperation of all concerned. The Board of Education reserves the right to enter into executive session as specified in Policy #1730 --Executive Sessions. Below is the text of Section 105:

#### §105. Conduct of executive sessions.

- 1. Upon a majority vote of its total membership, taken in an open meeting pursuant to a motion identifying the general area or areas of the subject or subjects to be considered, a public body may conduct an executive session for the below enumerated purposes only, provided, however, that no action by formal vote shall be taken to appropriate public moneys:
- a. matters which will imperil the public safety if disclosed;
- b. any matter which may disclose the identity of a law enforcement agent or informer;
- c. information relating to current or future investigation or prosecution of a criminal offense which would imperil effective law enforcement if disclosed;
- d. discussions regarding proposed, pending or current litigation;
- e. collective negotiations pursuant to article fourteen of the civil service law;
- f. the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation;
- g. the preparation, grading or administration of examinations; and
- h. the proposed acquisition, sale or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof.
- 2. Attendance at an executive session shall be permitted to any member of the public body and any other persons authorized by the public body.
