

**Regular Meeting
September 20, 2022**

Opening

Call to Order

At 5:32 p.m. School Board President Jessica Marelli called the September 20, 2022, Caesar Rodney School District regular meeting to order.

Roll Call

Members present in addition to President Marelli were Vice President Dave Failing, Board Members Mr. Michael Marasco, Dr. Joyce Denman, and Executive Secretary Dr. Christine Alois. Mr. P. Scott Wilson was not present.

Adoption of Agenda

Mr. Marasco made a motion to adopt the September 20, 2022 agenda with two date corrections under Personnel Matters. Dr. Denman seconded the motion and after roll call, the motion carried 4-0 with one absent (Marelli, Marasco, Failing, and Denman).

Approval of the August 17, 2022, Regular Meeting Minutes

Mr. Marasco made a motion to approve the August 17, 2022, regular meeting minutes as presented. Dr. Denman seconded the motion and after roll call, the motion carried 4-0 with one absent (Marelli, Marasco, Failing, and Denman).

Approval of the September 14, 2022, Special Meeting Minutes

Mr. Marasco made a motion to approve the September 14, 2022, Work Session Meeting Minutes as presented. Dr. Denman seconded the motion and after roll call, the motion carried 4-0 with one absent (Marelli, Marasco, Failing, and Denman).

Executive Session I

At 5:34 p.m. Mr. Marasco made a motion to go into Executive Session I the purpose of which is to interview for the Supervisor of Finance, Payroll, and Position Control and to discuss personnel matters. Dr. Denman seconded the motion and the motion carried 4-0 with one absent. (Marasco, Marelli, Failing, and Denman).

At 7:13 p.m. Mr. Marasco made a motion to come out of Executive Session I. Mr. Failing seconded the motion and the motion carried 5-0. (Marasco, Marelli, Failing, Wilson, and Denman).

Dr. Alois amended the roll call. Mr. Wilson was present.

Presentations

David E. Robinson Elementary School

A video was shared with the Board. Dr. Ashley Matticks, Assistant Principals introduced the video which was put together by a student. He interviewed several students and staff on what makes Robinson Elementary so special. Dr. Matticks thanked the Board.

Statewide Assessment Results

Mrs. Tara Faircloth, Director of Curriculum and Instruction, gave the Board an update on the statewide assessment results. Grade levels and the subjects assessed were shared. Year-to-year comparisons are not

appropriate due to the recent pandemic year. She shared what the district is doing to help our students improve. State averages were also shared. Mr. Marasco asked how the online SAT testing is doing nationally. Mrs. Faircloth stated she would be able to get this information for the Board.

School Safety

Mr. Jimmy Pennewell shared the facility's safety plan updates. Training and activities throughout the district were shared. He recently attended training from DEMA, regarding reunification which is organized for moving students in an emergency. We will be doing training throughout the district. We are working with the I Love U Foundation, ALICE (Active Shooter) 2 days of training for each building. We have partnered with the Delaware State Police (DSP) vulnerability assessment will be completed for our buildings. Current funding for the safety training was also shared. Radio communications will also be upgraded.

Mr. Wilson stated our administrators should be supportive of the Department of Justice. He received information regarding a principal who was less than cooperative with a safety concern. He stated this needs to be addressed immediately. All administrators should cooperate with the Department of Justice at all times. He likes what Mr. Pennwell is doing with safety in the district. Mr. Marasco inquired about the Delaware State Police (DSP) building assessments. Mr. Pennewell stated these will be done over the school year.

Dr. Alois thanked Mr. Pennewell for his active role in school safety and security.

Communications

Superintendent

- Dr. Alois stated we are excited to announce our new assistant superintendent. Dr. Jessilene Corbett will be on board in October. The team is near complete.
- Dr. Alois shared an update from the Strategic Planning Committee. They have finished focus groups, refining the mission, vision, core values, and key priorities. One final meeting is coming up in early October and then will format and finalize to present to the board in October/November. All information is found on our website.
- Dr. Alois announced this week is Historically Black Colleges and Universities (HBCU week). Members from DSU will be joining us for the Game on Friday. We are taking 78 CRHS students to the HBCU college fair on Friday at the Chase Center in Wilmington.
- Dr. Alois shared some funding news. We were awarded just over \$475,000 in grant funds to support work in professional learning for all of our elementary schools and their building administrators. The "elbow to elbow" coaching has had a positive impact on the implementation of high-quality instructional materials. In addition, the grant will fund K-12 Illustrative Mathematics professional learning in a similar format. The environmental specialist also received a grant of \$227,000 to further environmental education. She added this is from a grant from the National Fish and Wildlife Foundation. The grant comes as part of the Delaware Watershed Conservation Fund. CRSD is the only school district in the country to receive a grant of this kind. Both grants were featured on WMDT.
- Dr. Alois gave some social media updates. Advertisements for Project Thrive which provides free mental health services to eligible DE students have been posted. You can dial 2-1-1 or see your specialists at your school and receive services.
- Dr. Alois shared teachers have participated in training on our last in-service day to begin "Take Care DE" here in CR. As a reminder from a previous presentation, Take Care Delaware uses the Handle with Care model to build awareness and provide support, as needed, for students who may have been exposed to a traumatic event the day prior.
