

RSF Athletics Code of Conduct and Sportsmanship Agreement

I, _____, understand and agree to the following terms and conditions to ensure accountability and responsible behavior while participating in a sport at R. Roger Rowe.

1. Commitment to team: I will prioritize the team's goals and success, adhering to the team's values and guidelines set by the Athletic Director and coaching staff.
2. Respect: I will treat my teammates, coaches, staff members, and officials with respect and professionalism, fostering a positive and supportive team environment.
3. Compliance with rules: I will comply with all the rules and regulations established by the South Coast Middle School League and R. Roger Rowe School.
4. Training and practice: I will attend all required training sessions and practices, actively engaging in skill development and team preparation.
 - Student-athletes who miss 5 practices/games will receive a grade drop (i.e. A to a B)
 - Student-athletes who miss 8 practices/games will not be allowed to participate on a school team and will move into General PE.
5. Integrity: I will uphold the highest standards of integrity, both on and off the field, and refrain from any behavior that could bring disrepute to the team or school.
6. Positive representation: I will represent the team and school in a positive light, understanding that my actions reflect on the team's reputation and overall image.
7. Compliance with policies: I will adhere to the school's policies on cell phone usage, understanding the consequences of non-compliance. Cell phones are not allowed during practices or games, unless given permission by the Athletic Director or coach.
8. Sportsmanship: I will demonstrate good sportsmanship during games and competitions, respecting opponents, coaches, referees, and officials, regardless of the outcome.
9. Accountability: I understand that any violation of this agreement may result in disciplinary action, including suspension or termination from the team, at the discretion of the Athletic Director, coaching staff, and school administration.
10. Language: I will refrain from using any form of profanity or offensive language at all practices, games, and athletic events.
11. I will maintain good academic standing with a minimum 2.5 Grade point Average with no D's or F's and a minimum grade of "S" in Citizenship. I

understand that I will be on probation and only be permitted to participate in practices until my grades improve. Mr. Rossier and Ms. Fox will be speaking to students during Advisory about their status and what they need to do to regain eligibility.

Uniforms must be returned by the end of the season in good condition. There will be a \$150 fee for uniforms not returned by the end of the season.

Student-Athletes who fail to follow the code of conduct and sportsmanship agreement will face probation, which allows them to participate in practices but not in games. In severe cases, they may be suspended from the team. This process ensures that all members uphold the standards of behavior expected in our athletics program.

****Students will not be permitted to "switch" sports after the first two weeks of practice****
