### **Parental Responsibility and Involvement Requirements (VA Code §22.1–279.3) and FCPS Code of Student Conduct**

### **School Attendance**

I have read and understand the Frederick County Public Schools' Policy, 405P - Compulsory Attendance/Exclusions and Exemptions from School Attendance. Under the Code of Virginia 22.1-254, I understand that my child should attend school.

### **Computer Network and Internet Use**

### **Portable Communication Devices**

I have read and agree to abide by the Portable Communication Devices regulation (FCPS 219R) as described in the Student and Parent Handbook as evidenced by my signature below.

### **Frederick County Public Schools' Rapid Communication System**

I consent to receive autodialed and/or pre-recorded calls/text messages from or on behalf of Frederick County Public Schools via the Frederick County Public Schools' Rapid Communication System at the telephone number(s) included in my child's student record. I understand that I may opt out of receiving such communications at any time by notifying my child's school in writing and that such notification will remain in effect through the end of the current school year and must be renewed annually.

### **Lock-Down Drills**

Each Frederick County public school shall hold a lock-down drill at least once during the first 20 days of each school session and one additional lock-down drill after the first 60 days of the school session. Pre-kindergarten and kindergarten students are exempt from mandatory participation in lock-down drills during the first 60 days of the school session. Each pre-kindergarten and kindergarten student participates in each lock-down drill after the first 60 days of each school session. (Virginia Code Section 22.1–137.2)
