CJUSD Expanded Learning and Opportunities Grant (ELOG) was developed in collaboration with students, parents, teachers, staff and community stakeholders, including the CJUSD Department of Behavioral and Mental Health and our extended learning partners. Student achievement and attendance data as well as parent and school climate surveys were reviewed at Parent LCAP, DELAC and AAPAC meetings, and parent feedback from these meetings provided additional information for our needs assessment. Students and staff provided input during virtual meetings and through email. Data and stakeholder input identified actions to implement in all seven supplemental instruction and support strategies. A draft of the CJUSD Expanded Learning Opportunities Grant was shared at DPAC English and DPAC Spanish meetings, and updated with their input before going to the CJUSD Board for approval.

A description of how students will be identified and the needs of students will be assessed.

CJUSD tiered systems of support are integrated to utilize the evidenced-based Positive Behavioral Interventions and Supports (PBIS) three-tiered framework and the Response to Instruction and Intervention (RTII) multi-tier school improvement approach to provide early academic and behavioral supports to struggling students.

CJUSD utilizes a variety of diagnostic and formative assessments to identify academic and social-emotional needs and to monitor student progress. Student Engagement Plans include processes for school teams to monitor academic engagement, attendance, health, and social emotional needs while establishing communication with parents and guardians to identify barriers to learning. Working together, schools build relationships between students, parents and staff as they plan support for students.

Schools and parents may also agree to refer students requiring additional support to the CJUSD Behavioral and Mental Health or Pupil Services Departments to further identify needs and supports.

Student data is housed in the District Student Information System, and uploaded into the District Dashboard to ensure student data is available to administrators and teachers. In addition, each site has a School Plan for Student Achievement (SPSA) which includes actions to monitor and support students in identified subgroups.

CJUSD school sites individually invite students to programs and activities specifically designed to address individual students' needs. District and school websites, social media, and program flyers will also notify parents and guardians of the opportunities for supplemental instruction and support. CJUSD ensures information is provided to parents in their preferred language by asking parents to designate the preferred language for communication when they register students in school. A Language Line is available to all staff for phone translation in any language, and sign language interpreters are available to provide services when needed. All written communication is available in English and Spanish.

A description of the LEA's plan to provide supplemental instruction and support.

CJUSD Expanded Learning Opportunity Grant (ELOG) plan for supplemental instruction and support includes increased Social Emotional Support, Parent Engagement, extended day, intersession and Summer School programs and activities as well as an online credit recovery for deficient students to complete graduation or grade promotion. Services will be provided by certificated and paraprofessional staff, as well as partnerships with local colleges and universities to seek college student tutors to support student learning. Consultants and extended learning partners will provide enrichment activities and experiences such as art, drama, dance, music and sports to release classroom teachers for collaboration and staff development; and providing transportation for after school programs. Technology and hotspots to support student learning and access to internet. Extended school library hours to provide learning hubs for students' access to high-speed internet as well as reading and research materials. Staff Development for teachers and paraprofessionals on how to facilitate quality and engaging learning opportunities for ALL students and how to engage students and families in addressing academic and social-emotional needs, including trauma-informed practices.

CJUSD is coordinating Expanded Learning Opportunities Grant funds with other ESSER funds to fully serve the educational needs of our district. ESSER funds provided the instructional materials, technology, and student supports we needed to provide district-wide distance learning, and to provide the tools and equipment we need to reopen schools to meet new space and safety requirements. CJUSD expanded learning opportunities grant plan seeks to build rigor, relevance and relationships in an equitable, culturally proficient learning environment. ELO Grant funds will be utilized to provide Student Supports to engage students and families while addressing social-emotional needs and barriers to learning as we return to in-school learning.

An LEA receiving ELO Grant funds under EC Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income.
- English learners,
- foster youth,
- homeless students.
- students with disabilities.
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

#### For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental

instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, EC Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
