LOCAL GOVERNANCE

BOARD MEMBERS

- **BBD – Board Members: Training and Orientation**
 - Clarifies that a trustee's duty to complete Public Information Act training after a violation cannot be delegated to the public information officer, per HB 3033
- **BBFA – Ethics: Conflicts of Interest Disclosures**
 - Clarifies that a trustee's duty to disclose financial or personal interest in board transactions goes beyond statutory conflicts of interest, but includes potential conflicts of interest with a vote on a pending matter



BUSINESS & SUPPORT SERVICES

SAFETY & SECURITY

- **CKC – Safety Program / Risk Management: Emergency Plans**
 - Requires the development of administrative procedures on notifying parents of violent activity that occurred or is being investigated at a campus or district activity
- **CKE – Facility Standards: Safety and Security**
 - Revised to comply with HB 3
 - Adds terms for Student Resource Officer programs
 - Includes a list of SRO authority & duties
- **CKEC – Security Personnel: School Resource Officers**
 - Deletes this policy and moves the terms to CKE

TAXES, TECHNOLOGY

- **CCGB – Ad Valorem Taxes: Economic Development**
 - Revises the policy on the Chapter 313 tax abatement program as the program is expiring
- **CQC – Technology Resources: Equipment**
 - Adopts the model health and safety guidelines for effective integration of digital devices in schools, as developed by the TEA and the HHSC

PERSONNEL



TERMINATIONS, COMPLAINTS

- DCE – Employment Practices: Other Types of Contracts
 - Specifies that a non-Chapter 21 contract employee may request a hearing before the Board to appeal termination during the contract term
- DGBA – Employee Complaints / Grievances
 - Adds clarification on cross-references to other employee complaint processes

INSTRUCTION & STUDENTS



INSTRUCTIONAL & LIBRARY MATERIALS

- EFA – Instructional Materials

- Updates criteria for selection of instructional materials, in alignment with SBEC criteria and administrative regulations
- Revises the process for reconsidering instructional materials

- EFB – Library Materials

- Updates criteria for selection of library materials, in alignment with standards issued by TSLAC
- Revises the process for reconsidering library materials



HOMEBOUND SERVICES, COMPLAINTS

- **EEH – Instructional Arrangements: Homebound Instruction**
 - Clarifies that a student may receive homebound services for psychological reasons and the weeks of confinement don't have to be consecutive, per updates to the Student Attendance Accounting Handbook
- **FNG – Student & Parent Complaints / Grievances**
 - Adds clarification on cross-references to other employee complaint processes

- GF – Public Complaints / Grievances
 - Adds clarification on cross-references to other employee complaint processes
