President Jennifer Durney convened the regular meeting of the Aberdeen School District Board of Directors at 5:00 p.m. Tuesday, April 19, 2022, at Central Park Elementary School and via webinar following guidance for conducting remote meetings in compliance with the Open Public Meetings Act. Directors present were Jessica Jurasin, Annica Mizin and Suzy Ritter along with Student Representative Alexis Durr, Superintendent Alicia Henderson and 28 patrons and staff watching remotely. Director Jeremy Wright was excused. The meeting began with the flag salute.	CALL TO ORDER
On a motion by Director Jurasin and seconded by Director Ritter, the Board approved the Consent Agenda, which included the minutes from the regular meeting on March 22, 2022; payroll vouchers 832428 through 832468 for March totaling \$3,637,511.63; General Fund vouchers 832569, 832476, and 832478 through 832568 totaling \$904,010.28 and ASB Fund vouchers 832469 through 832475 and 832570 totaling \$19,818.06; approved an overnight trip request from Aberdeen High School and Miller Junior High School for students to travel to the YMCA's Camp Bishop for Outdoor School on May 31-June 3, and accepted gifts to the district from Timberland Bank, Greater Grays Harbor, Hanner Enterprises, Ingram, Zelasko & Goodwin, Sierra Pacific Foundation and Darrell Bellis totaling \$7,800 in support of Business Week at Aberdeen High School received and from the Moore Wright Group, which donated 24 cases of white, all-purpose glue to Miller Junior High School. Superintendent Henderson provided an update on health and safety measures in the district. She reported that the state Board of Health voted this week not to require a COVID vaccine for students to attend school and noted that it is	SUPERINTENDENT REPORT
expected the current health and safety protocols promoting hygiene and optimal air quality in schools and the workplace will remain in place when schools resume next fall.	HEALTH & SAFETY
Superintendent Henderson provided an update on the school gardens program and the Farm to School program.	
Superintendent Henderson reported on the instructional program in the district. She noted that Business Week is taking place this week for juniors, the SkillsUSA students performed exceptionally well at the state conference with three students capturing state titles, and that graduation ceremonies will resume their traditions this year. Harbor High School graduation is on Thursday, June 9, at Harbor High and Aberdeen High School is on Friday, June 10 at Stewart Field.	INSTRUCTIONAL PROGRAM
Superintendent Henderson reported that hiring for summer school sessions is almost complete.	
Superintendent Henderson reminded board members that the WSSDA Region 5 meeting is planned for 6 p.m. Monday, April 25, at Shelton.	WSSDA REGIONAL MEETING

Executive Director of Business and Operations Elyssa Louderback presented the Fiscal Status Report for March 2022. She reported an ending fund balance of \$2,504,497.59 in the General Fund, \$1,847,937.23 in the Capital Projects Fund, \$1,121,542.91 in the Debt Service Fund, \$288,723.04 in the ASB Fund and \$363,428.32 in the Transportation Vehicle Fund. With 58.33 percent of the fiscal year elapsed, the district has received 48.08 percent of budgeted revenue and is at 50.52 percent of expenditures.

Director Louderback discussed budget projections for the 2022-23 school year. She reported the revenue projection tool has not been issued yet by OSPI, that the district has begun posting some positions for 2022-23, and that following the state Board of Health's decision not to require vaccines for students, she is comfortable proceeding with an enrollment projection of 3,085 FTE, which is 15 less than this year's budget but reflects current enrollment. Director Louderback also noted that use of the ESSER funds has been extended for another year, and the district anticipates using some of those funds to maintain staffing.

Principal Joan Hoehn presented an overview of Central Park Elementary School and its school improvement plan. She and Preschool Coordinator/ECEAP Director Cyndy Mitby presented an overview of the Hopkins Preschool and ECEAP program in the district.

An update to Policy 1400 Meeting Conduct, Order of Business and Quorum changing the Board's meeting time to 6 p.m., along with updates recommended by WSSDA, was presented for first reading.

A new policy, Policy 5515 Workforce Secondary Trauma, was presented for first reading as recommended by WSSDA and to establish a new workforce mental health committee to comply with state law.

On a motion by Director Jurasin and seconded by Director Mizin, the Board approved an affiliation agreement with Grays Harbor College allowing students in the nursing program to gain clinical experience at schools.

The Board approved renewal of the Interdistrict Cooperative Agreement with the New Market Skills Center, which allows Aberdeen students to enroll at the Skills Center for courses not offered in the district.

On a motion by Director Ritter and seconded by Director Jurasin, the Board approved the 2022-23 school calendar. The first day of school will be August 31 and the last day of school will be Wednesday, June 14.

On a motion by Director Jurasin and seconded by Director Ritter, the Board approved an additional \$57,500 to complete the purchase of new equipment for the weight room at Sam Benn Gym.

MEETING CONDUCT, ORDER OF BUSINESS, AND QUORUM

Board meetings will be scheduled in compliance with the law, and as deemed by the board to be in the best interests of the district and community. The board will function through (1) regular meetings, (2) special meetings and (3) emergency meetings.

A. Regular Meetings

Regular meetings are held at <u>6:00</u> p.m. on the first and third Thursday <u>Tuesday</u> of each month in the Community Room of the J.M. Weatherwax High School or at other times and places as determined by the presiding officer or by majority vote of the board. An agenda of business to be transacted must be posted on the district website not less than twenty-four (24) hours in advance of the published start time of the meeting, unless the district does not have a website or employs fewer than ten full-time equivalent employees.

If regular meetings are to be held at places other than the Community Room, or are adjourned to times other than a regular meeting time, notice of the meeting will be made in the same manner as provided for special meetings. All regular meetings of the board will be held within the district boundaries. When a regular meeting date falls on a legal holiday, the meeting shall be held on the next business day.

B. Special Meetings

Special meetings may be called by the chair/president or at the request of a majority of the board members. A written notice of a special meeting, stating the time and place of the special meeting and the business to be transacted will be delivered to each board member. Written notice will also be delivered to each newspaper and radio or television station that has filed a written request for such notices. Written notice may be delivered personally or by mail, facsimile or electronic mail. The notice must be posted on the district's website unless the district 1) does not have a website, 2) employs fewer than ten full time equivalent employees; or 3) does not have an employee whose job description or employment contract provides a duty to maintain or update the website.

The district must also prominently display the notice at the main entrance of the district's headquarters as well as at the location of the meeting if the meeting is held at a location other than the headquarters.

All required notices must be delivered or posted not less than twenty-four (24) hours prior to the meeting.

The written notice requirement will be deemed waived if a member:

- 1. Submits a written waiver of notice to the board secretary at or prior to the time the meeting convenes. The waiver may be given by telegram, fax, or electronic mail; or
- 2. Is actually present at the time the meeting convenes.

Final disposition will not be taken on any matter other than those items stated in the meeting notice.

C. Emergency Meetings

In the event of an emergency involving fire, flood, earthquake, possible personal injury or property damage, the board may meet immediately and take official action without prior notification.

D. Public Notice

Public notice will be properly given for any special meeting; whenever a regular meeting is adjourned to another time; or, when a regular meeting is to be held at a place other than the Community Room.

All meetings will be open to the public with the exception of executive or closed sessions authorized by law. Final action resulting from executive session discussions will be taken during a meeting open to the public as required by law.

Individuals with disabilities who may need a modification to participate in a meeting should contact the superintendent's office no later than three days before a regular meeting and as soon as possible in advance of a special meeting so that special arrangements can be made.

During the interim between meetings, the office of the superintendent, as board secretary, will be the office of the board. The district's public records will be open for inspection in the manner provided by and subject to the limitation of the law.

E. Quorum and Voting

Three board members physically present will be considered as constituting a quorum for the transaction of business at a regular meeting. In the case of an emergency meeting, if it is not possible to constitute a quorum through physical presence, a quorum can be established via any communication platform.

Board members are not required to be physically present to attend a board meeting. Any or all board members may attend a board meeting and vote via any communication platform—including videoconference or teleconference-- that provides, at a minimum, simultaneous aural communication between those present, provided:

- 1. The meeting is properly noticed with any required passwords or authorization codes;
- 2. The meeting is accessible to the public;
- 3. The meeting accommodates any member of the public who wishes to participate, and
- 4. The communication platform is generally known and accessible to the public.

F. Meeting Conduct and Order of Business

All board meetings will be conducted in an orderly and business-like manner using *Roberts Rules of Order (Revised)* as a guide, except when such rules are superseded by board bylaws or policies. The order of business will be that indicated in the agenda. Any additions or

changes in the prepared agenda may be requested by the superintendent or a board member and must be approved by majority vote of the board members present. At a special meeting final action may be taken only on that business contained in the notice of the special meeting.

The board will establish its regular order of business, but may elect to change the order by a majority vote of the members present. All votes on motions and resolutions will be by "voice" vote unless an oral roll call vote is requested by a member of the board. All votes will be approved by majority of those present and voting, unless otherwise required by law. No action will be taken by secret ballot at any meeting required to be open to the public.

<u>The board will take no action by secret ballot at any meeting required to be open to the public.</u> <u>Generally, the board votes on motions and resolutions by "voice" vote, unless a board</u> <u>member requests to vote by oral roll call, in which case the board will do so. A motion passes</u> <u>when a majority of those board members present and voting vote in favor.</u> <u>However,-a</u>An oral roll call vote of *all* the members of the board is required for the election of board officers, filling a vacancy on the board, or for the selection of the school district superintendent, and a majority vote of all the members of the board is required for any person to be elected or selected for such positions.

During board meetings, board members will refrain from communicating electronically (e.g., by e-mail, text, social media) with their fellow board members.

G. Public Attendance and Comment

The board recognizes the value of public comment on educational issues and the importance of involving members of the public in its meetings. In order to permit fair and orderly expression of such comment, the board will provide a period at the beginning of the meeting during which visitors may present to the board. If possible, sSuch presentations should be scheduled in advance by contacting the Superintendent's Office.

The board will also allow individuals to express an opinion prior to board action on agenda items that the board determines require or will benefit from public comment. Written and oral comment will be accepted by the board before the adoption or amendment of policies not expressly or by implication authorized by state or federal law, but which will promote the education of kindergarten through twelfth grade students in public schools, or will promote the effective, efficient or safe management and operation of the district. Individuals wishing to be heard by the board will first be recognized by the chair/president.

<u>The board may require those who wish to speak to sign in. When called forward,</u> <u>Hindividuals, after identifying themselves, will proceed to make comments within the time</u> limits established by the board. Any representative of a firm eligible to bid on materials or services solicited by the board will also be entitled to express an opinion. <u>The board is not</u> <u>obligated to respond to questions or challenges made during the public comment period and the</u> <u>board's silence will not signal agreement or endorsement of the speaker's remarks.</u> The <u>chair/president may interrupt or terminate an individual's statement when it is too lengthy,</u> <u>personally directed, abusive, obscene, or irrelevant when the allotted time has passed and</u> <u>may interrupt a speaker to require the same standard of civility that the board imposes on</u> <u>itself. Examples of uncivil comments include comments that:</u>

- 1. Are libelous or slanderous;
- 2. Are an unwarranted invasion of privacy;
- 3. <u>Are obscene or indecent pursuant to the Federal Communications Act or any rule or regulation of the Fecderal Communcations Commission;</u>
- 4. <u>Violate school district policy or procedure related to harassment, intimidation,</u> <u>bullying, or discrimination;</u>
- 5. Incite an unlawful act on school premises or violate a lawful school regulation; or
- 6. <u>Create a material and substantial disruption of the orderly operation of the board</u> <u>meeting.</u>

The board as a whole has the final decision in determining the appropriateness of all such rulings and can maintain order by removing those who are disruptive. The board recognizes the distinction between uncivil discourse, which it will not tolerate, and comments that are negative yet still civil in nature, and will maintain order in a content neutral manner.

WORKFORCE SECONDARY TRAUMATIC STRESS

The Aberdeen School Board is committed to preventing and addressing secondary traumatic stress for District personnel by supporting mental health in the workplace. Every day, school staff work with students experiencing trauma and loss. As a result, teachers, school counselors, administrators, and other school staff may experience secondary traumatic stress. When secondary traumatic stress is left unaddressed, it may lead to staff turnover, burnout, adult chronic absenteeism, and health issues that negatively impact everyone in the school community.

Secondary Traumatic Stress

The Board acknowledges that secondary traumatic stress, also called compassion fatigue, is a natural but disruptive set of symptoms that may result when one person learns firsthand of the traumatic experiences of another. Symptoms of secondary traumatic stress may include feelings of isolation, anxiety, dissociation, physical ailments, and sleep disturbances. In addition, those affected by secondary traumatic stress may experience:

- 1. Changes in memory and perception;
- 2. Alterations in their sense of self-efficacy;
- 3. A depletion of personal resources; and
- 4. Disruption in their perceptions of safety, trust, and independence.

Policy Statement

The District will promote a positive workplace climate that includes a focus on diversity and inclusion.

The Board hereby establishes a district-wide workforce mental health committee with the following functions:

- 1. Share secondary traumatic stress, stress management, and other mental health resources and supports available through the Office of the Superintendent of Public Instruction, the Educational Service District, and the School Employees' Benefits Board;
- 2. Share links to a secondary traumatic stress self-assessment tool and any associated resources;
- 3. Report to the Board at least once per year with a summary of committee activities.

The District will regularly assess district-level and school building–level implementation of this policy and procedure. The assessment will include input from the District's workforce. The District will provide appropriate resources and training to schools and staff for continuous improvement.

In consideration of the promises and conditions contained herein, ASD #5 and Bickar First-Aid Training (Denny Bickar), hereafter referred to as the Contractor, do mutually agree as follows:

I. DUTIES OF THE CONTRACTOR

The Contractor shall perform the following duties to the satisfactions of ASD #5's designee:

A. The general objectives of this contract shall be as follows:

- Provide Basic CPR and First Aid training, including infant and child CPR techniques, for employees of ASD #5;
- Issue CPR/First Aid cards to participants who meet the appropriate standards.
- B. In order to accomplish the general objectives of this agreement, the Contractor shall perform the following specific duties:
 - Collaborate with Teaching & Learning (Grace Hagen) on scheduling of the training and arranging a preferred location;
 - Provide the necessary materials to conduct the training.

II. DUTIES OF ASD #5
