### Aberdeen School Board Statement in Support of Superintendent Alicia Henderson

The Aberdeen School District Board of Directors would like to acknowledge the frustration of the community during these uncertain times. We thank you for sharing your concerns and assure you they are all heard and considered as we navigate this unfamiliar territory. As we work closely with Superintendent Henderson, we have witnessed her dedication to our district and believe she is acting proficiently and in good faith. For this, we would like to reaffirm our confidence in her this evening.

The political influence of educational funding is convoluted and has been extremely detrimental to our district. Superintendent Henderson worked tirelessly to convince the Legislature not to let this happen. The impact of the Covid-19 worldwide pandemic greatly exacerbated our previously forecasted budget challenges. With regard to the operation of schools during this pandemic, Superintendent Henderson continues to take guidance from OSPI as well as health organizations. We appreciate frequent communication updates from our Superintendent during a time when information changes quickly.

Please know that we value and encourage staff and community input. As we work toward common goals, it is essential that all parties demonstrate the same level of respect and courteousness. Staff members who have concerns about the direction of our district are encouraged to reach out to the board as well as their union leadership. This letter is an expression of our formal "Vote of No Confidence" in Dr. Alicia Henderson and her inability to run our school district competently. We do understand the severity of this decision and did not arrive at it hastily.

As of June 7, 2020, we had 965 signatures from the community on our petition. And that number continues to go up daily.

The Aberdeen School District has always been a district to be proud of, a school district where decisions were made on a collaborative basis with the best interest of our students in mind. The Aberdeen School District has always been a district that has experienced great vision from our leaders and our teachers were given the respect and support to achieve our goals which unfortunately is not the case anymore.

Throughout the past few school years we have had concerns regarding Dr. Alicia Henderson's leadership specifically concerning the severe absence of transparency, trust, collaboration, decision making, vision for future goals, and the lack of respect for parents and staff. The disregard for providing true communication, investment and vision for our district is most distressing.

Superintendent Dr. Alicia Henderson's inability to create positive working relationships with staff members and the community as a whole has created an environment of distrust, intimidation and retaliation that makes staff and administrators fearful to speak out on behalf of our students, parents and community. And recent decisions made on staffing has turned some teacher's worlds upside down. Some teachers are now having to teach subjects they haven't taught for over 20+ years or haven't taught these subjects at all in their career. How are these decisions beneficial for students or teachers? Yes these teachers have certificates for different subject but if you haven't taught math for example in the last five or in some cases 20+ years it's definitely different now and a quality education will not be achieved for our students.


For these reasons stated above, We the undersigned Parents, Citizens and Tax Payers of the Aberdeen School District are submitting a "Vote of No Confidence" in Dr. Alicia Henderson, to the school board members on the June 16th, 2020, school board meeting.

Please send this anonymously because I teach in the district.

I have worked in the district going into my 7th year. I listened to the budget meeting in April and as I was listening, my spouse said, "She doesn't have to do this right now". In the midst of a pandemic, with all of our worlds thrown upside down, she decided to ramp up more fear by planning to do away with jobs. The provisional teacher RIF's came out during Teacher Appreciation Week. I have never felt more devalued in any profession I have worked in than I do now. When Mike Villareal applied for the Superintendent position, his interview and ideas inspired me. I went to school the next day feeling so empowered and lucky that I got students to change their lives. Im sad he did not get the position in Aberdeen, and one only has to look beyond Myrtle Street to see how his district is doing. One only has to look to Ocosta, where Mike's works, to see how their district is doing. We can do better, we must do better for the sake of everyone who lives in Aberdeen, This is not mission impossible, except under the current administration. Good candidates can be found, and we will be well served by having our ESD 113 send an interim in to right the ship. SOS is the correct acronym for this project, because we and our students desperately need a lifeline now.

Sherri is loved at that school and needs to be moved back. According to the Washington State Report Card, enrollment was 909 students in 2014-2015 and was 965 this last year. Graduation rates were 75.8% in 2014-2015 and was up to 82.1% this last year. Sherri is doing a wonderful job.

At the board meeting when concerned citizens were upset by Dr. Henderson's poor decision, Sandra Bielski stated that we should ask Sherri to see her evaluations to shine some light on her moving schools. I encourage all of you to look at her evaluations because I'm sure it has always been exemplary.

The stories being told by a high school teacher at our town hall meeting is that she refused to stop a protest from the students that Dr. Henderson demanded to be stopped. Sherri would not comply with refusing students constitutional rights. Then guess what happened? That's correct, retaliation. I was unable to reach Ms. Northington for a statement, but I ask you all to look into this. Imagine how it will look if the reporters we have been in contact with start investigating that.

I do not personally know Sherri Northington and the only time I have met with her was during my child's IEP meeting. I don't want you to think this is coming from someone fighting for their friend. I am a parent of a special needs child that needs Ms. Northington at the high school because Ms. Northington is wonderful.

You are allowing a huge mistake to be made. I watched as Barb Page was ripped from her school and I cannot stand by and let her continue to do this. Should we bring up Derek Cook? Dr. Henderson told us that he was trying to return to Hoquiam to finish his career. Do you really believe that? Call him!

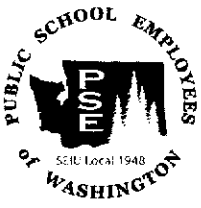

Open Public Meetings; I have reached out to several districts around the state to find out how they are handling their School Board Meetings. Several of them ARE allowing public comment during their meetings, via phone calls and chat. I saw the notice under the School Board Tab on the ASD5 home page the Provide Public Comment document, which brings me to this;

*"The proclamation requires that these remote meetings include an option for telephonic access, such as those embedded in a Zoom or Go-To Meeting, for the public to attend. Those attending the meeting must be able to hear each other at the same time.*

*This means it would be insufficient to record the meeting and later post it on your website. Instead, the public must be able to hear the persons talking while the meeting is underway. Similarly, the public must be able to hear oral public comment, if there is oral public comment."*

*Per the Governor's Proclamation 20-28.....transparency in state government and all of its political subdivisions is an important state policy, such that all statutes related to open public meetings and public records are the business of the state;...and there are a plethora of electronic, telephonic and other options that make it possible for the public to attend open public meetings remotely;...and for the public to attend the proceedings through, at a minimum, telephonic access, and may also include other electronic, internet or other means of remote access, and (b) provides the ability for ALL persons attending the meeting to hear each other at the same time.*

.....if the agency permits oral public comment at a meeting for other reasons, its remote participation arrangement will also need to have a means for each member of the public who is speaking to hear each other, not just to hear the members of the governing body who are speaking.

Now, the AGO recommends providing notice online, including by uploading the agenda and information on how members of the public can attend and participate. Other more active ways to provide electronic notice include emailing stakeholders, posting on social media, and issuing news releases.

SO, explain to me why Aberdeen is NOT allowing public comment at the board meetings, when you all continually say how important transparency and community involvement is to the success of our district.

I would appreciate a response from each of you.

## Lack of Public comment & concerns of withholding information

About a month ago (5/19/19) I wrote to [schoolboard@asd5.org](mailto:schoolboard@asd5.org) about concerns of lack of public comment available to your community. All I have seen since is a letter on the website. It basically implies that WSSDA guidance tells you that you don't have to read them out loud in the meeting, and you can post them. Then the letter states that this is similar to other districts and names 7 of them. Last it states that you will continue to look for strategies that allow the public to share comments. So far you have changed nothing and have not tried any new strategies. In my original letter I asked that you at least publish the letters for all to see. I looked up these 7 districts for you. I know you have busy schedules and may not be able to spend time verifying all of the information you are given by the superintendent. First of all of those 7 districts listed 2 of them post the emails with videos of their board meeting or on their website. 2 of them read the emails during their board meeting. At best the statement that we are similar to these other districts is a stretch of the truth designed to give a false sense to your community that you are doing the same as others. 3/7 do the same as us from your examples (43%).

Then I looked at that source more carefully there are a few in that document that were not mentioned by your letter, but did mention their strategy for board meeting comments. Mercer Island is the same as us, Bellevue reads the comments in the meeting, and Spokane still allows speakers. In total the document you based your letter off has 4 same as us, and 6 with more transparency and more willing to share their public comments. We are in the minority.

I tried to look up local districts but many do not have a statement posted on how they handled it. I am waiting for some email responses from them, but I did find out that Elma allows comments typed in chat and responds to them during their meeting. I also checked through several districts similar to our size. I found out that Riverview and Ellensburg are the same as us, while Washougal & Selah publish the comments with their board stuff online. Many others still have not responded.

Next is the biggest issue I have with something I heard at a board meeting from Superintendent Henderson. She said, "The only area that we have a savings is in heating." This was talking about saving money during the shutdown. She went on to talk about propane down \$2000. Water, sewer and all that going up. Then she talked about cleaning going up & food service losing money. I wanted to research that because it seemed odd to me.

According to your financial records from board meetings:

- Aberdeen sanitation is currently near \$1,224 when a couple months ago it was near \$7,800. Last year at this time it was near \$3,600.
- Cascade (natural) Gas is currently near \$8,300 when a couple months ago it was near 18,000. Last year at this time it was near \$9,500.
- Ferrel gas (propane) is currently near \$1,900 when a couple months ago it was near \$800. Last year at this time it was not listed so assumed \$0
- Harbor Disposal is currently near \$800 when a couple months ago it was near \$1,800. Last year at this time it was near \$1,200.
- Masco/Petrocard (Fuel) is currently near \$1,00 when a couple months ago it was near \$10,635. Last year at this time it was near \$15,400.

- PUD is currently near \$22,000 when a couple months ago it was near \$52,000. Last year at this time it was near\$51,000.

All of this leads to a total savings of about \$52,000 per month compared to a couple months ago, and a savings of \$36,000 per month compared to last year at this time.

The only thing she said we were saving on is actually one of the few things that went up (Propane). Her statement at best is trying to manipulate others to believe her, when she should know the facts.

She neglected to even mention one of the biggest savings our district has during this shutdown Payroll & Benefits.

Looking at previous months board documents it is easy to find the payroll and benefits numbers. There are 2 pages listed with withdrawals that all have to do with payroll, & benefits. For the most part these should be somewhat steady with some fluctuation for subs and other factors. A couple of months ago the total amount was near 3,589,339 and now that amount is listed near 3,434,512. This is a savings of about 155,000 per month.

Put all of these savings together to get a savings of approximately \$190,000+ per month for 3 months (1/2 March, April, May, 1/2 June). That is more than \$570,000 savings in these areas.

Why did she decide to say, ""The only area that we have a savings is in heating.""

It sounds like at best she decided to only give the information she wanted everybody to hear, and none of you questioned her any further on it.

When you evaluate her this year, please at least do not extend her contract. I would hope you would also ask her to start giving all pertinent information to you and the community.

## ABERDEEN SCHOOL DISTRICT NO. 5

### Minutes of the Regular Meeting of the Board of Directors – June 2, 2020

President Sandra Bielski convened the regular meeting of the Aberdeen School District Board of Directors at 5:00 p.m. Tuesday, June 2, 2020, via webinar following guidance for conducting remote meetings in compliance with the Open Public Meetings Act. Directors present were Bill Dyer, Jennifer Durney, Jessica Jurasin and Suzy Ritter, along with Superintendent Alicia Henderson and 159 patrons and staff watching remotely.

The meeting began with the Flag salute.

On a motion by Director Bill Dyer and seconded by Director Jennifer Durney, the Board approved the Consent Agenda, which included the minutes from the regular meeting on May 29, 2020.

Director Suzy Ritter offered comments thanking staff and community members for sharing their thoughts and concerns, commended the students and families for continuing to engage with their schools during a tumultuous time, and read a shared statement from the Board of Directors regarding the public comment.

Director Jessica Jurasin offered comment in support of continued conversations regarding issues of concern about the budget and district operations.

Directors Bill Dyer and Sandra Bielski expressed condolences to the family of David Wilhelms, spouse to former AHS choir teacher, the late Pat Wilhelms.

The Board received written public comment from Alexa Amarok, Tiffany Burkett, Ian Dorsch, Christine Hill, Kathryn Hirschfeld, Alicia Morris, Tricia Sorensen, Cathleen Wilder and Julia Woods.

On a motion by Bill Dyer and seconded by Jennifer Durney, the Board adopted on second reading an update to Policy 2410 Graduation Requirements. The update includes transitioning from a trimester to semester schedule for the class of 2024.

Superintendent Henderson provided a report on planning for the 2020-2021 budget. She reported that schools have continued to reach out to families to determine their plans for the fall. Since the last board meeting, the percentage of families contacted has increased from 96 percent to 99.2 percent with an additional 60 students identified as planning to be enrolled in the fall. She will be recommending an adjustment in the enrollment projection from 3,000 to 3,060. In addition, she reported the state budget should be released later in June with conflicting reports on whether the Legislature will convene a special session to deal with budget issues, and that the district continues to absorb a shortfall in the Food Service program, although CARES Act funding is earmarked to help offset the cost. She also noted that there have been questions about how much the

district is saving as a result of the closure and she said the only are of savings is in heating, as all staff have continued to be paid and resources have been used to clean and sanitize buildings.

Superintendent Henderson provided an update on the district's ongoing COVID-19 response. She noted that preparations are being framed for the fall with the purchase and training for the learning platform, Canvas, which is one of the platforms supported by the state.

Superintendent Henderson said schools are awaiting word from the state on options for the fall from a state level work group that is due to issue its report on June 8. She said preliminary reports indicate an array of options is likely, with districts selecting the option that best fits their community. With that in mind, she is convening a local Reopening Task Force to explore what a return to school will look like in Aberdeen. Regarding sports, everyone is still awaiting guidance from WIAA, although the district has begun looking at whether to offer e-sports.

Superintendent Henderson shared information about awards ceremonies and plans for graduating the Class of 2020. Graduation is Friday, June 12, with Miller Junior High and the grade schools planning to conduct remote "moving up" ceremonies and assemblies at various times.

Teaching and Learning Director Traci Sandstrom presented the Teaching and Learning Report for May. Director Dyer commented that he appreciated the information about Canvas.

CTE Director Lynn Green provided information about Career and Technical classes being offered online this summer, and planning for the fall.

On a motion by Jennifer Durney and seconded by Suzy Ritter, the board approved Resolution 2020-07 renewing the Washington Interscholastic Athletic Association as the governing body for student sports.

The next meeting of the board is set for 5 p.m. Tuesday, June 16, 2020, to be conducted remotely with proper notice and access provided under the governor's emergency provisions of the Open Public Meetings Act with instructions for joining the meeting to be posted on the ASD5 website with the agenda.

At 5:51 p.m., President Sandra Bielski recessed the meeting for an executive session expected to last 30 minutes under RCW 42.30.110 (g) (to evaluate the qualifications of an applicant for public employment or to review the performance of a public employee. At 6:21 p.m. the meeting was extended for an additional 5 minutes. The regular meeting reconvened at 6:28 p.m.

**Re: Aberdeen students eligible for \$399 to buy food**

Dear Aberdeen School District Families,

Because COVID-19 closed our schools, your children are likely eligible for up to \$399 in food assistance, called Pandemic EBT (P-EBT): Emergency School Meals Program. These benefits will be on an Electronic Benefits Transfer (EBT) card which can be used like a debit card to buy groceries.

P-EBT provides families with funds to make up for the cost of meals while school was closed. This benefit is for Washington children in grades K-12 who receive free or reduced-price school meals. Because of the high percentage of students eligible for free and reduced lunch in our district, we are being advised that every student who was enrolled at the time schools were closed is eligible for this assistance.

Every eligible child may receive **up to a maximum of \$399** of P-EBT. Immigration status does not matter for P-EBT – it is not Basic Food and will not count in a public charge test. P-EBT is intended to replace meals missed while schools are closed due to COVID-19. Children are allowed to continue to get free meals from the school sites and get P-EBT at the same time – they are separate programs.

If your family does not receive Basic Food, you must apply for P-EBT if you want to receive the funds. The application will open by June 30.

- Is attending a school where meals are free for all students

#### CAN IMMIGRANT HOUSEHOLDS APPLY?

Yes. Using P-EBT benefits does not count as a public charge. P-EBT does not change a parent or child's immigration status. P-EBT replaces school meals and are for all families that receive free and reduced-price school meals.

#### WHAT IS THE BENEFIT?

For children who received free or reduced-price meals when schools closed in March, each family will get \$399 per child. For families that enrolled in Basic Food or applied for school meal benefits after schools closed, each child will get less than that. The value depends on when you applied for food assistance.

#### IMPORTANT INFORMATION

- Applications for P-EBT must be completed by August 31, 2020 or before the start of the 2020-2021 school year—whichever is later.

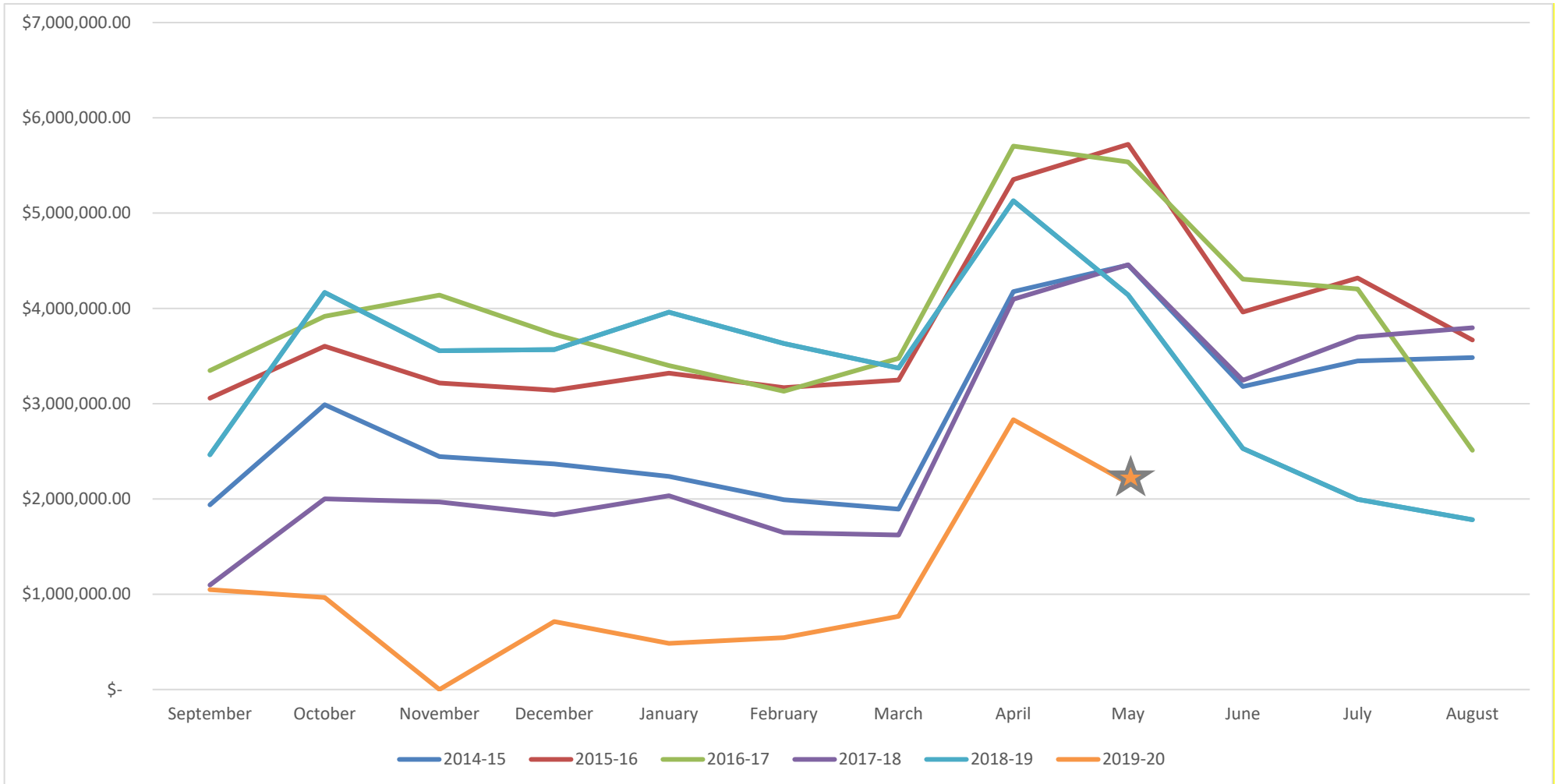

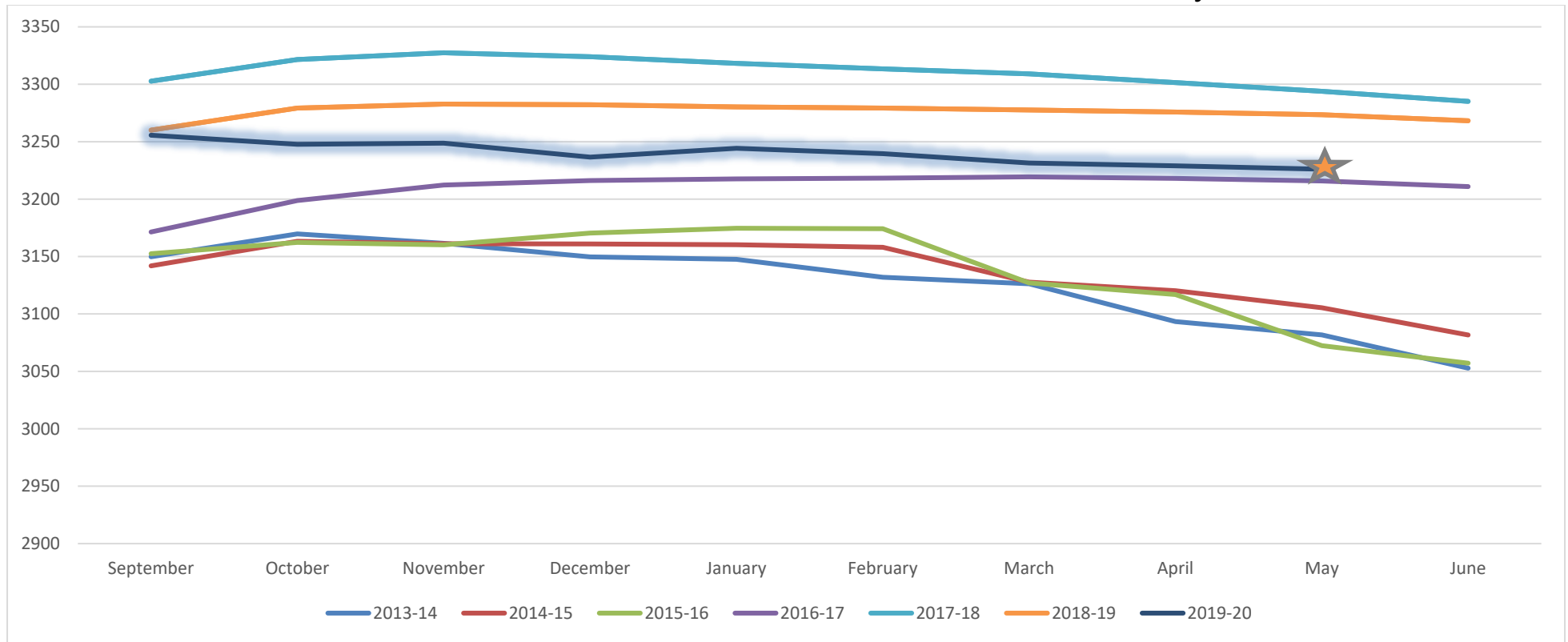


# GENERAL FUND FUND BALANCE TRENDS

The content can be scaffolded to accommodate all levels of students. Some of the material can be read aloud in class and students can access pieces of the book through audiobook on youtube.com for free. Also, the materials provided in the Bridge to College curriculum include scaffolded learning and lessons to help teachers support students of all ability levels. Because the book is a higher lexile, portions of the text will be exercises in skimming and scanning to help students discern important information while other more narrative pieces of the book will be read independently for tone/mood and events that move the story along.

The book is interesting for all gender types as it is about history, untold stories in history, real life, and the people who continued to build our nation. The book has mostly female characters, but includes minor and very strong male characters along with positive portrayals of African Americans and other minorities using historically correct settings and information.

*Hidden Figures* is historically correct non-fiction written about a unique "secret" in American history. While some of the background and detail of the book is a higher level of reading than students are used to, the unit has strategies to help students discern meaning from the text. Parts of the book are more engaging narratives about the women involved in the team of computers (human computers) that NACA hired during WWII. Through the study of the text, students will learn about the history of African Americans, women, the space race, and more. Students will analyze relationships, reasoning, and behaviors through the eyes of a variety of people. The final assessment involves a research project, giving students an opportunity to answer questions raised during the unit.

The book is interesting for all gender types as it is about relationships, war, personal growth, and human flaws. The book has mostly male characters, but includes one minor and very strong female character along with positive memories of females in the soldier's lives.

## **INTERDISTRICT COOPERATIVE AGREEMENT TWIN HARBORS, A BRANCH OF NEW MARKET SKILLS CENTER**

This Agreement by and between Aberdeen School District No. 5 (hereinafter referred to as "Host District") and the other member districts (hereinafter referred to as "Member Districts") provides for the operation of the Twin Harbors, A Branch of New Market Skills Center (hereinafter referred to as "Skills Center.") The Host District and the participating districts together will be referred to as "consortium districts" as listed below:

Aberdeen School District No. 5  
Hoquiam School District No. 28  
Lake Quinault School District No. 97  
Montesano School District No. 66  
North Beach School District No. 64  
Ocosta School District No. 172  
Raymond School District No. 116  
South Bend School District No. 118  
Taholah School District No. 77  
Willapa Valley School District No. 160  
Wishkah Valley School District No. 117

It is agreed by and among the several parties hereto as follows:

### **I. Needs and Purposes of Operation**

The Skills Center is established to provide students with regional access to comprehensive, industry-defined career and technical education that prepares students for careers, employment, apprenticeships and post-secondary education. This Agreement is intended to avoid unnecessary program duplication and purchasing of expensive training equipment by individual districts, and to provide flexibility in operation which will facilitate rapid program adjustments and most emergency educational needs as they arise.

### **II. Terms of the Agreement**

The terms of this Agreement shall be for a period of ten (10) years on a fiscal year basis effective September 1, 2020 through August 31, 2029. The term of this Agreement is subject to provisions of withdrawal and dissolution herein contained. Any amendments to agreement shall be submitted to Office of Superintendent of Public Instruction Career and Technical Education.

III. Location of Serving Facility

The Skills Center campus is located at 416 North G Street, Aberdeen, Washington 98520. The Administrative Council shall have the authority to consider other program sites if/when appropriate in accordance with any criteria specified in the Revised Code of Washington or the Washington Administrative Code.

IV. Membership and Participation

A. A Member District is defined as those districts eligible for full rights, privileges and responsibilities to include full representation on the Administrative Council. Districts eligible for and considered to be members of the signing of this Agreement are: Aberdeen School District, Hoquiam School District, Lake Quinault School District, Montesano School District, North Beach School District, Ocosta School District, Raymond School District, South Bend School District, Taholah School District, Willapa Valley School District and Wishkah Valley School District.

B. The Host District is the Aberdeen School District No. 5. The Host District is also a Member District. A Participant District is a school district, private school or individual public school that is not a Member District as defined in Paragraph IV (A). A Participant District may apply to the Administrative Council to allow students to attend the Skills Center and pay a per student fee as to be determined by the Administrative Council.

V. Administrative Structure

A. The Governing Board shall consist of the Skills Center Administrative Council, which will consist of the Superintendent or his/her designee from each Member District. Representatives on the Council shall have an equal vote. The Skills Center Director will serve as the secretary and ex-officio member of the Administrative Council.

B. The Administrative Council will govern the Skills Center under the direction and policies formulated and shall have the following responsibilities:

1. Ensure the Cooperative is operating in a manner consistent with this Agreement and in accordance with the laws and regulations of the State of Washington.
2. Formulate and establish policies and procedures relating to the operations of the Skills Center intended to differ from the general operational policies and procedures of the Host District.

3. Receive and act on recommendations from the Member Districts, the Skills Center Director, and such advisory committees as might be connected to Skills Center programs.
4. Review and/or approve rules and regulations concerning operations of the Skills Center.
5. Review organization and staffing levels of the Skills Center.
6. Review and approve the course offerings.
7. Review the slot assignments of students from the Member Districts.
8. Review budget information on an annual basis.
9. To establish and amend policies and procedures to govern Administrative Council organization, composition and conduct.
10. Be responsive to the Director of the Skills Center to assist with operational decisions and emergencies.

C. The Host District shall have the following responsibilities:

1. Select, supervise, evaluate, and employ a career and technical education certified Skills Center Director on terms and conditions approved by the Administrative Council. The Director shall be responsible for carrying out the administrative functions in accordance with the policies, rules and regulations adopted by the Administrative Council and will be an employee of the Host District.
2. Operate and manage the Skills Center in accordance with the Host District policies and procedures unless the Administrative Council specifically addresses an issue in a policy or procedure of the Cooperative.
3. Hire, evaluate, and if necessary, terminate the employment of employees consistent with the budget, policies and procedures of the Administrative Council.
4. Provide support in the areas of personnel, finance, technology and special education.
5. Maintain and operate facilities, as funds are available.
6. Act as fiscal agent for the Skills Center and maintain separate accounts and fund balances for each fund.

7. Review and adopt the skills center budget as a part of the Host District budget.
8. Provide such services as may be mutually agreed upon by the Host District and the Skills Center.

VI. Description of Joint Financing Arrangement

A. Capital Investment:

1. It is hereby mutually agreed that existing building facilities and equipment have been provided and maintained in accordance with program needs as approved by the Administrative Council.
2. Pursuant to RCW 28A.245.100, the Host District shall maintain a separate Minor Repair and Maintenance Capital Account for facilities constructed or renovated with Skills Center state funding. Member and Participant Districts must make an annual deposit into the account to pay for future minor repair and maintenance costs of those facilities as determined on an annual basis by the Administrative Council. The amount of the deposit shall be reviewed annually and will be based on the Member and Participant District's averaged student counts from the October P223 report.
3. Future capital improvements and major facility equipment purchases shall first be financed through the Minor Repair and Maintenance Capital Account. Any expenses in excess of the Minor Repair and Maintenance Capital Account shall be financed according to a separate plan to be adopted by the Administrative Council and submitted to the Board of Directors of the Member Districts in this Agreement for approval. Capital investment funding shall be prorated among all member districts party hereto based on the share value and slot allotments as determined by the Administrative Council.

B. Cost of Operations

1. The cost of operating the Skills Center shall be met in the following manner:
  - a. State apportionment funds from state support for secondary students enrolled in the Skills Center.
  - b. Any federal, state, local or private allotments, grants or contract training agreements received expressly for the Skills Center.

- c. Any interlocal FTE agreements between the Skills Center and community and technical colleges.
- d. Operating costs not covered by Section VI(B)(a-c) may be prorated among all member districts party hereto based on the share value and slot allotments as determined by the Administrative Council.

2. Definition of Terms

- a. Cost of Operation: Cost of operation is defined to mean the total cost of operating the Skills Center program but specifically excludes capital investments and major items of equipment.
- b. Student Enrollment Hours: Student enrollment hours are hereby defined to mean the hours for which each student is enrolled and carried on the Skills Center register without regard to the actual attendance of students at the Skills Center.
- c. State Apportionment Funds: State apportionment funds are those funds paid by the state in support of approved program offerings of the Skills Center. For this Agreement, funds shall follow the student to the Host District at an FTE calculated by enrollment in programs and average weekly minutes of each program. This shall apply to students from both Member and Participant Districts.
- d. Slot: A slot is a measure of participation and consists of the equivalent program of funded enrollment per 180-day calendar.

3. Procedures

- a. An annual program budget shall be developed by the Skills Center Director and submitted to the Administrative Council for approval. When approved, the budget shall be transmitted to the Board of Directors of the Host District for action. A program budget account and format shall be maintained for auditing, accounting and reporting purposes.
- b. The Host District shall report student enrollment and claim state apportionment up to 1.0 FTE for each student enrolled in the Skills Center in accordance with state guidelines, with the Skills Center first claiming its share of FTE, followed by the sending Member or Participant Districts. Students enrolled in both a high school and a skills center may be claimed up to a total of 1.6 FTE based on their enrolled hours. Each student from a Member or Participant District enrolled at the Skills Center for a three period session will be counted for apportionment purposes by the Host District for a minimum of .5 FTE (or an FTE percentage in alignment with

OSPI) per student. A student may qualify for additional classes from the Sills Center (i.e. additional program hours, summer school, a second skills center program, etc.). Remaining FTE will be allocated based on enrollment hours.

- i. Exceptions to minimum enrollment requirements may be made by a vote of the Administrative Council.
  - ii. Minimum enrollment exceptions may be reviewed for re-approval by the Administrative Council.
- c. Each Member District's entitlement to a percentage of allocation of student slots shall be based on total enrollment in grades 9-12 of the Member Districts as reported to OSPI in October of each school year. Exceptions to this distribution may be allowed with the consent of the Administrative Council.
  - d. Unused slots by one Member District may be used by another Member District on a first-come, space available basis.
  - e. If there are remaining enrollment opportunities, they may be used by non-participating districts or by non-public schools with approval of the Administrative Council. Participant and home schooled students must enroll in their district or residence or complete an Inter-district transfer and enroll in a Host District high school for the time they are attending the Skills Center.
  - f. The Host District shall claim any other federal, state, local or private grants or allotments available to the Skills Center.
  - g. The Host District shall control, monitor, and audit all financial transactions at the Skills Center by following procedures of the State Accounting Manual and report to the Administrative Council at each of its meetings on the financial status of the Skills Center. The Host District shall identify any additional costs and present the matter to the Administrative Council prior to preparation of the budgets by the Consortium Districts.
  - h. The Host District shall charge no more than five percent (5%) of the apportionment dollars received by the Skills Center for its operation. Extraordinary expenses for costs such as attorneys' fees and litigation costs approved by the Administrative Council will be paid by the Host District and amortized over a period of time agreed between the Administrative Council and the Host District.

- i. Transportation costs to and from the Skills Center for transporting students in district buses shall be borne by the district of student residence.
  - j. Any situations not covered in the foregoing provisions shall be resolved by decision of the Administrative Council.
4. Students with Disabilities
- a. The resident district understands, acknowledges, and agrees that it is ultimately the entity responsible for ensuring that the substantive and procedural rights of its students with disabilities are being afforded in a way that complies with all applicable federal and state laws and regulations, including its obligation to provide disabled students with a Free Appropriate Public Education. The resident district also understands, acknowledges, and agrees that it remains solely responsible for the providing of related services to disabled students; including providing or funding the cost of transportation, para educator support, interpreter, or assistive technology support if the disabled student's IEP or Section 504 plan calls for such services.
  - b. In order to ensure that the resident district can meet its obligations for students with disabilities who attend the Skills Center, the Skills Center agrees it will:
    - i. Follow any disabled student's Individualized Education Plan (IEP) or Section 504 Plan when the student is receiving educational services from the Skills Center, including providing any appropriate accommodations and modifications.
    - ii. Make a staff member available to participate in an IEP or Section 504 team meeting for a disabled student who is or may be attending the Skills Center when such participation is requested by either the resident district or the parent/adult student (telephonic participation is an acceptable method of participation).
    - iii. Alert the resident district if the disabled student violates a rule or regulation of the Skills Center that will result in the disabled student being excluded from the Skills Center, so that the resident district may conduct timely manifestation determination reviews.
    - iv. Provide information regarding the student's program to the IEP or Section 504 team upon request, including providing information as part of an eligibility evaluation or re-evaluation.

- c. The parties jointly agree that if a claim, complaint, or due process hearing is brought in relation to a disabled student who is attending the Skills Center that involves the provisions of services or actions attributable to one or both parties, the parties will confer to discuss the matter and to resolve the responsibility for the defense of the allegations.
- d. Student Information:
  - i. The Skills Center shall have access to student information of enrolled students from the data resource center of the Member and Participant Districts, including, but not limited to health records, discipline records, Special Education/504 records or any information pertinent to the student enrollment at the Skills Center.
  - ii. Upon request, the Skills Center may be provided directory information related to students to the extent allowable under the Family Education Records Privacy Act (FERPA) (see Paragraph VI(B)).

VII. Program Scope, Eligibility and Retention

A. Program

The program or course offerings of the Skills Center shall be approved by the Administrative Council in keeping with the purpose and intent of the Skills Center. Programs will be voluntary and tuition free.

1. The Director will identify and recommend potential new programs based on demand as measured by input from advisory committees and labor data reviews.
2. The Skills Center's career and technical education program shall consist of career and technical courses approved by the state of Washington.

B. Approval of Courses

Only approved career and technical education courses will be offered by the Skills Center career and technical education program. All Skills Center personnel and programs shall meet state requirements for career and technical education instructors.

C. Services

The Skills Center, in cooperation with the administration and counseling staffs in the Member District high schools, shall make adequate provision for the

availability of ancillary services and shall facilitate contact to obtain employment, placement, and follow-up records on all Skills Center students.

D. Eligibility

1. Any student enrolled in a high school of any Member District, party hereto, is eligible to attend the Skills Center career and technical education programs subject to the following:
  - a. General admission requirements as established by the Administrative Council.
  - b. Requirements set by the Board of Directors of the district of student residence.
  - c. Availability of space according to the number of slots allotted the district of residence of the student. Participant and Homeschool students shall be enrolled on a space available basis.
  - d. A determination of the appropriateness of the placement in the program, including such things as attendance, disciplinary records, grades, progress towards graduation, ability to accommodate special needs, English Language Learners, etc.
2. Summer Session
  - a. The Skills Center is authorized to offer summer school when state funding is available. The purpose of the summer session is to:
    - i. Provide opportunities for students to attend approved CTE programs that are aligned with school year Skills Center programs or meeting necessary graduation requirements.
    - ii. Promote CTE and skills center programs.
    - iii. Enhance employability and industry-ready skills.
    - iv. Support the individual student's High School and Beyond Plans where students earn high school credits that meet graduation requirements.
  - b. Summer School programs will be open to students in incoming grades 9-12. Students who have completed the 8<sup>th</sup> grade are eligible to attend summer school. The Skills Center may continue to serve a graduated senior until the end of the school year (August 31) for completion of their industry certification program.

E. Retention

Retention of students in the Skills Center shall be governed by policies established by the Administrative Council and by policies of the district of residence of the student.

VIII. Resolution of Conflict

A. Mediation

A majority vote of the Administrative Council shall govern in all matters. In the event a majority vote cannot be reached by the Administrative Council on an issue requiring resolution, the matter shall be referred to a mutually acceptable third party mediator for final resolution. If the matter cannot be resolved there, it will be referred to the Superintendent of Public Instruction.

B. Due Process

Due process procedures shall be established by the Administrative Council.

IX. Withdrawal

- A. It is hereby agreed that any party (district) to this Agreement may withdraw at any time provided it shall be done in an orderly basis and pursuant to the following:
- B. In the event that a district desires to withdraw from the program, such district desiring withdrawal shall give notice in writing to all districts no later than October 1 of the fiscal year preceding withdrawal, said withdrawal to be effective on September 1 of the next succeeding fiscal year.
- C. The other Member Districts and the State Board of Education must approve the application for withdrawal.
- D. If a participating district withdraws from the Skills Center, no reimbursement will be due to the withdrawing district.
- E. Land, improvements and equipment purchased for the Skills Center shall be the property of and remain with the Host District.

X. Dissolution Provisions

The cooperative operation of the facility under this Agreement can be dissolved only under the following procedures:

- A. WAC 180-31-040 provides that procedures for the dissolution of the operation of the school plant facilities under an interdistrict cooperative plan shall not be instituted prior to the expiration of ten (10) years after the date of State Board of Education approval of the financial plan for the construction of such facilities: PROVIDED, that a request for dissolution prior to the expiration of ten (10) years may be approved when in the judgment of the State Board of Education there is substantiation of sufficient cause therefore.
- B. Any plan for dissolution in (A) above described shall be submitted to the State Board of Education for review and approval prior to proceeding with dissolution action.
- C. Upon dissolution of the Cooperative, the real property and attachments thereto will be the property of the Host District.

XI. Admission of New District

Whenever a new district wishes to become a member of the Skills Center Cooperative and have students attend the Skills Center, it shall submit to the Administrative Council a formal proposal based on approved guidelines and procedures established by the Administrative Council. The Administrative Council must review the proposal and determine acceptance of the district into the Cooperative based on approval guidelines and procedures established by the Governing Board. Approved Districts as new Member Districts shall be subject to all of the terms and conditions contained within this Agreement as they pertain to Member Districts.

XII. Gifts

The Skills Center program may receive gifts, cash, equipment or services from any source whatsoever, contingent to acceptance by the Host District.

XIII. Insurance

The Host District shall at all times during the term of this Agreement, at its cost and expense, carry and maintain general public liability insurance, including contractual liability and professional liability and/or malpractice liability coverage when appropriate, against claims for bodily injury, personal injury, death, or property

damage occurring or arising out of services provided under this Agreement. This insurance shall cover such claims as may be caused by any act, omission, or negligence of the Skills Center or its officers, agents, representatives, assigns or servants. The limits of liability insurance shall cover such claims as may be caused by any act, omission, or negligence of the Skills Center or its officers, agents, representatives, assigns or servants. The limits of liability insurance, which may be increased from time to time as deemed necessary by the Host District.

XIV. Non-Discrimination

All parties shall comply with all the federal, state, and local non-discrimination laws, ordinances, regulations and policies, which are otherwise applicable to the Host District and the Skills Center. The Skills Center does not discriminate in any programs or activities on the basis of race, creed, color, religion, national origin, age, sex, veteran or military status, marital status, sexual orientation, gender expression or identity, pregnancy, disability, or the use of a dog guide or trained service animal (a service animal is a dog or miniature horse that is individually trained to do work or perform tasks for the benefit of an individual with a disability). Accordingly, no person shall be unlawfully excluded from participation in, be denied the benefits of, or be otherwise subjected to illegal discrimination under any activity performed by the parties and their agents under this Agreement. Harassment on the basis of any of the foregoing conditions is strictly prohibited. Each party shall notify the other party's chief executive officer or designee immediately of any decision by a local, state or federal agency, court or jury that it violated a law, regulation or ordinance prohibiting discrimination. In the event of a party's noncompliance or refusal to comply with this nondiscrimination provision, this Agreement may be rescinded, cancelled or terminated in whole or part, and the party may be declared ineligible for further contracts with the other party.

XV. Severability

If any provision of this Agreement or its application is held invalid, the remainder of the Agreement or the application of the remainder of the Agreement shall not be affected.

XVI. Waiver

Failure by any party to enforce any provision of this Agreement or to declare a breach shall not constitute a waiver thereof, nor shall it impair any parties right to demand strict performance of that or any other provision of this Agreement any time thereafter.

XVII.Amendment

This Agreement may be amended by approval of 60% of all Member Districts in the cooperative.

XVIII.Joint Resolutions

Resolutions by the proposing district and Member Districts have been duly consummated, and by this reference and attachment are made a part of this Agreement.

When the Administrative Council determines that it is necessary to allocate operating or capital costs or to allocate enrollment slots among consortium districts, such allocation shall be in proportion to each consortium district's FTE student enrollment in grades 9-12 as a percentage of total 9-12 enrollment as illustrated below.
