RESOLUTION NO. 2020-03

A RESOLUTION of the Board of Directors of Aberdeen School District No. 5, Grays Harbor County, Washington, repealing Resolution No. 2020-01; rescinding its request that the Auditor of Grays Harbor County, Washington, call and conduct a special election on April 28, 2020, for the purpose of submitting to the District's voters the proposition authorized by Resolution No. 2020-01; requesting that the Auditor withdraw such proposition from the April 28, 2020, special election; and providing for other matters properly relating thereto.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF ABERDEEN SCHOOL DISTRICT NO. 5, GRAYS HARBOR COUNTY, WASHINGTON, as follows:

- <u>Section 1</u>. <u>Findings and Determinations</u>. The Board of Directors (the "Board") of Aberdeen School District No. 5, Grays Harbor County, Washington (the "District"), takes note of the following facts and makes the following findings and determinations:
- (a) On February 18, 2020, the Board adopted Resolution No. 2020-01, which requested that the Auditor of Grays Harbor County, Washington, as *ex officio* Supervisor of Elections (the "Auditor"), call and conduct a special election on April 28, 2020, for the purpose of submitting to the District's voters a proposition of whether the District may (i) issue general obligation bonds in the principal amount of no more than \$46,800,000 to pay costs of constructing a new elementary school to replace Stevens Elementary School, and (ii) levy annual excess property taxes to repay such bonds (the "Bond Proposition"). Resolution No. 2020-01 was filed with the Auditor by the filing deadline of February 28, 2020.
- (b) It is in the best interests of the District and its residents to: (i) repeal Resolution No. 2020-01; (ii) rescind the Board's request that the Auditor call and conduct a special election on April 28, 2020, for the purpose of submitting to the District's voters the Bond Proposition; and (iii) request the Auditor to withdraw the Bond Proposition from the April 28, 2020 special election.
- Section 2. Repeal of Resolution No. 2020-01; Rescission of Request; Withdrawal of Filed Ballot Issue. Resolution No. 2020-01, adopted by the Board on February 18, 2020, and filed with the Auditor by the filing deadline of February 28, 2020, is hereby repealed and has no further force or effect. The Board hereby further rescinds its request, which is contained in Section 3 of Resolution No. 2020-01, that the Auditor call and conduct a special election within the District on April 28, 2020, for the purpose of submitting to the District's voters the Bond Proposition. The Auditor is requested, directed and authorized to withdraw the Bond Proposition from the April 28, 2020 special election without further action of the Board. The Secretary to the Board (the "Secretary") or her designee is hereby authorized and directed to present a certified copy of this resolution to the Auditor as soon as reasonably practicable.
- <u>Section 3.</u> <u>General Authorization and Ratification.</u> The Secretary, the District's Executive Director of Business and Operations, other appropriate officers of the District and special counsel, Foster Garvey P.C., are severally authorized and directed to take such actions and to

execute such documents as in their judgment may be necessary or desirable to effectuate the provisions of this resolution. All actions taken prior to the effective date of this resolution in furtherance of and not inconsistent with the provisions of this resolution are ratified and confirmed in all respects.

<u>Section 4.</u> <u>Effective Date.</u> This resolution is effective immediately upon its adoption.
