A. Student/Staff Recognition

1. The Seneca Valley Academic Decathlon Team clinched first place at the United States Academic Decathlon (USAD) State Competition and will now move on to nationals. Seneca Valley's Academic Decathlon Team had an outstanding score of 42,290 points and earned numerous medals across a range of subjects at the

state competition held last month in Harrisburg. Seneca Valley's Academic Decathlon Team, led by Seneca Valley Senior High School Teacher Mr. David Reichard, will proudly represent the state of Pennsylvania as they compete at the USAD National Competition April 25-27 at the David L. Lawrence Convention Center in Pittsburgh.

- 2. Mrs. Tracy Glass has an unwavering dedication and commitment to the art of music and her many accomplishments will be noted as she makes her way to Erie later this month to accept the 2024 Pennsylvania Music Educators Association (PMEA) Citation of Excellence in Teaching Award for District 5. Mrs. Glass currently serves as an instrumental instructor for students in grades 4-6 at Connoquenessing Valley Elementary, Ehrman Crest Elementary and Ehrman Crest Middle School. She is also the director of beginner band, fifth grade band, and sixth grade band performance ensembles.

Also to take place later this month, Ms. Chessa Fernandez-Crum, Ryan Gloyer Middle School Choir Director, will receive the 2024 Butler County Symphony Association's Outstanding Music Educator Award. The award brings attention to the excellent and impactful work of a music teacher in Butler County. In addition to being the RGMS Choir Director, she is also the vocal director for both the RGMS Musical and the junior cast of the SV All-School Musical. Ms. Fernandez-Crum will be recognized by the symphony at an upcoming concert in Butler.
- 4. The Seneca Valley School District is proud to recognize a Haine Middle School fifth grader, Yasmeen Fahs, who was recently named a 2024 Carson Scholar. Miss Fahs is one of 570 students across the nation who have the coveted honor of being named a Carson Scholar in recognition of her high level of academic excellence and community service.
