March 4, 2024

- 1. CALL TO ORDER by Mr. Eric DiTullio, President, called the meeting to order at 7:07 p.m.
 - A. **Moment of Silence** The meeting opened with a moment of silence.
 - B. <u>Pledge of Allegiance</u> Annie Janovsky, third grader from Haine Elementary School, continued the board initiative, "I Led the Pledge" by reciting the Pledge of Allegiance.
 - C. Roll Call by Ms. Julia Benson, School Board Secretary, showed the following members in attendance: Mr. Nick Brower, Mr. Eric DiTullio, Ms. Susan Harrison, Mr. Tim Hester, Mr. Mike Jacobs, Mr. Jeff Widdowson and Ms. Kari Zimmer. Ms. Leslie Bredl and Mr. Fred Peterson were not in attendance.

2. INFORMATION REPORTS

A. Student/Staff Recognition

- 1. Seneca Valley seniors Lucas Boyle, Alexander Kim and Shivani Umesh have been named finalists in the 69th Annual National Merit Scholarship Program held by the National Merit Scholarship Corporation (NMSC). These SV standouts are three of approximately 15,000 finalists and will now advance to the next level of the program where they have the opportunity to earn National Merit Scholarships and, ultimately, the Merit Scholar® title.
- 2. The Seneca Valley Academic Decathlon Team clinched first place at the Western Pennsylvania Regional Competition that was held Feb. 2-3 at the Seneca Valley Senior High School. The team had a remarkable score of 40,422 points and earned numerous medals across a range of subjects; from art to science and economics to music. Seneca Valley's Academic Decathlon Team is advancing to the Pennsylvania State Competition scheduled for March 8-9 at Carlisle High School in Carlisle, Pa. with aspirations of advancing to the National Academic Decathlon Competition in Pittsburgh next month. The team is coached by David Reichard, Senior High School learning support teacher.
- 3. Congratulations to the members of the 2021-22 and 2022-23 Seneca Valley School Boards for recently being named a Tri-State Area School Study Council D. Richard Wynn Distinguished School Board Award winner. The board received this elite honor as they have demonstrated exemplary practices in addressing important issues that reflect directly on improved schooling for students. The D. Richard Wynn Award was commissioned by the Executive

- Committee in the late 1980s to symbolize the contributions of Dr. D. Richard Wynn. Dr. Wynn was the Executive Secretary of Tri-State, a part of the University of Pittsburgh's School of Education, from 1974 to 1980. The Board will be recognized by Tri-State during their 75th Annual School Board and Distinguished Educator Ceremony later this month.
- 4. Seneca Valley's Mock Trial team continues to raise the bar with a first-place finish at their recent District competition. A total of 11 teams from across the area competed at the Butler County Court House earlier this month in a series of mock trials. Seneca Valley went undefeated, ultimately advancing them to regionals which will be held at the Beaver County Courthouse. The SV Mock Trial Team is comprised of students in grades 9-12 in the gifted program and is advised by Ms. Brieana Nassan, senior high school gifted support teacher. This is the second time in school history (last year being the first) that the Seneca Valley Mock Trial team has won Districts. If they win their trial at regionals, it will advance them to the state competition.
- 5. Cybersecurity is vital for protecting sensitive information, and four young women at Seneca Valley have proven themselves as future leaders in safeguarding digital frontiers. Seneca Valley's Women in Computer Science CyberPatriot Team won second place in the state within the Silver division during the recent online CyberPatriot National Youth Cyber Defense Competition. As part of the competition, students were challenged to find and fix cybersecurity vulnerabilities in virtual operating systems. CyberPatriot is the National Youth Cyber Education Program created by the Air Force Association to inspire K-12 students toward careers in cybersecurity or other STEM disciplines critical to the nation's future. SV's team adviser is Diane Koegler, Senior High School computer programming and mathematics teacher.
