Mr. Nickel recognized and thanked the retirees for their hard work and dedication to the Seneca Valley School District over their many years of service.

- 2. Seneca Valley students in Dan McKosky's video production classes brought home six awards from Robert Morris University's (Virtual) Digital Media Arts Consortium (DMAC) Student Video Festival held in early April. Over 500 students from Western Pennsylvania participated in the contest. This event provides students with the ability to interact with other students and see clips from productions from across the region.
- 3. Junior Kaitlyn Moore, and sophomores Rachel Spear and Veronica Pimenova, were recently recognized by the National Center for Women and Information Technology (NCWIT). Miss Moore and Miss Spear were selected as 2020 Central and Western Pennsylvania Affiliate Honorable Mention recipients of the NCWIT Award for Aspirations in Computing. Miss Pimenova was named a 2020 Central and Western Pennsylvania Affiliate Rising Star recipient of the NCWIT Award for Aspirations in Computing.
- 4. Seneca Valley High School Math League team placed first in the region and 16th out of 34 high schools in the state. Individually, junior David Choi tied for 18th place in the state and Rachel Spear tied for 24th place in the state.

- B. **2020 -21 Return-to-School Task Force** Authorized the administration to establish a "Return-to-School Task Force" comprised of administration, labor union representatives, teachers, school board members (2), parents and students to explore options and develop plans for instruction delivery and school operations for Fall 2020.

Mr. DiTullio motioned, seconded by Mr. Peterson, to approve the board policies and Return-to-School Task Force as listed above. Motion carried on a roll call vote with those present voting in the affirmative.

9. **BUSINESS/FINANCE ACTION** – Mr. Mike Jacobs

- A. **Budget Transfers** Approved budget transfers.
- B. **PDE Lease** Acknowledged receipt of the PlanCon Part K, "Project Refinancing"
- C. **Depository/Treasurer** Appointed NexTier Bank as depository and treasurer for the 2020 2021 school year.
- D. **Proposed 2020-21 Budget** Approved the proposed 2020-21 budget in the amount of \$139,998,325 with <u>no millage increase</u> and authorize the budget to be made available for public inspection.

Ms. Burtner noted a 2.67% increase in the 2020-21 expenditure budget with only contractual increases and no millage increase. Also, she noted that it is difficult to prepare revenue projections at this time with no guide given regional shutdowns and family challenges, but that there will likely be a reduction in revenue in fiscal year 2020-21. Hard copies of the proposed budget will be sent to any resident who requests one. Mr. Nickel highlighted that this is only a proposed, not a final budget. The final budget is to be approved on June 9, 2020. Mr. DiTullio stated that the 2.67% increase in expenses is not that far above the 2.4% inflation we saw in February. In addition, the rate of our pension plan is 25% of this increase. He also noted that the Seneca Valley administration has always done a good job when planning and is always fiscally responsible. Ms. Burtner noted a significant decrease in earned income tax and real estate transfer tax because of the economic slowdown. Mr.

Peterson questioned if we'd be able to continue feeding into the 2020-21 school year. Ms. Burtner answered that it is unsure at this time, given government shortfalls, if we will have those funds available moving forward; however, it is our plan to continue feeding as we are currently. Mr. DiTullio noted that, so far this year, the District has provided over 78,000 meals at no taxpayer cost.

- E. **Drug Testing Fee** Approved a fee of \$30 (no increase) for drug testing for the 2020-21 school year.
- F. **Haine Elementary School Re-Roofing Contract Award** Approved Duro-Last, Inc. vendor agreement for the Haine Elementary School re-roofing project to be completed in the Summer of 2020 in the amount of \$236,365,59; pending solicitor review of final agreement.

Ms. Whittle motioned, seconded by Mr. DiTullio, to approve budget transfers, PDE lease, depository/treasurer, proposed 2020-21 budget, drug testing fee, and HES re-roofing contract as listed above. Motion carried on a roll call vote with those present voting in the affirmative.
