MINUTES

March 2, 2020

- 1. CALL TO ORDER Mr. James Nickel, president, called the meeting to order at 7:13 p.m.
 - A. Moment of Silence The meeting was opened with a moment of silence.
 - B. <u>Pledge of Allegiance</u> Dean Uplinger, a second-grade student at Haine Elementary School, continued the board meeting initiative, *I Led the Pledge*, by reciting the "Pledge of Allegiance."
 - C. 2. INFORMATION REPORTS

- A. <u>Student/Staff Recognition</u> Ms. Linda Andreassi announced the following student and staff recognition:
 - 1. Seneca Valley seniors Nishant Jayachandran, Olivia Schultheis and Sean Scott, have been named finalists in the 65th Annual National Merit Scholarship Program held by the National Merit Scholarship Corporation (NMSC). These seniors are three of approximately 15,000 finalists and will now advance to the next level of the program where they will have the opportunity to earn a National Merit Scholarship and, ultimately, the Merit Scholar® title.

Nishant Jayachandra and Olivia Schultheis were greeted by the Board and congratulated for their achievements. Nishant and Olivia attributed much of their success to the support and care from SV teachers.

- 2. For the third time in a row this year, the Seneca Valley Academic Decathlon Team placed first in a regional Academic Decathlon Competition, this one held at Edinboro University on Feb. 8. As of February, Seneca Valley ranks first in total points for Decathlon teams all across the state. Each competition includes 10 events: art, music, literature, social science, economics, math, science, essay, speech and interview. The group will compete in the state competition later this month.
- 3. Four Seneca Valley students are gearing up to participate in a regional orchestra festival. Junior Jacklyn Ko and sophomores Erin Keppler, Aaron Sedlak and Lindsay Walls Rivera will be moving on to the Pennsylvania Music Educators Association (PMEA) Western Region Orchestra Festival later this month. Additionally, Mr. Sedlak placed first chair in a section of 14 cellists. Students were chosen through audition and are led by Ms. Sarah Miller, secondary orchestra instructor.

C. Butler County Area Vocational-Technical School 2020-2021 Budget Presentation – Mr. Kurt Speicher and Dr. Regina Hiler presented to the Board a summary of the Butler County Area Vocational-Technical School's budget in the amount of \$5,952,479 for the 2020-2021 school year which shows an increase of 2.9% over last year's budget. Dr. Hiler stated there are currently 119 Seneca Valley students attending vo-tech with the majority of them studying graphic design and welding. Dr. Hiler further stated that 94% of vo-tech graduates are either gainfully employed or continue on to higher learning. Mr. Speicher will be retiring on June 30, 2020 and Dr. Hiler will then replace him as Executive Director of the Vocational-Technical School. The Board thanked Mr. Speicher for his hard work and dedication to making the vo-tech thrive.

- 1. **Vo-Tech** Mr. Fred Peterson, Jr. and Mr. Nickel deferred their vo-tech report in consideration of Mr. Speicher and Dr. Hiler's presentation.
- 2. I. U. IV Mr. Eric DiTullio reported the MIU IV is moving forward on disposing of the Martha Street property. He recommends the Board approve the MIU IV's proposed budget for the 2020-21 school year which is on the action agenda for March 9, 2020. He stated there will be no presentation of the budget as there was no increase from the 2019-2020 school year.

E. <u>Legislative Report</u> – Mr. Peterson reported on legislative developments at the State level including Governor Wolfe's budget request to increase funding for public schools. Gov. Wolfe is also seeking charter school reform as well as calling for every PA school district to offer full-day kindergarten.

At the Federal level, the proposed budget from President Trump includes a \$5 billion cut to education which equates to a 7.8% decrease; however, he does call for an increase in special education and vocational-technical spending.

In recognition of National School Breakfast Week, Mr. Peterson commended Darlene Carmack, Food Service Director, and her staff for a job well done in preparing and serving nutritious breakfast meals to our students.
