SCHOOL BOARD ACTION MEETING MINUTES

October 12, 2021

- 1. CALL TO ORDER Mr. Eric DiTullio, President, called the meeting to order at 7:04 p.m.
 - A. <u>Moment of Silence</u> The meeting was opened with a moment of silence in memory of Dr. Lyle Miller, former Seneca Valley School Board Member and School Board President.

The homecoming football game at NexTier Stadium on Friday evening went into double overtime, but the Raiders came out with the win against Canon McMillan, 24-17. Ms. Andreassi also thanked the many staff members who went above and beyond to ensure the homecoming parade/carnival, football game and dances took place during this time.

Special Olympics Nick Logero, senior high school student, and Taylor Wagstaff, SV Class of 2021, were recently named winners of the 2021 Leadership Award by Special Olympics Unified Champion Schools (UCS). E. <u>COVID-19 Update</u> - Dr. Vitale provided a COVID-19 update as follows:

Pennsylvania Department of Health (PADoH) Early Warning Dashboard

- The difference in confirmed cases in the most recent 7-day period vs. the previous 7-day period shows cases are down by 75
- The current incidence rate per 100,000 residents is 355
- The PCR percent positivity rate is fairly high at 15%

Butler County

- The 14-day incidence rate rolling average = 117.57
- The 7-day incidence rate rolling average = 756 cases
- The 7-day incidence total incidence rate per 100,000 residents = 402 cases

Seneca Valley Zip Codes

- When pulling this data today, we saw an increase of 13 cases from the previous day; this number tends to increase the next day
- On October 11, 60 cases were reported

- A. <u>Co-Ed Cricket Club</u> Approved the establishment of the Co-Ed Cricket Club at no cost to the District and under the supervision of volunteer sponsor Mr. David Reichard.
- B. <u>Slippery Rock University (SRU) Transition Achievement Program</u> Approved the agreement for the SRU Transition Achievement Program with SRU to provide transition services for the 2021-22 school year. Dr. Roberts
- C. <u>BC3 College Within High School (CWHS) Partnership Agreement</u> Approved the CWHS Partnership Agreement between Seneca Valley School District and Butler County Community College from July 1, 2021 June 30, 2022. Dr. Roberts
- D. <u>Grant Disbursements</u> Granted permission to apply for and disburse, if approved, the following grants:
 - 1. First Tech Challenge Grant funded by the Arconic Foundation in the amount of \$1,000 to fund the cost of equipment, fees and supplies related to the 2021-22 First Tech Challenge. Ms. Annie Mersing and Mr. Steve Fortunato
 - 2. Homeless Children and Youth Grant in the amount of \$62,248 funded by the United States Department of Education to support students who are experiencing homelessness to meet their physical and mental health needs. Dr. Jeff Roberts

Dr. McKinley reported that students approached Ms. Lewis about establishing the Co-Ed Cricket Club. They completed the required paperwork and received the requisite number of signatures as well as a sponsor.

Dr. Roberts noted that the Slippery Rock Transition Achievement Program is available for high school students, some over the age of 18, who need transitional assistance to learn life skills they can use beyond high school. The partnership program also provides students the opportunity to learn and work on campus which offers a rich experience on the college campus.

Ms. Harrison motioned, seconded by Ms. Bredl to approve the Co-Ed Cricket Club, SRU Transition Achievement Program, BC3 CWHS Partnership Agreement, and grant disbursements. The motion carried on a roll call vote with those present voting in the affirmative.

10. BUSINESS/FINANCE ACTION

A. <u>Bond Issue</u> - Approved the appointment of PNC Capital Markets, LLC, as investment banker and Dinsmore & Shohl, LLP, as bond counsel related to both outstanding and anticipated debt financings in connection with the school district's proposed and developing plans for capital improvements and facilities.

Ms. Burtner stated that PNC has been on board for about six year. Dinsmore & Shohl have been with the District for about 20 years. They have been hired to perform the third in a series of bond issues related to the Ehrman Crest Elementary/Middle School project and other long-range plans of the District. The plan has been ongoing for at least ten years and will continue beyond completion of Ehrman Crest.

Mr. Jacobs motioned, seconded by Mr. Nickel to approve the bond issue. The motion carried on a roll call vote with those present voting in the affirmative.



13. MISCELLANEOUS - Mr. DiTullio provided a PSERS update as follows:

Current Cost Saving Initiatives

- PSERS administration cost per member is \$13 under the peer average with an associated annual savings of \$6.4 million.
- The Annual Required Contribution (ARC) has only been fully funded by the state of Pennsylvania for the last six years. Since 2017, we have been receiving 100% of the ARC from legislature. Fiscal Year 2022 is the sixth consecutive year with 100% of actuarially required contributions.
- The PSERS fund was valued at \$59.1 million in July of 2020. With contributions totaling almost \$6 million and net investment income totaling nearly \$15 million, the fund now totals over \$72.5 million a historic and unprecedented growth for PSERS.



Mr. DiTullio noted that retirements were up 8% from 2020 to 2021.

Lastly, Mr. DiTullio stated that there are challenges in educating new teachers with the new retirement system under ACT 120 as the new teachers have a hybrid plan. To help new teachers navigate their personal plan, the District is looking at financing this education and possibly helping them during their onboarding.

14. **ADJOURNMENT** - With nothing further to come before the board, Mr. Nickel motioned, seconded by Mr. Jacobs, to adjourn the meeting at 8:07 p.m.
