# **September 20, 2021**

D. Robert Morris University All Academy Event - Dr. Tracy Vitale announced the representatives from the United States Military Academy at West Point, U.S. Naval Academy, U.S. Air Force Academy, U.S. Coast Guard Academy, and the U.S. Merchant Marine Academy will be hosting a Military Service Academy Night for students interested in attending one of our nations Service Academies.

E. Pennsylvania Youth Survey (PAYS) – Dr. Jeff Roberts announced that PAYS has been conducted at schools across Pennsylvania every other odd year for over 30 years. The survey administration is supported through the PA Department of Education (PADOH), the PA Commission on Crime and Delinquency, and the PA Department of Drug and Alcohol programs. Survey questions ask students about school climate, violence, depression, bullying, and substance abuse. Student names

are not tied to the survey submissions and no student data can be obtained from the data set collected. Results are reported in aggregate from to the school district, county, and state-wide levels. As of Friday, 377 of Pennsylvania's 500 school districts plan to participate in the PAYS survey, slightly more than 75%. At Seneca Valley, students in grades 8, 10, and 12 will participate. Participation is voluntary and students can skip questions if they do not wish to answer. Parents can alert their building Assistant Principal if they do not want their children to participate. The four Butler County school districts participating include Butler Area, Karns City, Moniteau, and Seneca Valley. Results from the 2019 survey supported the need for SV to address vaping among our teens. Information will be sent to parents and guardians via School Messenger in the month of October. A full report back will be provided in April 2022.

# F. <u>COVID-19 Update</u> - Dr. Vitale provided a COVID-19 update as follows:

## **Butler County**

- The most recent 7-day period vs. previous 7-day period shows Butler County up by 97 reported cases
- The incidence rate for the most recent seven days per 100,000 is 329.5
- The PCR positivity rate for the most recent seven days is 13.8%
- The difference in the average daily COVID-19 hospitalizations is up by 11.5
- Butler Memorial has 44 confirmed COVID-19 cases to date with six in the ICU and five deaths reported over the weekend
- Number of new daily cases on a 14-day rolling average = 113.6

## Seneca Valley Dashboard

- Active student cases = 16
- Students in quarantine = 66
- Active staff cases = 3
- Staff in quarantine = 1
