- B. <u>Bid Awards</u> Awarded bids for the aquatic center for the following Prime Contracts:
  - General Construction (GC) Bid to VendRick Construction Inc in the amount of \$9,284,200.00. Base Bid of \$9,994,200.00 with the following DEDUCT Alternates accepted:

     a. Alternate 3 - Pool Roof Structure: DEDUCT of <\$420,000.00> for steel roof structure in lieu of wood.
     b. Alternate 4 - Pool Skylight: DEDUCT of <\$290,000.00> to delete the skylight scope of work.
  - 2. HVAC Construction (HC) Bid to Hranec Corporation in the amount of \$1,154,000.00.
  - 3. Plumbing Construction (PC) Bid to Wm. T. Spaeder in the amount of \$1,047,350.00.

- 4. Electrical Construction (EC) Bid to McCurley Houston Electric in the amount of \$1,160,000.00.
- C. <u>Student Adjudication</u> Approved student adjudication #2018-19-09.
