The MDUSD CARES Expanded Learning Program strives to develop a variety of academic, recreation, enrichment, health and support services for students. We strive to provide a safe, fun, nurturing environment.

## **CARES Expanded Learning Program Profile**

#### **Academic and Enrichment Opportunities**

#### **Direct Services to Students Include:**

CARES is comprised of a Science, Technology, Engineering and Mathematics (STEM) program, academic program (homework help, tutoring, connections to the school), enrichment and recreation program (arts, sports, leadership, crafts and field trips) and a safe and healthy environment program (nutrition, gardening and physical fitness education). In addition, the program provides a daily nutritional snack. Parent support and education is also provided.

## **Student Selection & Enrollment Policy**

CARES is available to transitional kindergarten through twelfth grade students enrolled at any of the 23 participating Mt. Diablo Unified School District sites: Bel Air, Cambridge, Delta View, El Monte, Fair Oaks, Gregory Gardens, Hidden Valley, Holbrook, Meadow Homes, Monte Gardens Rio Vista, Silverwood, Shore Acres, Sun Terrace, Westwood, Woodside, Wren, Ygnacio Valley Elementary, El Dorado, Oak Grove, Riverview Middle, Mt. Diablo High School and Ygnacio Valley High School.

These expanded learning programs are funded primarily through grants from California Department of Education - After School Safety and Education Grants. The grants serve high need population areas and provide academic, enrichment, recreational and health support 5 days a week 2.5 hours a day throughout the school year and intercession.

Highest priority for participation will be given to students who meet the following criteria: (criteria not in priority order)

- Identified as "high need" (Homeless and/or Foster Child)
- Teacher recommendation
- Parent participation in Adult Education and/or Pre-School classes
- School referral from a Student Success Team (SST) or Family Success Team (FST)
- Positive behavior during the regular school day
- Grade level availability
- Parent request
- Open enrollment

CARES student population must be reflective of the regular school day student population. Program management will make every effort to ensure student participants are a heterogeneous group that is equally representative of students in transitional kindergarten through eighth grade. CARES will also take into consideration the siblings of students being referred.

In the event that student interest exceeds program capacity, a Wait List will be maintained. Wait lists will be maintained according to grade and date submitted. As space becomes available, students on the waitlist will be considered for enrollment and program management will contact the home to see if the student is still interested in attending the program.

Questions and/or concerns should be directed to the Program Coordinator. If further assistance is needed the Program Coordinator can refer individuals to the CARES Coordinator.

#### STUDENT SELECTION & ATTENDANCE

#### **STUDENT SELECTION**

- Student eligibility criteria:
  - o Currently enrolled in one of the fifteen participating schools
  - Identified as high need (Homeless and Foster Youth)
  - Can attend all five days of program a week
  - Child of an essential worker
  - Recommendation by Principal or designee
  - Siblings of high priority student or student recommended for CARES program
  - Student struggling social and/or academically

If the number of priority enrollment exceeds capacity, names will be chosen via a lottery. Parent/Guardians must review and acknowledge the Parent Handbook. A "waiting list" will be maintained at each site.

#### **ATTENDANCE**

Students who are frequently absent may be asked to leave the program and may be eligible to re-enroll at a more appropriate time.

## **Discipline Policy**

The MDUSD CARES Expanded Learning Program reserves the right to change classes of any student, remove and/or dismiss a student from the program if the safety of students and/or staff are in question.

All students participating in CARES are expected to be respectful, caring, responsible, and safe individuals. At each site specific rules need to be followed (refer to site school specific program information at the back of the packet).

Although the program is after school hours, site principals will be informed of accidents and incidents.

CARES will utilize the following steps to support positive behavior: All students will be respectful, responsible, and safe. Students will receive frequent praise and positive reinforcement. Rules and expectations will be reviewed with all students.

#### Discipline steps can include:

- A verbal warning. However, if the behavior continues, the student will speak to the Program Coordinator.
- If the behavior does not improve, the Program Coordinator or Program Coordinator Assistant will call home and send a Behavior Warning Notice home.
- Behavior Warnings may include the student being picked up immediately. If a parent/guardian or emergency contact can not be reached or refuses to pick up the student, this student may be removed from the program.
- A student who receives three Behavior Warning notices may be asked to leave the program.

Harassment of any kind, physical altercation, or inappropriate language will result in automatic removal from the program.

Parents/Guardians who harass staff of any kind, physical altercation, yelling, or inappropriate language will result in asking the parent/guardian to designate an alternate pickup person or student will be automatically removed from the program.

## Early-Release/Attendance Policy

If students participating in the CARES Expanded Learning Program need to leave early, parents must complete the "Early Release Form." This form must be completed **prior** to the child leaving and not given the following day. Failure to comply with the early release form policy may result in your child's removal/dismissal from the program. In the event that a child needs to leave early on all Tuesdays for example, the form may be filled out for specific days instead of dates.

Only those individuals whose names are listed on the emergency card will be allowed to fill out an "early release form" and sign the child out from the program.

Due to state compliance, a maximum of three Early Release forms are allowed per month. Excessive Early Releases will result in removal from the program.

If your child did not attend school, he/she cannot attend the CARES program that day.

#### LATE PICK-UP POLICY

The CARES Program has a policy that all children should be picked up no later than 6:10 p.m. The program ends promptly at 6:00 pm. In the event that a child is picked up at 6:10pm or later, they will be given a Late Warning Form. If by 6:30, calls have been made to ALL numbers on the emergency card with no success, law enforcement will be called. If an individual receives three Late Warning Forms they will be asked to leave the program. This policy will be posted and reviewed with students.

For intercession and summer program days all children should be picked up no later than 5:10pm. The program ends promptly at 5:00pm. In the event that a child is picked up at 5:10pm or later, they will be given a Late Warning Form. If by 5:30, calls have been made to <u>ALL</u> numbers on the emergency card with no success, law enforcement will be called. If an individual receives three Late Warning Forms they will be asked to leave the program. This policy will be posted and reviewed with students.

The first time a child is picked up late, Program Coordinators will issue Late Warning #1. (See Late Forms). The second time the child is picked up late, warning #2 will be issued. Upon receiving the 3<sup>rd</sup> Late Warning Form, the child will be asked to leave the program.

## **Illness/Medication Policy**

If your child shows signs of infection or illness, do not send him/her to the program. This is for your child's own welfare as well as that of others. If your child arrives at the program not feeling well, the Program Coordinator may contact you to have the child picked up. If they have a fever or diarrhea, they will be sent home immediately. Refer to the COVID Guidelines in this handbook for protocols surrounding COVID-19 exposure and illness. Children must be lice and nit free to attend Mt. Diablo CARES Expanded Learning Program.

### Medication

CARES staff (Managers, Program Coordinators, Program Coordinator Assistant, Recreation Specialist or Teacher Liaison) cannot administer medication to students TK-12 unless under the circumstance of asthma or EpiPen where the parent gives documented parental consent.

Education Code 49423, 49423.1 Any pupil who is required to take, during the regular school day, medication prescribed for him/her by a licensed healthcare provider, may be assisted by the school nurse or other designated school personnel or may carry and self-administer prescription auto-injectable epinephrine or inhaled asthma medication if the school district receives a written statement from the healthcare provider detailing the name of the medication, method, amount, and time schedules.

## **Program Policies**

## **Emergency/Identification**

All the necessary paperwork was provided to you prior to the beginning of the program. Program registration includes a student emergency card. Please be sure to fill out all of these forms completely before the first day of the program. Your child/children will not be allowed to participate in the program until these forms are completed in full and returned to the site.

You must note any allergies (food, bee stings, etc.) and/or other special needs you feel the staff should know about your child/children. Please be sure to keep this information current throughout the year and notify staff of any changes.

## Personal Belongings/Possession of Cellular Phones and Other Personal Electronic Signaling

Please label all of your child's belongings—coats, backpacks, sharing items. It is up to your child that all belongings be stored in the designated locations. CARES staff are not responsible for any misplaced/lost/stolen items.

Students are not permitted to use any type of electronic device. The electronic device must remain turned off during the CARES Expanded Learning Program.

If a school staff member finds it necessary to confiscate a device, parents will be notified promptly and the device will be returned in accordance with program rules after the administrator or designee has consulted with the student's parent/guardian. The program is not responsible for lost or stolen electronic devices. Students are to make arrangements with their parent(s) or guardian(s) to contact the Expanded Learning office when attempting to reach them during the CARES Program. Failure to adhere to policy, Program Coordinator/Program Coordinator Assistant will confiscate the device and return at the end of the program day.

## Student Check-In/Sign-Out

All students must check-in/out with CARES program staff. Each site has a check out system that will be implemented. It is a program policy that each child is checked out by a parent/guardian or designated individual listed on the CARES student emergency card every day. No one under the age of eighteen can be on the emergency card or may pick up child/ren. You will be asked to provide a valid identification card at the time of pick up.

Only individuals listed on the emergency card prior to the date of pickup, with identification, will be permitted to check your child out. Please make sure this information is updated regularly. Failure to check your child out is a breach of program policy and may result in dismissal from the program. This is a safety policy and it is strictly enforced.

All students that are considered walkers, (marked on their emergency card) must be fourth graders and above. MDUSD CARES does not allow students in kindergarten through third grade to sign themselves out and be walkers. We understand that this may be an inconvenience, but it is to ensure the safety of all program students. Students in kindergarten through third grade must be signed out by an adult eighteen years of age or older who is listed on the emergency card and has a valid identification card.

## Healthy Food and Beverage Policy Mt. Diablo CARES Expanded Learning Program

Mt. Diablo CARES Expanded Learning Program will make every effort to promote health and wellness by being a role model in encouraging the consumption of healthy food and beverages.

As mentors and role models for staff, children and families, our efforts in maintaining a healthy image at our workplace and providing healthy opportunities and choices must be intentional. Therefore, Mt. Diablo CARES Expanded Learning Program will:

- Increase the range and availability of healthy food and beverage options available at meetings, events and at premises under our agency's control.
- Ensure that only healthy options are provided for food and beverage rewards, prizes and give-aways.
- Ensure that CARES staff avoids consuming or conveying "Junk Food" on any CARES school site during program hours or presence of students. This includes but not limited to: Soda, Chips, Candy.
- Only support fundraising activities involving food or drink items that meet the agency's food and beverage policy guidelines.
- Ensure that any food and beverage catering for meetings and events sponsored or organized by our agency; meet the *Healthy Food and Beverage* policy guidelines.

#### **Implementing the Policy**

Mt. Diablo CARES *Healthy Food and Beverage Policy* will be distributed and explained to paid staff, clients and volunteers within our organization, and to collaborators, contractors and partners.

## How will CARES Expanded Learning Program ensure students are safe when participating in the program?

All students and staff will maintain the following:

- Frequent hand washing and sanitizing
- Follow all cleaning guidelines and safety precautions outlined by the CDC, CDE, and MDUSD practices, protocols, and COVID response and reporting guidelines Which all can be found on the Mt. Diablo Unified School District website
- CARES protocols will be aligned with the school day protocols and guidance.

#### When and/or if a student or staff member tests positive?

CARES will follow district/BACR COVID response and reporting guidelines, which can be found on the MDUSD website and BACR website. The CARES Leadership Team will work in partnership with the CARES Program Coordinator and site Principal when a staff or student tests positive for Covid 19.
