I am calling to welcome the A-C Valley Community back to the start of the "new" school year. The district staff have worked diligently over the summer to have the campus ready for the first day of school, which will be next Wednesday, August 21, 2024.

#### A-CV School Calendar

The 2024-2025 school calendar is posted to the acvsd.org website, located in the student handbooks, and available for pick-up at both schools. To ensure a successful start to the school year be aware of a few important dates: 7th grade and new student orientation is Monday, August 19, 2024 from 5:00 – 6:30 PM at the Jr/Sr High School, Students' first day of school is on Wednesday, August 21, 2024, the district is closed on September 2nd for Labor Day, students will be off school on October 3, 2024 and October 4, 2024 for an Act 80 day and ALF day. Just note that October 3, 2024 will be used for Parent Teacher Conferences, and an evening Open House, so please plan accordingly. We will also have a 45 minute early dismissal prior to Thanksgiving break on November 27, 2024 and a 45 minute early dismissal prior to Christmas Break on December 20, 2024 and the last student day on May 28, 2025, dismissal will be at 11:15 for the Elementary School and 11:30 for the Jr/Sr High School

## • A-CV Transportation

There is a transportation tab at acvsd.org website that you can access for additional transportation information. Alternatively, you can call and speak to Mrs. Sherman any time with questions and concerns, she is located at the Elementary Office.

Just know that we do our best to keep everyone safe and ask that students stay 5 feet from the road while waiting for the school bus to arrive and wait until the RED flashing lights are on display before walking onto the road.

Students who plan to drive to school, we ask that you drive slowly and schedule a time to leave your house early enough so that you do not need to rush. In addition, the student drivers will need to have their driver's license and insurance card to obtain a parking permit from the HS office to park on campus in the student parking lot only.

## • Day-to-day Operations

The Elementary School will start at 8:00 AM and Jr/Sr High School will start at 7:50 AM and we will have staff on duty at 7:30 AM for morning arrival and free student breakfast at this time. If you plan to drop off your children off in the morning, please do so after 7:30 AM.

During the school year, if your child is absent from school you will need to submit an excuse within 3 days of the absence. In addition, if you are planning to take an educational trip, you will need to complete the education trip form prior to leaving for the trip. This form is available in the office and please do your best to avoid PSSA/Keystone testing dates from April 21 to May 23, 2025.

Finally, communication is the key to the success in educating our students. If your child is struggling academically, your first call or email should be to your child's teacher, we have highly qualified teachers who are experts in their field. If it is a behavioral or mental health concern, the school counselors or principals will help support your family and be able to provide resources.

# School Safety

The school board and staff take great pride in providing a safe and secure learning environment for our students and staff. Dr. McDeavitt is the Safety and Security Coordinator and works closely with the A-CV School Police Officer, Dave Sitler. Dave has many years of experience as a police officer in Pennsylvania and in serving as school police officer here at A-CV.

Officer Sitler carries a firearm and is well equipped to provide the highest level of security on campus. In addition to Officer Sitler, we also have an MOU with the Clarion State Police to provide additional support when needed. We have also made several safety related upgrades to the campus this summer, and will continue to do so with additional financial support from the state to enhance mental supports and physical safety. However, to ensure our safety at school we need help from our community while on campus. If you "See something, you say something."

Please help us keep our students safe by reporting anything that is concerning (See something, say something), you can do so by calling 911 or contacting a school official. The district will do our part as well, and will be conducting security drills throughout the year, the first drill will be conducted during the first month of school.

Outside Guest: The safety and security of our students and staff is of utmost concern during the school day. Parents, adult residents, and other guest will be welcomed to the Elementary and Jr/Sr HS buildings between the hours of 8:00 AM-3:05 PM and may only enter through the secure entrance, at which point you will need to provide state issued identification before gaining access to the building.

## • Health and Safety Plan

Just like in the past, if students and staff are sick, we ask that you stay home. We will continue to promote hand washing; fresh air circulation, and do our best to keep sickness out of the district.

#### Communication

The district will continue to use the schoolmessenger phone system and the acvsd.org website for our primary means of communication. If you have questions that you cannot find on the website, please contact the office.

#### Athletics

In order to provide our students with appropriate extra-curricular offerings, A-CV continues to add cooperative agreements with Union School District (USD).

As we prepare for football season, all our home varsity games at the Union School District until we are able to renovate our football field.
