VOLUNTEERING AT MMS

Volunteers at MMS (including for ABC events, chaperoning field trips, etc.) require a completed online background check as well as a completed volunteer application on file with MMS (both the link to the online background check and the paper application can be located on the SCCBOE website). PHYSICAL EDUCATION

All students are required to take physical education each day. To ensure student safety as they participate in various activities, students are required to wear tennis shoes in PE. SCHOOL NURSE INFORMATION

- School nurses try to help children stay in school so that they can learn. We do, however, follow Public Health Department guidelines to prevent the transmission of communicable diseases and conditions. Any student with fever, head lice, vomiting, diarrhea, or an undiagnosed rash will be sent home.

- ALL MEDICATION MUST BE ADMINISTERED BY THE SCHOOL NURSE. A PARENT/GUARDIAN MUST DELIVER ANY STUDENT MEDICATION TO THE OFFICE/SCHOOL NURSE.

CELL PHONES & SMARTWATCHES

The SCCBOE Code of Conduct explicitly states all cell phones and connected devices (smart watches, earbuds, etc.) must be turned off and placed inside of the student's locker or backpack during the school day. If a student violates the cell phone/smart watch policy their device will be taken up by school personnel and require someone from the student's contact list to pick the device up. Additional discipline procedures including, but not limited to: Saturday School, Out of School Suspension, or a placement in Alternative School may also be enforced.

CONCERNS

Please know that we are here to ensure that your students have a positive, safe experience at school. If your student has any concerns, issues, etc. while they are at school, please encourage them to report these things to their teacher, the school counselor, or an administrator as soon as possible. If they report these things to you, please reach out to us as soon as possible so that we can work to correct the issue. We want to make sure your students are taken care of, but we must know that something is going on in order to be able to address it. We appreciate you sharing your student with us!
