

# School Nutrition Program News 2024-2025



We look forward to serving your student(s) a healthy, balanced and fun meal at both breakfast and lunch. School Meals provide protein, grains, fruits, vegetables and low-fat milk all in a selection of age specific favorites and provide convenience to busy families.

If your student is approved for reduced price meals or attends a CEP school, there will be no charge for daily breakfast and lunch for the 2024-25 school year.

Families that qualify for Direct Certification do not need to fill out an application and will receive a letter confirming their eligibility in the program by the beginning of school. ## **Notice of Direct Certification**

Families who were mailed a *Notice of Direct Certification* from School Nutrition Administration (prior to school opening) **DO NOT** need to complete a meal application for 2024-25. If you did not receive a letter for EACH enrolled student in your household, please contact us immediately at 540-422-7223.

## **Free and Reduced Price Meal Application**

Meal benefit applications for the new school year are now being accepted. Families who received meal benefits last year **MUST** submit a new application and be approved on or before September 26, 2024. Prior year approvals will expire after lunch meal service on September 26, 2024.

Meal applications are processed within six business days upon receipt in the School Nutrition Administration office. Applications must include ALL household members (related or unrelated) and their GROSS income (pay before taxes or deductions), signature, and **LAST FOUR NUMBERS** of the social security number (or box checked indicating there is no SSN). Applications without all income information CANNOT be processed unless a valid Supplemental Nutrition Assistance Program (SNAP) case number OR Virginia Temporary Assistance to Needy Families (TANF) number is provided OR the student for which the application is being submitted is a foster child.

## **Student Accounts**

## **Non-Sufficient Fund Check Recovery**

The Fauquier County School Nutrition program participates with a non-sufficient fund (NSF) check recovery service. All NSF checks will be subject to a non-refundable fee. The School Nutrition Program reserves the right to refuse checks from families who are habitual offenders or who do not reconcile NSF transactions.

## **School Fee Waiver**

Fees may be waived for students whose families are undergoing economic hardships and are financially unable to pay them. A fee waiver will be granted when any of the following valid documentation is presented to the student's school finance office:

1. Approved free or reduced price school meal eligibility letter
2. Supplemental Security Income (SSI) benefit verification
3. Medicaid card
4. Unemployment monetary determination letter
