and the Air Force Junior ROTC Senior Aerospace Science Instructor (SASI) at Willis High School. This contract contains the minimum AFJROTC program requirements all cadets must meet, and the minimum standards of performance each cadet must achieve and maintain, in order to remain in the AFJROTC program in good standing. This is an equal opportunity program and totally voluntary. Each cadet must abide by the required standards and code of conduct. No inherent right of admittance or retention in the program may be assumed by any cadet. Failure to meet and maintain the following requirements and standards will be considered sufficient evidence of a cadet's lack of effort, indifference to training, absence of motivation, lack of interest, and/or general unsuitability to continue in the AFJROTC program. Also, any cadet who fails any Aerospace Science class for a semester may be dismissed from the AFJROTC program and become ineligible to enroll in future AFJROTC classes. An overall failing grade for the year may automatically disqualify a cadet from re-enrolling in the AFJROTC program the following year. If the cadet is attending Willis High School and subsequently resigns, is truant, or commits any act prejudicial to the high standards expected of a cadet or is otherwise dismissed from the AFJROTC program by the Senior Aerospace Science Instructor for any reason; that cadet may be dismissed from the AFJROTC program and reassigned to another class immediately. Parents and cadets should review the WHS AFJROTC website to become familiar with program requirements' governing documents and instructions.

USE AND CARE OF U.S. GOVERNMENT PROPERTY

() () 1. I agree to properly use, and care for, all U.S. Government property and equipment, and further understand that safeguarding all property and equipment entrusted to me is solely my responsibility.

- a. I understand all AFJROTC books, uniforms, accessories, weapons, equipment, and other items issued to me are property of the U.S. Government.
- b. I understand the unauthorized use, damage to or destruction of U.S. Government property is prosecutable under penalty of applicable Public Law.
- c. I agree to keep my uniform properly cleaned, pressed and in good condition at all times (**pants and shirt dry cleaned every other week**). (Service coat, pants and lightweight blue jacket must be dry cleaned only).
- d. I agree to immediately return all books, equipment and uniform items issued to me upon resigning, dismissal from the AFJROTC program, or when directed by the SASI.
- e. I agree to pay the current list price for any uniform item or equipment that I lose or damage.
- f. **I agree when I return the uniform items, they must be dry cleaned prior to turn-in.**

- b. I agree to keep my hair and personal grooming compliant with official Air Force standards as spelled out in AFI 36-2903.
- c. I will not lie, cheat, or steal, nor try to gain unfair advantage over my peers.
- d. I agree to complete and turn in all homework, classroom projects and assignments on time.
- e. I understand that all assignments, such as homework, notices to parents, course projects, etc. require parent's/guardian's signature before it will be accepted for credit and assignment of a grade.
- f. I agree that I will not injure or endanger myself or others at any time by any careless act or deed.
- g. I understand the use of profane or abusive language (or racial slurs) is totally unacceptable and will not be tolerated at any time. A repeated offense is sufficient grounds for immediate dismissal.
- h. I agree to maintain at least the minimum grades in all subjects required by Texas law for graduation.
- i. I understand that if I fail any Aerospace Science class, I may not be allowed to re-enroll in AFJROTC the following school year.
- j. I understand proper class attendance is mandatory and failure to attend AFJROTC classes is grounds for immediate dismissal from the program.
- k. I will not commit any immoral, degrading or other embarrassing act that will reflect on the integrity and high principles of the AFJROTC program.
