**TO ENROLL** – 1) All students must be 16 years old  
2) possess an **Official New York State Learner's Permit or Junior License prior to September 11, 2024.**

#### **COST**

The cost of this program is **\$750.00**. The full amount is required with the completed application no later than September 11, 2024. **Credit cards are not accepted.** Please make payment by certified check or money order made payable to the **Half Hollow Hills School District.** **No refunds will be honored after September 15, 2024.**

#### **Lecture Classes**

Lecture classes will be in person and include videos and guest speakers. Classes are not credit bearing and will meet once a week at school. If you miss your class time, makeup must be completed as soon as possible. Book work will be assigned and must be handed in by the assigned date to count. Late assignments will lose points for each day late. After a week late, it will result in a zero for that assignment. Students must maintain an average of 65 or better to pass the course. All work must be completed regardless of grade. Attendance is mandatory. Arriving late or leaving early to class is not permitted and will affect your attendance grade.

#### **Driving Classes**

Students will drive and observe once a week for 90 minutes each class. Vehicles will be leaving school grounds promptly and lateness will not be permitted. The use of electronic devices is prohibited throughout the driving session. #### **Applications and Registration**

**All applications must be submitted to FGAC Administration building, room 104, attention to Lisa Florio, by September 11, 2024,** to be considered for the program. Students are enrolled by birth date, oldest to youngest. If mailing your application, please remember to leave extra time so school receives it before the deadline. We are not responsible if the application is received late.

Applications are to be filled out in its entirety and include:

- 1) A clear copy of the student's NYS Official Photo Learner's Permit or Junior License (Front Only)
- 2) Signed Parent Consent Form
- 3) Application with money order/certified check.

**Once the maximum number of students have been reached, classes will be closed. No exceptions!!**

- 1) All students must maintain at least a 65 average for lecture and car instruction.
