Mike Ruetschle from Ruetschle Architects shared highlights of the information discussed at the October 2, 2023 Primary Facilities Steering Committee. Highlights included results of a traffic study, budget information, and 8 options that were reviewed by the committee in preparation for the community forum on October 30th. Board members asked questions confirming that options include all three primary sites and the answer was yes.

VI. Presentation: Wyoming City Schools Local Report Card Update

Dr. Whitely shared a video presentation on the 2023 ODE report card for Wyoming City Schools. She noted the report card components of Achievement, Progress, Early Literacy, Gap Closing, Graduation, and College, Career, Workforce and Military Readiness (CCWM) and the measures that contribute to the ranking of each component and the District's performance on each component. Dr. Whitely reviewed the

weights of each component and shared that Wyoming received a 5 Star rating. Performance Index was also reviewed with Wyoming's PI calculated at 104.868. Dr. Whitely also shared report card achievement data for the primary, middle school and high school levels.


