Minutes of the Meeting of the Wyoming City School District Board of Education Monday, September 18, 2023 Central Office

I. Call to Order

Mrs. Zoller called the meeting to order at 7:02 p.m.

II. 087-23 Roll Call

V. Board Committee Reports

Finance Committee – Mrs. Johnson reported that Finance Committee met at 5:30 PM this date and reviewed the analytic for the 23-24 school year, reappraisal history, tentative values for residential and commercial property estimated overall at a 28.73% increase, the correlation between values and tax rates in previous cycles of reappraisal, a homeowner example noting how effective millage rates will be reduced when values increase, the impact of new values on the statutory calculation for debt limits, the financial components of the recently released ODE report card including 76% of our budget focused on instruction, and our most recent property tax settlement compared to forecast.

Citizens Advisory Committee – Mrs. Feldmeier reported that the first meeting of the CAC was held on September 12th where committee members were assigned to one of the three study teams: internships, food service operations and artificial intelligence.

VI. Superintendent Committee Liaison Reports

Belonging Committee – Mr. Weber reported that the first meeting of the BIC was held on September 5th with a new format this year inviting experts to speak on topics of inclusion. The first topic was related to protocols for having difficult conversations with Dr. Janet Zydney as the speaker.

Community Engagement – Board members reported recent activities including the Primary Facility Community Conversation on September 6th, open houses, athletic events, primary school harvest fest, and primary literacy night. Mrs. Henke highlighted upcoming events on the school calendar for the months of September and October.

Facilities Committee – Mr. Weber reported that creation of the primary facilities steering committee is being finalized after 58 community members and 8 staff members applied. The first meeting will be held

on October 2nd. Members are being selected with an eye on diversity of membership including geographically, members with primary students, empty nester members, members with preschool age students, members with high school students, and members with various backgrounds and areas of expertise.

Planning and Goal Setting – Mrs. Zoller reported that the committee met last week to review student performance on the report card.

Policy Review Committee – Mrs. Yee reported that the committee is scheduled to meet on October 16th.

Student Achievement – Mr. Weber reported that the committee reviewed student performance on the report card.

X. Discussion: 2023-24 Enrollment Update

Mrs. Johnson shared an update on 2023-24 enrollment. Enrollment history was reviewed back to the 08-09 school year noting the mobility of two kindergarten groups from FY18 and FY19. For the current school year, actual enrollment was compared to the forecast which is built using birth rates, enrollment ratios and mobility averages. The current 6th grade class grew 10 students (from 172 students in 5th grade to 182 students in 6th grade) which is the only grade level with mobility off-trend (trend is 5). Overall, enrollment is stable.

XI. Superintendent's Update

Mr. Weber recognized Raena Monks, WMS ELA Teacher, for receiving the most recent Wyoming City Schools Impact Award. He also shared that ODE recently released District and Building report cards and while we are excited to have 5 stars on the report card, we are most excited about student growth. We continue to dig into the data to identify strengths and opportunities. Mr. Weber also congratulated National Merit Semifinalists at WHS: Andrew Burns, Avery Feller, Carter Hagenauer, Avi Rosenberg, and Roxy Sorensen.
