### **Scholars Statement of Beliefs**

Students in the Charles County Scholars Course of Study are committed to the following:

- Challenging academic courses that focuses on advanced coursework.
  - Utilizing an academic support system that includes parents, teachers, counselors, and administrators.
  - Demonstrating perseverance in the attainment of rigorous concepts.

### **Identification in Elementary School**

In the spring of fifth grade, an articulation team recommends advanced level courses for students transitioning to middle school.

### **Middle School Scholars**

8th grade students must be enrolled in **5 of the 7** following courses to qualify:

- Advanced Math Course  
(Algebra 1 **or** Geometry Honors)
  - Grade 8 Honors Language Arts
  - Grade 8 Honors Science
  - Grade 8 Honors Social Studies
  - World Language
  - Exploring Computer Science
  - Introduction to Engineering Design

### **Recognition**

Students who take required courses and achieve a 3.2 cumulative grade point average will be acknowledged at the end of their eighth grade year. Grade point averages are determined from eighth grade quarter one to third quarter.

Participation in middle school Scholars Course of Study does not guarantee participation in high school.

### **High School Scholars**

Students must earn 18 credits from advanced courses and be enrolled in high school for four years in the following:

- 4 English (Honors, Advanced Placement)
  - 3 Lab Sciences (Honors, Advanced Placement)
  - 3 Social Studies (Honors, Advanced Placement)
  - 4 Mathematics (at least 3 must be Honors or Advanced Placement)
  - 3 World Languages - at least 2 in the same language (credit can be awarded based on successful completion of designated high school level World Language courses taken during middle school)
  - 1 additional advanced course

### **Recognition**

Students who complete courses and achieve a cumulative grade point average of 3.5 (weighted) are recognized at graduation with a medallion and notation in the graduation program. Statement of completion will be noted on final transcript.
