#### ABOUT OAKLAND SCHOOLS

Oakland Schools is a regional service agency that offers support services to school personnel that are best delivered regionally and provide cost, size and quality advantages to those we serve.

Oakland Schools is an autonomous, tax-supported public school district governed by Michigan General School Laws and is one of 56 intermediate school districts (ISDs) established in Michigan in 1962.

Oakland Schools organizes our strategies around these central objectives:

- Increase student achievement
- Serve diverse needs of schools
- Decrease costs/increase efficiencies

#### **HOW WE ARE FINANCED**

Oakland Schools is financed by Oakland County taxpayers through an annual authorized property tax millage.

The combined millage rate for 2020-2021 was 3.2012. Oakland Schools operates using three major funds:

- **1. General Education Fund** provides instructional and administrative support for districts and obtains its revenue primarily from a property tax levy. Oakland Schools was authorized to collect .1902 of a mill (\$12.0 million in 2020-21).
- **2. Special Education Fund** is supported by a tax of 2.4192 mills (approximately \$153.1 million in 2020-21) and supports Special Education administration and district services, including compliance support and district and student services.
- **3.** Career Focused Education Fund supports Vocational Technical Education administration, the four Oakland Schools Technical Campuses that serve students from all 28 local school districts at no cost to the sending districts, The County as a Classroom initiative and several specialized technical academies. The fund is supported primarily by a levy of

.5918 mills (approximately \$37.5 million in 2020-21).

In addition, Oakland Schools operates three grant funds that are actively sought out to defray costs of regional projects. Oakland Schools serves as the fiscal agent for grants that fund ongoing and pilot projects for the benefit of Oakland County students (approximately \$77.4 million in 2020-21).

#### PRO-RATED MEMBERSHIP FOR STATE AID



#### PUBLIC SCHOOL MEMBERSHIP

Public school membership reflected in this publication is the 2021- 22 spring and 2022-23 fall membership. Membership for Special Education students has been pro-rated in general education at grade levels and in Special Education categories based on the percentage of time spent in each classroom.

#### FULL-TIME EQUIVALENT AND MEMBERSHIP DEFINED

(Michigan Department of Education Pupil Accounting Manual) FTE is the individual pupil's prorated share of membership.

Membership is the full-time equivalent number of pupils enrolled and in regular daily attendance on the official count day in accordance with the State School Aid Act and Administrative Rules. In no circumstance may the reported membership for an individual pupil be greater than 1.00 FTE.

#### **EXCLUDING RESIDENCY ADJUSTMENTS**

A residency adjustment occurs when a pupil attends a district (known as the educating district) that is not the pupil's resident district, and the educating district could not obtain a release from the resident district to count the pupil in membership. In these cases, the pupil

is listed as attending the nonresident district, but their FTE is subtracted from the educating district's membership report.





## TAX VALUATIONS AND RATES

#### **TAXABLE VALUE**

Taxable Value is a property valuation calculation utilized by state and local taxing agencies to assess the prevailing tax millage rate. The difference between Taxable Value (TV) and the State Equalized Value (SEV) is the result of voter approved legislation such as the Headlee Amendment and Proposal A. Specifically, Taxable Value has been capped at the annual property value increase or an indexed formula representing an annual inflation factor, whichever is less. Taxable Value will be increased to reflect market value upon the transfer of title/ownership. Typically, for these reasons, Taxable Value lags behind that of SEV.


