It is the desire of the Hart County School Board that all students should have every possible opportunity to take advantage of instructional programs that will allow them access to the best possible education. Any distractions from a favorable teaching and learning environment lessen this opportunity. Students are expected to adhere to standards of behavior that will facilitate a positive learning environment for themselves and other students, to respect each other, school district employees, and school property. They are also expected to comply with student behavior policies adopted by the board of education, and to obey student behavior rules established by individual schools.

The rules listed in this policy apply to all Hart County Charter System schools concerning state coded discipline. The dispositions listed are recommended maximums. This list is not all inclusive, and a student committing an act of misconduct not covered by this policy will be subject to the discretionary authority of the principal. More severe punishment may be necessary.

Notwithstanding, the recommended maximum dispositions, a principal, acting through and with the concurrence of the superintendent or superintendent's designee, may refer a student to a disciplinary tribunal or to the Board of Education for disciplinary action arising out of the violation of any of these rules. Upon such referral and after proper notice and hearing, appropriate action may be taken.

Parent involvement is the most desirable avenue for correcting behavioral problems and will be used when possible. Parent conferences may be used in conjunction with other forms of discipline. Parents shall be involved in periodic revisions of the Code of Student Conduct.

Schools shall request a parent or guardian signature and or student signature, as is appropriate, in acknowledgement of receipt of this Student Code of Conduct and Discipline Procedures. Please sign and return this sheet to the student's home room teacher immediately. Please keep the behavior code for your files.

## Student Code of Conduct and Discipline Procedures

Revised July 2024



**Board Policy: Student Behavior Code****Descriptor Code: JCDA**

It is the policy of the Hart County Board of Education that each school within this school district shall develop and implement age-appropriate student codes of conduct designed to improve the student learning environment and which will comply with state law and State Board of Education Rule 160-4-8-.15. Each code of conduct shall include the following:

1. Standards for student behavior designed to create the expectation that students will behave themselves in such a way so as to facilitate a learning environment for themselves and other students. The standards should be designed also to encourage students to respect each other and school district employees, to motivate students to obey student behavior policies adopted by this Board and to obey student behavior rules established at each school within this school district.
2. Student support processes designed to consider, as appropriate in light of the severity of the behavioral problem, support services available at each school, the school system and other public entities or community organizations which may assist students to address behavioral problems;
3. Progressive discipline processes designed to create the expectation that the degree of discipline imposed by each school will be in proportion to the severity of the behavior of a particular student, the previous discipline history of the student and other relevant factors, while ensuring that each student receives the due process mandated by federal and state law.
4. Parental involvement processes designed to enable parents, guardians, teachers and school administrators to work together to improve and enhance student behavior and academic performance. The process should enable parents, guardians and school employees to communicate freely their concerns about student behaviors which detract from the learning environment.

Each school shall involve parents in developing and updating student codes of conduct. Each code shall require disciplinary action for each infraction of the code. All student codes of conduct shall be submitted to the Board for approval.

The student code of conduct shall be distributed to each student and the student's parents or guardians during the first week of school and upon enrollment of each new student. The parents shall be requested to sign an acknowledgment of the receipt of the code of conduct and return promptly the acknowledgment to the school. The student code of conduct shall be available in the school office and each classroom.

**TEACHER REPORTING REQUIREMENT**

A teacher shall have the authority, consistent with Board policy, to manage his or her classroom, discipline students, and refer a student to the principal or his designee to maintain discipline in the classroom. Any teacher who has knowledge that a student has exhibited behavior which violates the student code of conduct and repeatedly or substantially interferes with the teachers ability to communicate effectively with the students in his/her class or with the ability of such student's classmates to learn shall file a report of such behavior with the principal or his designee. The principal and teacher shall thereafter follow the procedures set forth in Georgia law, specifically O.C.G.A. 20-2-737-738.

The Superintendent and/or his designee shall develop procedures as necessary for implementation of this policy and this state law.

**FELONY AND MISDEMEANOR**

O.C.G.A. 20-2-768

Each local board of education is authorized to refuse to readmit or enroll any student who has been suspended or expelled for being convicted of, being adjudicated to have committed, being indicted for, or having information filed for the commission of any felony or misdemeanor or any delinquent act under Code Sections 15-11-602 and 15-11-707 which would be a felony if committed by an adult. If refused readmission or enrollment, the student or the student's parent or legal guardian has the right to request a hearing pursuant to the procedures provided for in Code Section 20-2-754

## **CHRONICALLY DISRUPTIVE STUDENTS**

Teachers are required to file a one page report with the principal or designee, documenting a student's violation of the Student Code of Conduct which repeatedly or substantially interferes with the teacher's ability to communicate effectively with the students in the class or with the ability of such student's classmates to learn. The report must be filed within one school day of the most recent occurrence of such behavior. The principal or designee shall, within one school day after receiving such a report, send to the student's parents or guardians a copy of the report and information regarding how the principal or designee may be contacted. The principal or the principal's designee shall send written notification to the teacher and to the student's parents or guardians of the student support services being utilized or the disciplinary action taken within one school day and shall make a reasonable attempt to confirm receipt of such written notification by the student's parents or guardians. Written notification shall include information regarding how the student's parents or guardians may contact the principal or principal's designee. Hart County Charter System's procedures for dealing with chronically disruptive students are included in the district's behavior support process, the Student Support Team (SST). Behavior plans may be included in the SST process. The Superintendent is authorized to develop procedures pursuant to OCGA 20-2-738 enabling a teacher to remove from class a student who repeatedly or substantially disrupts the class.

### **DEFINITIONS:**

**Bus Suspension** - The student is suspended from all school buses for a specified period of time by the local school administrator. The student is expected to attend school, but the parents are responsible for providing transportation to school.

**Repeated Offenses** - Multiple infractions of the Code of Conduct.

**Detention** - Student attends a work/study session outside of regular school hours. The student makes arrangements for transportation.

**In-School Suspension** - The student is removed from regular classes for a specified period of time. Class work assignments are sent to the student by the teachers.

**Short-Term Suspension** - The student is suspended out of school up to ten (10) days by the local school administrator. The student may be suspended for an accumulation of offenses, as well as a major offense. Absences are discussed in policy JB. During the term of suspension the student is not allowed on the school campus or at any school activity or school-sponsored event for Hart County Schools or any other Georgia public school.

**Long-Term Suspension** - The student is suspended out-of-school for more than ten (10) days but not beyond the current quarter or semester. The student may be suspended for an accumulation of offenses, as well as a major offense. Absences are discussed in policy JB. During the term of suspension the student is not allowed on the school campus or at any school activity or school-sponsored event for Hart County Schools or any other Georgia public school.

**Expulsion** - Expelled from all public school property and activities or events for one calendar year. This action is taken only by tribunal or action of the Board of Education. The student may be expelled for an accumulation of offenses, as well as a major offense. During the term of expulsion the student is not allowed on the school campus or at any school activity or school-sponsored event for Hart County Schools or any other Georgia public school.

1 - Expelled beyond the end of the current school quarter or semester but not permanently expelled.

2 - Permanently expelled.

**Non-Prescription Drug** - Over-the-counter drug not authorized by a registered physician and not prescribed for the student. Student use is prohibited except in accordance with local school policy.

**Prescription Drug** - Use of a drug (medication) authorized by a registered physician *and* prescribed for the student. Procedures for use of prescription medication at school are found elsewhere in Board policy.

### **Searches**

If there is reasonable suspicion the student is in possession of an item that is illegal or against school rules. Student bookbags, school lockers, desks and other school property are subject to inspection and search by school authorities at any time without further notice to students or parents. Students are required to cooperate if asked to open bookbags or lockers.

**RULES AND RECOMMENDED MAXIMUM DISPOSITIONS:**

The dispositions listed for each rule are possible maximums. This list is not all inclusive, and a student committing an act of misconduct not covered by this policy will be subject to the discretionary authority of the administration. More severe punishment may be administered in certain cases. The principal is the designated leader of the school and, along with the staff, is responsible for its orderly operation.

<b>Rule 01: ALCOHOL – State Reported</b>	Violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of intoxicating alcoholic beverages or substances represented as alcohol. This includes possession, sale, use, transmission, manufacture, purchase, or being under the influence of any alcoholic beverage, or possessing related paraphernalia during a school activity, function, or event on or off school grounds or while under school supervision.
Alcohol Level 1 - Unintentional possession <i>State Code 011</i>	
Alcohol Level 2 - Under influence without possession State <i>Code 012</i>	
Alcohol Level 3 - Sale, purchase, transportation, possession, consumption of alcohol

<b>Rule 02: ARSON – State Reported</b>	Unlawful and intentional damage or attempted damage to any real or personal property by fire or incendiary device.

1st Offense - (10) days suspension; referral to law enforcement; possible referral for alternative placement; possible referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education.

<b>RULE 03: BATTERY – State Reported</b>	Actual and intentional touching or striking of another person against his or her will or intentionally causing bodily harm to an individual. Includes an attack with a weapon or one that causes serious bodily harm to the victim. This code should be used only when the attack is very serious, serious enough to warrant calling the police or bringing in security, where the intent is to do bodily harm to someone.
Battery Level 1- Battery with no injuries <u>State Code 031</u> Battery Level 2- Battery with mild or moderate injuries <u>State Code 032</u> Battery Level 3- Battery with severe injuries; three or more offenses in same school year <u>State Code 034</u>

<b>Rule 04: BREAKING AND ENTERING/ BURGLARY – State Reported</b>	Unlawful entry into a building or other structure with the intent to commit a crime. This applies to school buildings or activities related to a school function.
B&E/Burglary Level 3- Any incident involving breaking and entering/burglary <u>State Code 204</u>	
1st Offense - (10) days suspension; referral to law enforcement; possible referral for alternative placement; possible referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education. Subsequent Offenses - long-term suspension and referral to law enforcement officials; possible referral for alternative placement; possible referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education.	
<b>Rule 05: COMPUTER TRESPASS – State Reported</b>	Unauthorized use of a computer or computer network with the intention of deleting, obstructing, interrupting, altering, damaging, or in any way causing the malfunction of the computer, network, program(s), or data.

1st Offense - ten (10) days suspension; referral to law enforcement; possible referral for alternative placement; possible referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education. <b>Rule 06-H: DISORDERLY CONDUCT/CLASSROOM DISTURBANCE – Hart Reported</b>	Any student action that disturbs the normal flow of teacher/school directed activities.
Disorderly Conduct/Classroom Disturbance Level 0 – Hart Reported - Minor First/Subsequent Offenses: – Consequences will be age appropriate. Possible action consists of behavior dispositions and resolutions codes 151 – 199.	
<b>Rule 06: DISORDERLY CONDUCT – State Reported</b>	Any act that substantially disrupts the orderly conduct of a school function, substantially disrupts the orderly learning environment, or poses a threat to the health, safety, and/or welfare of students, staff, or others.
Disorderly Conduct Level 1 - Minor disturbance <u>State Code 061</u> Disorderly Conduct Level 2 - Moderate disturbance; three or more minor disturbances in same school year <u>State Code 062</u> Disorderly Conduct Level 3 - Severe disruption; three or more moderate disturbances in same school year <u>State Code 063</u>

<b>Rule 07: DRUGS, EXCEPT ALCOHOL AND TOBACCO – State Reported</b>	Unlawful use, cultivation, manufacture, distribution, sale, purchase, possession, transportation, or importation of any controlled drug or narcotic substance, or equipment or devices used for preparing or using drugs or narcotics. Includes being under the influence of drugs or substances represented as

	drugs. Code includes over-the-counter medications if abused by the student. Also includes intentionally smelling or inhaling fumes from any substance (for example: glue, solvents) for the purpose of becoming intoxicated. Code does not include tobacco or alcohol.
Drugs Level 1 - Unintentional possession <u><i>State Code 071</i></u> Drugs Level 2 - Failure to report medication to school authorities <u><i>State Code 072</i></u> Drugs Level 3 - Possession or distribution of unlawful drugs <u><i>State Code 073</i></u>

<b>Rule 10: KIDNAPPING – State Reported</b>	Unlawful seizure, transportation, and/or detention of a person against his/her will, or of a minor without the consent of his/her custodial parents or legal guardian.
Kidnapping Level 3 - Any incident involving kidnapping <u><i>State Code 210</i></u>	
1 <sup>st</sup> Offense - referral to law enforcement officials and referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education	
<b>Rule 11: THEFT/LARCENY – State Reported</b>	The unlawful taking, carrying, leading, or riding away of property of another person without threat, violence, or bodily harm. This includes pocket-picking, purse or backpack-snatching if left unattended, theft from a building, theft from a motor vehicle, theft from a coin-operated machine, and all other types of larcenies. The Larceny / Theft code should be used only when theft is serious enough to warrant calling the police or bringing in security
Larceny/Theft Level 1 - Unlawful taking of property with a value between \$25 and \$100 <u><i>State Code 311</i></u> Larceny/Theft Level 2 - Unlawful taking of property with a value between \$100 and \$250 <u><i>State Code 312</i></u> Larceny/Theft Level 3 - Unlawful taking of property with a value exceeding \$250; three or more offenses in the same school year <u><i>State Code 313</i></u>

<b>Rule 13: ROBBERY – State Reported</b>	Taking, or attempting to take, anything of value that is owned by another person or organization, under confrontational circumstances by force or threat of force or violence and/or by putting the victim in fear.

Robbery Level 2 - Robbery without a weapon <u><a href="#">State Code 315</a></u> Robbery Level 3 - Robbery with a weapon <u><a href="#">State Code 316</a></u>

<b>Rule 14: SEXUAL BATTERY – State Reported</b>	Unlawful sexual behavior or contact with force or threat of force or where the victim is incapable of giving consent. Age of the student should be taken into account. This code should be used only when the incident is severe enough to warrant calling in law enforcement.
Sexual Battery Level 3 - Any incident involving Sexual Battery <u><a href="#">State Code 214</a></u>	
1st Offense - ten (10) days suspension and referral to law enforcement officials; possible referral for alternative placement; possible referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education. Subsequent Offenses - long-term suspension and referral to law enforcement officials; possible referral for alternative placement; possible referral to Board of Education with recommendation for expulsion pursuant to the policies of the Hart County Board of Education.	
<b>Rule 15: SEXUAL HARASSMENT – State Reported</b>	Deliberate, repeated, and unsolicited physical actions, gestures, or verbal or written comments of a sexual nature when such conduct has the purpose or effect of interfering with a student’s academic performance or creating an intimidating, hostile, or offensive learning environment. Includes any unwelcome sexually oriented communication or behavior that makes an individual feel afraid, offended, or uncomfortable.
Sexual Harassment Level 1 - Unwelcome comments not directed towards individuals <u><a href="#">State Code 318</a></u> Sexual Harassment Level 2 - Unwelcome comments directed towards individuals <u><a href="#">State Code 319</a></u> Sexual Harassment Level 3 - Violation of sexual harassment policy; three or more offenses in the same school year <u><a href="#">State Code 320</a></u>

<b>Rule 16: SEX OFFENSES – State Reported</b>	Unlawful sexual behavior or contact without force or threat of force where the victim is capable of giving consent. Code includes indecent exposure and obscenity. Includes viewing or downloading pornographic content onto communication devices on school owned or personal devices.

More severe measures, including restitution for damages, immediate referral for expulsion, and/or notification of law enforcement officials, may be taken.	

<b>Rule 106: GIVING FALSE INFORMATION - HCCS</b>	Refuse to identify himself/herself or give false identity or information upon request of any teacher, principal, superintendent, school bus driver, or other authorized school personnel. If an ID card is issued, it must be shown to school officials when requested.
First/Subsequent Offenses: – Consequences will be age appropriate. Possible action consists of behavior dispositions and resolutions codes 151 – 199. More severe measures, including restitution for damages, immediate referral for expulsion, and/or notification of law enforcement officials, may be taken.	

<b>Rule 107: FOOD AND LITTERING - HCCS</b>	Good behavior and cleanliness, including returning trays and utensils to service area and placing trash in containers provided, is expected in the dining area. Students shall eat in designated areas. The use of food items or chewing gum in the halls or classroom is not allowed unless approved by the administration or under the direct supervision of a teacher in food preparation. Littering will not be tolerated. No outside food (restaurant) is permitted at school in accordance to federal guidelines. Failure to follow this guideline can lead to disciplinary action and the discarding of the food. Cafeteria food should not leave the cafeteria at breakfast or lunch in accordance to federal guidelines as well.
First/Subsequent Offenses: – Consequences will be age appropriate. Possible action consists of behavior dispositions and resolutions codes 151 – 199.	

<b>Rule 108: THEFT – PETTY - HCCS</b>	Taking, carrying, leading, or riding away with property of another person of a value of less than \$25 without threat of violence and no law enforcement notification.
First/Subsequent Offenses: – Consequences will be age appropriate. Possible action consists of behavior dispositions and resolutions codes 151 – 199.	

<b>Rule 109: PARKING AND TRAFFIC VIOLATIONS - HCCS</b>	Students below grade ten are prohibited from driving on campus. Students must pass three of four courses during the previous semester in order to have driving/parking privileges on campus. Violations include driving too fast for conditions, reckless driving, improper parking, parking without a decal, or any behavior that might cause an accident or injury.
Vehicles may be towed away at the owner's expense. 1st Offense: \$ 15 fine and/or permanent loss of parking privileges 2nd Offense: \$ 20 fine and/or permanent loss of parking privileges Third Offense: \$ 25 fine and/or permanent loss of parking privileges Suspension may be imposed for serious violations. Law enforcement may be notified as deemed necessary.
