• Identify classroom, grade-level, and school-wide Responsive Classroom strategies and Zones of Regulation strategies to address challenges for all students, particularly those struggling with social and emotional situations due to anxiety.

Kindergarten families will also receive additional support and guidance based on the 1,2,3 Magic Parent resource kit.

• Explore and establish activities to promote inclusiveness and promote student emotional welfare throughout the school.

• Spring 2024 orientation welcoming meeting for incoming families, where we offer new parent support. Plan and host an evening for families to learn about Zones, in particular meetings for preschool and kindergarten parents.
