



# Parent and Family Engagement Policy - 2024-2025

  - The Pease parent-family engagement policy is reviewed yearly during family engagement events and at the beginning and end of each school year. Families' role in this process is to advocate for their students needs through collaboration and communication to enhance this engagement policy.

- Progress Reports every nine weeks and quarterly report cards.
