### Welcome and Introductions:

Mrs. Pivniska Petrie welcomed everyone.

Amber Hoffman was a guest at the meeting.

Ms. Sabalone reviewed the agenda and norms.

### Review and Approve Minutes:

We reviewed the minutes from the August 25, 2002 meeting.

### Public Input:
