- 1. CTC enrollment for 2015-2016 currently stands at 233 AM students and 341 PM students for a total of 574.
- 2. CTC Student of the Month for May is Miranda Garcia, a Sophomore at Scranton High School. Miranda has been recognized by her instructor, Mrs. Kristine Lenceski, in the Child Development program. Mrs. Lenceski states, "Miranda is a great and positive role model and has a bright future ahead. She is an inspiration to everyone she encounters." She is currently a member of the Scranton High School Spanish Club. Miranda would like to obtain her Bachelor's Degree in Elementary Education.
- 3. Carbondale Area School Board held their public meeting at CTC this month. Board members were provided with a dinner prepared by the Culinary Arts program and were provided with a tour of the facility.
