District Ratification and Approval of Funding Upon the recommendation of the Superintendent and on motion by Becky Backer, seconded by Dan Borden, the Board of Education of the Belfast Central School District approves the funding and ratification of the terms negotiated between the Belfast Central School District and the Belfast Teachers’ Association, The Collective Bargaining Agreement will be effective July 1, 2020 through June 30, 2024. The Superintendent shall have authority on behalf of the Board of Education to acknowledge the Agreement accordingly. Carried 5-0

MOA Teachers’ Association Motion by Becky Backer, seconded by Randa Harrington, the Board of Education hereby approves the terms of the Memorandum of Agreement between the Belfast Central School District and the Belfast Teachers’ Association providing for Teaching Assistants who are off step as of June 30, 2020 to be placed on the appropriate step according to the amount of their paid service to the district, effective July 1, 2020, and authorizes the Superintendent to execute such Agreement on behalf of the District. Carried 5-0
