3.1 **Motion by _____, seconded by _____, to approve the following personnel motions, as recommended by the Superintendent.**

- a. To appoint Jason Hamer to the position of Senior Maintenance Mechanic effective July 1, 2022, with a one year probationary appointment. Mr. Hamer will be eligible for a permanent appointment July 1, 2023.
- b. To appoint Katelyn Davis who holds an Initial NYS Certificate permitting her to teach in grades PK-6, to the position of Elementary Education Teacher in the elementary education tenure area for a probationary period of four years, to commence August 29, 2022 and to end August 29, 2026. Eligibility for tenure at the end of the probationary period is dependent on Mrs. Davis receiving APPR ratings of Effective or Highly Effective in 3 of 4 preceding years and no ineffective composite or overall ratings in the final year.
- c. To appoint Sadie Ellis who holds an Initial NYS Certificate permitting her to teach in grades PK-6, to the position of Elementary Education Teacher in the elementary education tenure area for a probationary period of four years, to commence August 29, 2022 and to end August 29, 2026. Eligibility for tenure at the end of the probationary period is dependent on Miss Ellis receiving APPR ratings of Effective or Highly Effective in 3 of 4 preceding years and no ineffective composite or overall ratings in the final year.
- d. To appoint Mary Guilford to the position of Library Media Specialist in the library media specialist tenure area for a probationary period of three years, to commence August 29, 2022 and to end August 29, 2025. Eligibility for tenure at the end of the probationary period is dependent on Mrs. Guilford obtaining NYS certification as a library/media specialist.
- e. To appoint Rebekah Brennan who has applied an Initial NYS Certificate permitting her to teach music, to the position of Vocal Music Teacher in the music education tenure area for a probationary period of four years, to commence August 29, 2022 and to end August 29, 2026. Eligibility for tenure at the end of the probationary period is dependent on Mrs. Brennan obtaining NYS certification receiving APPR ratings of Effective or Highly Effective in 3 of 4 preceding years and no ineffective composite or overall ratings in the final year.
- f. To approve Rachel Onivoqui as an instructional substitute for the 21-22 school year.
