Erin Lord addressed the Board to request a paid sabbatical leave of absence from her position of special education teacher for the fall semester of the 2014-15 school year. She stated she is in the process of obtaining an additional teaching certification in Spanish and that a leave would expedite the process by as much as one year. Mrs. Lord explained she felt this knowledge would be a benefit to the students in her classrooms and to BCS in general in the future. Also she envisions enrichment opportunities for students in younger grades in this area.

Chris Enders made the motion, seconded by Cecy Curcio, that the Board of Education of the Belfast Central School accept the treasurer's report for the month of November as presented. Carried 5-0

Mr. Lingenfelter presented the Budget Status and Revenue Status Reports, November warrants, and the Internal Claims Auditor Report to the Board for November Warrants.

Mr. Lingenfelter also presented the first look at the 2014-15 Budget with focus on general support items. No revenue information was presented.

Mr. Roche presented the discipline report for the month of December.

Mrs. May shared a note of thanks for the senior citizens Christmas dinner and stated the event was well attended and enjoyed by many.
