Mr. Lingenfelter distributed the budget status and revenue status reports, January warrants, and the internal claims auditor's report to the Board for January warrants.

Budget Status Revenue Status & Warrants

Mr. Lingenfelter provided information on the tax levy limit calculation he recently submitted to the state and the variables and formulas involved in this determination. Using the formula the state has provided, the allowable tax levy limit for Belfast Central School would be 3.62% before requiring a super-majority vote of 60%.

Mr. Lingenfelter provided the most up-to-date budget figures for the 2015-16 budget depicting changes made in line items since the last meeting. The instructional portion of the budget was presented which included: teaching/supervision, programs for the disabled, occupational education & summer school, library & audiovisual, attendance, guidance, health & psychological services, and athletics.

Mr. Roche presented the discipline report for the month of February. He informed the Board of the upcoming staff development day scheduled for March 11 with topics pertaining to technology and social networking for support staff and family engagement for teachers, aides, and office staff. He also mentioned that staff are working hard for Open House scheduled for March 12. He touched upon recently held student assemblies that dealt with internet safety and distracted driving. Mr. Roche stated that the early dismissal situation due to a water leak went well with staff making phone calls and riding buses to ensure student safety.

Mrs. May provided enrollment numbers for the past month and spring sports schedules. She informed the Board that she has spoken to legislators at the legislative breakfast in Scio and in Albany. No firm state aid numbers were available as of yet. She reminded the Board that the Fun Starts grant will be ending next June and that the home to school coordinator position is not in the budget. There may be the need for another elementary teacher as the self-contained classroom is going away and we will need more math instruction for next year as well. Mrs. May stated that the Americorps program began again in January with Megan Specksgoor filling a two part-time position slot until June. Our portion is paid out of $21^{\rm st}$ Century funds. We have a half-time slot available until next year but we will apply again for grant renewal in August.
