At 6:30 p.m., President Hull called the meeting to order.

David Hanks noted one addition.

Motion by Janine Preston, seconded by Randa Harrington, that the Board of Education of the Belfast Central School upon the recommendation of the Superintendent approve the minutes of the February 14, 2017 regular meeting. Carried 5-0

Motion by Randa Harrington, seconded by Josie Preston, that the Board of Education of the Belfast Central School upon the recommendation of the Superintendent approve the minutes of the March 2, 2017 special Meeting. Carried 5-0

David Hanks spoke about the effort necessary to put together a solid financial plan, and said that Mr. Lingenfelter works diligently to this end. Mr. Hanks also said of himself and of the district, that we are fortunate to have Robert Lingenfelter's financial guidance.

Robert Lingenfelter handed to the Board a tentative budget similar to the tentative budget previously presented. Mr. Lingenfelter explained each item that experienced a change since its original appearance. He expounded on that items significance, as well as the mechanism that effected its adjustment. Mr. Lingenfelter explained items on the list that are still in flux, and explained that we are currently unaware of what our New York State aid package will consist of. Questions from the board included an inquiry about cost as it relates to students from our district attending elsewhere, and how funds from Community Schools are allocated.

Robert Lingenfelter also provided the Board with a Comptroller Report which provided a comparison of the Western New York region to state wide numbers in the areas of: revenue, expenditure, median per pupil spending, expenditure growth, limited English proficiency rate, FRPL (free or reduced priced lunch) and child poverty, graduation rate.

Mr. Lingenfelter supplied the Board with the results of the CEP (Community Eligibility Provision) survey results. Out of the 1553 surveys sent to Belfast tax payers, 214 were returned. The tally was 36.59% of total returned surveys for the program, and 63.41% of returned surveys against the program. In response to an audience member's question, President Richard Hull stated, that if the results would had been more favorable, further consideration would have been considered. David Hanks concurred.

Mr. Lingenfelter presented the budget status and revenue status reports, January warrants, and the internal claims auditor's report to the Board for January warrants.

Mike Roche talked briefly about the discipline report, and how it has improved. Mr. Roche reminded all about the Open House slated for March 16, and invited everyone to attend. He stated that the Read Across America themed week was a huge success. Mr. Roche indicated that the advisement privilege granted to high school students has been a success, and the practice will be extended to seventh and eighth graders. Seventh and eighth graders will have the opportunity to have free time in the gym as opposed to study hall if they meet the criteria for this privilege. Mike Roche expressed the importance of standardized tests, maintaining that it is important for students to be exposed to this type of exam in the elementary grades, because as high school regent's exams are required.

David Hanks explained to the Board, that after careful review, the decision was made to move up the start date of the gym floor portion of the Capital Project 2016. He asked the Board for a short special meeting to approve bids. Mr. Hanks provided Belfast CS enrollment numbers, and let the Board know that Belfast may have a couple of girls interested in joining the Friendship girls' softball team. He also reminded board members about the April 18 BOCES Budget vote, the BOCES Annual meeting on April 5, and the ACASB Delegates Business Meeting on March 23.

Motion by Janine Preston, seconded by Randa Harrington, that the Board of Education of the Belfast Central School upon the recommendation of the Superintendent approve the legal notice of budget hearing and annual meeting for 2017.

Motion by Randa Harrington, seconded by Cecy Curcio, that the Board of Education of the Belfast Central School upon the recommendation of the Superintendent approve appointment of Kimberly LaGreca who holds an Initial New York State Teaching Certificate in science grades 7-12. Ms. LaGreca would be appointed as science teacher for a probationary period of four years, to commence on March 27, 2017 and to end on March 27, 2021. Eligibility for tenure at the end of the probationary period is dependent on Ms. LaGreca receiving APPR rating of Effective or Highly Effective in three of four preceding years and no Ineffective composite or overall rating in the final year. The expiration date of this probationary appointment is tentative and conditional only. In order to be eligible for and considered for tenure, the teacher must meet all requirements of the education law and corresponding regulations. The salary during the first year of this appointment will be pro-rated, and paid in accordance with the salary schedule as outlined in the Teachers' Collective Bargaining agreement and will be based on Step F and will include credit for master degree.
