- The following observation criteria have been agreed upon by the BTA and BCS.
  - Tenured teachers
    - Will have one unannounced observation by the superintendent to take place before the announced observation
    - Will have one announced observation by the principal to take place after the unannounced observation
    - May request a post observation meeting after the unannounced observation
      - Once all observations for the year are completed, the overall observation score will be calculated. This will ensure <u>all</u>

<u>observable teaching standards are addressed</u> <u>across the total</u> <u>number of observations for the year.</u>

- Non-Tenured Teachers
  - Will have one unannounced observation by the superintendent
  - Will have two announced observations by the principal
  - Will have a post observation meeting after the unannounced
    - Once all observations for the year are completed, the overall observation score will be calculated. This will ensure all observable teaching standards are addressed across the total number of observations for the year.
- Announced observations will have a scheduled post-observation conference with the principal. The principal or teacher may elect to have a pre-observation conference.
- If the teacher/class is doing an atypical instructional activity when the superintendent enters the classroom for an unannounced observation, the superintendent will return at a later time to complete the observation.
