

It is crazy how fast this summer has flown by, and at the same time I am very excited to share some of the new things happening at BCS for the 18-19 school year.

- All students will receive a free breakfast and lunch every day;
- We will have an iPad for every student in the building, and students in grades 5-12 will be able to take them home:
- A new digital sign will be installed in the front of the building this fall;
- A new door security system is being installed to enhance security;
- Our fitness center will be open for community use (hours and requirements will be publicized);
- Digital signs are being installed in the building to support empathy and understanding among our students and community;
- Students will have the opportunity to participate in new clubs and activities during the year;
- We have added two Robotics classes in the middle and high school grades; and
- We have added Lego League, Vex



Robotics, Scholastic Challenge, and Masterminds teams as opportunities for our students.

The safety and security of our students continues to be a priority for our district. To that end, the following changes have been made for the new school year:

- All students will enter the building through the cafeteria door.
- All guests to the building will need to have a picture ID to enter the building, which will be scanned. This includes

parents of our students.

- All offices have been moved to the gym area to increase security.
- Students who are late or being picked up early will be picked up at this new main entrance, which is by the gym, on South St.
- We have added additional and upgraded our security cameras throughout the building.

We will continue to work on building security over the next several years. We are sorry for any inconveniences our changes may make, but we must take every precaution to help our students feel safe and protected at school.

It is an exciting time to be a member of the BCS community. Our halls and many of our classrooms have been painted, classrooms and offices have been moved, and teachers have worked hard to plan for the new school year over the summer. I can't wait to see our students and families at our Back to School Picnic on August 28.

From the desk of Mrs. Hess, PK-4 Principal

It's hard to believe that summer is coming to a close and we are gearing up for another school year! Our teachers have been hard at work this summer working on many new initiatives for the 2018-2019 school year. Our first big focus this summer was providing training for our teachers, classroom aides, and our teaching assistants on our new reading assessment tool. We will no longer be using the DRA, but rather a tool from Fountas and Pinnell called the Benchmark Assessment System, or the BAS for short. Your child will be assessed with the BAS three times a year (fall, winter, spring). This assessment will identify the reading behaviors your child can do independently, as well as their instructional level based on their reading accuracy, a comprehension conversation, and a writing piece. Teachers will use this information to guide their instruction in the classroom, as well as for intervention groups.

Our teachers, classroom aides, and teaching assistants have also been trained on a new intervention program, Leveled Literacy Intervention, or LLI for short. LLI is an intervention program from Fountas and Pinnell which ties directly to the Benchmark Assessment System. LLI has over 20 years of research to support its effectiveness in moving struggling readers into proficiency. LLI lessons are designed for small groups



that move at a rigorous pace. Students are reading books, writing, and completing word work activities daily. With a new schedule that allows for dedicated reading intervention, each grade level will have the support of two reading teachers and the classroom teacher(s), as well as any classroom aides or teaching assistants working with the grade level. You may be wondering, "What if my child reads on or above grade level? What will they be doing during intervention time?" Students who are reading at or above grade level will be able to benefit from our new guided reading library, also published by Fountas and Pinnell. This library will offer staff a variety of multiple copy books at each reading level. Both LLI and the guided reading library structure their lessons similarly to help strengthen students'

reading comprehension skills, as well as allowing students to easily transition from an LLI group to a guided reading group. These skills are then assessed using the Benchmark Assessment System (BAS) to guide further instruction. By tying all of our reading assessment and intervention tools together, we will be able to improve student achievement and grow a love of reading in our students.

The students in grades PK-4 have an exciting new adventure in September as well. We are going to be launching a Positive Behavior Interventions and Supports plan, also called PBIS. The focus of our PBIS initiative is to help our students demonstrate their character in all areas of the school; from the school bus to the cafeteria to the classroom and the hallways. We will be asking the question, "What print will your PAWS leave?" as our students Practice Safety, Act Responsibly, Work Towards Success, and Show Respect. On the first day of school students will learn the expectations for their behavior in the different areas of the school as well as some fun new words like KAHFOOTY! I can't wait to see what print your child leaves!

I look forward to seeing everyone at the Back to School Picnic on August 28 from 5:00-7:00! Make sure you find me to say "Hi!" and earn your first PAWS ticket!

WELCOME BACK!

Hopefully you had a relaxing and enjoyable summer.

I hope that all students will push themselves to do their personal best in everything they attempt this year. With the continued support of our families and community, our students will surely shine.

I would like to personally invite you to visit our classrooms, volunteer at our school, and be involved whenever possible. I understand that each of us is very busy, but I believe there is no greater investment of our resources of time and energy than our children.

We will have our Back to School Picnic on Tuesday, August 28th. Our hope is that your family will join us for this event and many others as we work together to help each of our students be successful and build a sense of community together.

Just a quick reminder to consult the Code of Conduct regarding the specifics of our dress code, cell phone guidelines and school attendance policy. I have included a couple of general items from each of the policies for your family to review prior to the start of the school year.

Dress Code

Your dress reflects the quality of the school, your conduct, and your schoolwork. Students are expected to give proper attention to personal cleanliness and to dress appropriately for school and school functions. Students and their parents have the primary responsibility for acceptable student dress, hygiene, and appearance. Teachers and all



other district personnel should exemplify and reinforce acceptable student dress and help students develop an understanding of appropriate appearance in the school setting.

A student's dress, grooming and appearance, shall: be safe, appropriate, and decent and not disrupt or interfere with the educational process.

Cell Phones

Cell phones are to be turned off, and put away; in general their use will not be allowed during school hours. Examples of cell phone use include, but are not limited to, using the phone to make a phone call, texting, sending pictures, looking up information on the internet, and/or accessing social media. A student may use his/her cell phone during his/her lunch period, (please check with them to see when they eat lunch). A student may use his /her phone to make an emergency call/ text in either the school office or nurse's office provided he/she has obtained appropriate permission. In some cases, at a teacher's discretion a student may use his/her cell phone with teacher permission in a classroom for instructional purposes.

We need your support as we help our

children to become responsible users of the powerful tool they carry in their hands and pockets.

We understand that there are times when you must get in touch with your children, however, if it is a true emergency, please call the Main Office.

Attendance

School attendance is both a right and a responsibility. The District believes that the student's presence and classroom participation are critical to the educational program and, as such, are properly reflected in a student's final grade. Absences have an adverse affect on the student as well as the educational program. The Board of Education urges parents to make every effort to ensure their children's attendance. Consequently, for each marking period a percentage of a student's final grade will be based on classroom participation as well as the student's performance on homework, tests, papers, projects, etc., as determined by the school administrators and/ or classroom teacher. Students are expected to attend all scheduled classes. Consistent with the importance of classroom participation, unexcused student absences, tardiness, and early departures will affect a student's grade, including credit for classroom participation, for the marking period.

I look forward to working with you as we ensure that all our Belfast Middle & High School students have the courage to demonstrate Bulldog Pride as we look to graduate each of our students career and college ready.

WE ARE EXCITED TO BEGIN A NEW FREE BREAKFAST AND LUNCH PROGRAM FOR ALL THIS YEAR!

Every student Pre-K through 12 will receive one complete breakfast and one complete lunch at no charge everyday. A second breakfast will cost \$1.10. A second lunch will cost \$1.65 (K-4) or \$1.80 (5-12). Second meals and snacks must be paid for with cash or the student must have money on their account.

<u>In order to put money on your child's account you can:</u>

- 1) send money in with your child (cash or check) **OR**
- 2) use myschoolbucks.com

Myschoolbucks.com can be accessed through your smart phone! Please note, if your child does not have the funds for extras or snacks, they will not be allowed to charge them. There will be no charging permitted.

All children are required to complete the new simplified 2018-2019 Application for Free and Reduced Price School Meals/Milk Form. All information is confidential and used solely for New York State reporting requirements and obtaining additional funding for the district.

2018-19 New Free and Reduced Lunch Form

With the start of the CEP (Community Eligibility Program) grant that allows all students to receive one free breakfast and one free lunch, the annual free and reduced lunch application is no longer required. However, many grants offered to school districts require some form of income eligibility guidelines to verify that our district is eligible for various funding opportunities. With that in mind, we are requiring all families to fill out the much shorter version of the free and reduced application included below. Advisement Period

Advisement period is an opportunity for students to receive additional instruction and make up work as needed and is held each day from 2:45 - 3:08.

Students in grades 10 – 12 may leave school IF:

- They are not on the "D List"
- They have no outstanding discipline matters pending
- They have their own transportation to leave the school/school grounds
- A signed permission slip is on file in the Main Office

Students may NOT leave school/school grounds and then return to use school transportation at 3:08.

Students in grade 7-9 will be assigned an advisement room/location for supervision, academic support or discipline as applicable. For instance, students in good academic and behavioral standing will be assigned to a flexible setting. Students on the "D – List" or with discipline matters pending will be assigned to a structured study hall.

All students in grades 7-12 MUST report to a teacher during advisement if his/her teacher(s) request them to do so. Failure to report to a teacher when requested may result in disciplinary penalties.

BUS PICK UP TIMES

For the safety

of all our students, BCS will no longer be publishing students' bus pick up times in the school newsletter. Families will receive a letter from the school informing them of their children's morning bus pick up times.

Summer just flies by! Many families have been busy with summer soccer, time in sprinklers or pools, traveling, visits to the playground and catching up with family. Hat/Dress Down Days

On a Friday morning has your child asked you for a quarter or said they want to wear a hat in school? Maybe you've been in our school on a Friday and have noticed faculty and staff wearing jeans or students wearing hats. Every other Friday we have "hat/dress down days" where students can pay a quarter to get their hand stamped with a special designated stamp to wear a hat; faculty and staff donate money to wear jeans to school. The money we collect is donated to various worthy causes in our community. Thank you for your support as we continue our "hat/dress down days" throughout the school year.

Income Tax Code

New York State resident income tax returns IT200 and IT201 require you to enter the name and code number of the public school district where you were a resident on December 31, 2017. The Belfast Central School code number is 044.

DISTRICT TRANSPORTATION PROCEDURES

Please make note of the following regarding student transportation.

Students will have only one pickup and only one drop off address. These may both be the same or may be two different addresses. Example: a student may be picked up at home and dropped off at a childcare provider. Both addresses must be within the boundaries of the school district. We will not pick up or bus students to any other address but the two provided us. (The district will not transport students to social functions such as parties, overnights, or youth group activities.)

Should you wish a permanent change in either of the two addresses, we will make those changes upon written notification to the office. The request must be received two days prior to the requested change. Phone calls requesting changes WILL NOT be accepted. Requests for changes must be made in writing.

The only exception to this procedure will be for baby-sitting situations involving a student in grades 7-12 watching a student in our Pre K-6 program. We will allow, on occasion, either the Pre K-6 student or the 7-12 baby-sitter to change buses provided the following procedure is followed: A note from the Pre-K-6 student's parent/guardian and a note from the parent/guardian of the baby-sitter is submitted to the appropriate office by 8:05 AM the day the change will occur. The student will then be given a bus pass that must be presented to the bus driver of the bus they will be riding.

Bus drivers are not authorized to allow students who are not regular riders onto their buses without a bus pass signed by office personnel.

GENERAL NOTICE

The Belfast Central School District complies with all applicable Federal and State regulations, laws and requirements including, but not limited to the following: the Rehabilitation Act of 1973, Americans with Disabilities Act and Section 504 Laws, Family and Medical Leave Act of 1993, Education Amendments of 1972, Title IX, Civil Rights Act of 1964, Title VII, Age Discrimination Act of 1975, Drug Abuse Office and Treatment Act of 1972, as amended, and the requirements of any other non-discrimination statute(s) which may apply.

The District does not discriminate in employment practices or in the planning and implementation of its educational programs because of factors such as age, race, creed, color, national origin, sex, disability, marital status, or arrest record. Anyone wishing to obtain information or lodge complaints on the part of the school district is asked to contact the Superintendent of Schools at 365-9940.

SMOKING/ALCOHOL BANNED ON PROPERTY

Included in Education Law are provisions that impact every school district that directly or indirectly receives Federal funds. The regulations ban smoking, alcohol, e-cigarettes, vapor cigarettes, and the possession of firearms on school grounds. Belfast Central School will abide by those regulations. Everyone's assistance is necessary!

NOTICE OF ASBESTOS REINSPECTION

In compliance with the U.S. Environmental Protection Agency (EPA) Asbestos Hazard Emergency Response Act (AHERA), we performed reinspections of each of our school buildings for asbestos-containing building materials. The inspection findings and asbestos management plans are on file in the school administrative office.

The EPA requires us to perform re-inspections of the asbestos materials every three years. Six-month inspections are performed during the school year.

All asbestos material in this school remains in good condition, and we will continue to manage them in place, as recommended by EPA guidelines.

You are welcome to view these materials anytime during normal school hours (Monday through Friday 8 a.m. until 4 p.m.) The Asbestos LEA Designee is available to answer any questions you might have about asbestos in our school building; the phone number is 365-2646.

FIREARMS IN SCHOOL,

MAINTENANCE OF PUBLIC ORDER

The Belfast Central School District has adopted various Board of Education Policy statements over the years relating to various issues focusing on public order. Pursuant to various laws and regulations be advised that firearms or other weapons are not allowed on school property. Education can flourish only in an environment of mutual respect, self-restraint, civility, and trust among all groups and individuals. The failure on the part of individuals to live by our rules for the maintenance of public order and discipline will be addressed in a prompt and serious manner.

POLICY ON SEXUAL HARASSMENT

The Belfast Central School District has a policy concerning sexual harassment. The entire school and community is alerted to the fact that acts of sexual harassment are contrary to school district policy and will not be tolerated in the school district environment. In accordance with applicable laws and regulations, this policy applies to all staff members and students. Sexual harassment creates an unhealthy atmosphere destructive of the School District's educational purpose. The Board of Education will investigate alleged harassment and will affect an appropriate remedy when an allegation is determined to be valid. Such conduct violates Education Laws 3214, 3020A, and Civil Service Law 75. Any complaints are to be reported to the Superintendent of Schools who shall investigate the complaint.

PARENTS "RIGHT TO KNOW" ADVISORY

Under the federal No Child Left Behind legislation, parents are required to be given several official notifications:

1. Parents may request information regarding the qualifications of their child's Title I teachers and paraprofessional staff. Parents may request specific information as to the following: ["Title I" Teachers are those supported by Federal Title I funds]

- whether the teacher has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction;
- whether the teacher is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived;
- the teacher's college major; whether the teacher has any advanced degrees and, if so, the subject of the degrees; and
- if the child is provided services by any instructional aides or similar paraprofessionals and, if so, their qualifications.
- 2. Section 9528(a)(1) of the legislation requires that each school district receiving Title I funds under No Child Left Behind shall provide, on a request made by military recruiters or an institution of higher education, access to secondary school students' names, addresses, and telephone listings. A student or a parent may request that such information not be released without prior written parental consent. In order to make such a request, please contact the high school guidance office at 365-8297 for further information. If you do not wish to have your student's information released to the military or to colleges without your expressed permission, you must send a signed, written statement to that effect to the high school guidance office.

Under the Sex Offender Registration Act (Megan's Law) information that is disseminated to the School District regarding the presence in the community of a convicted sex offender will be communicated to staff, community, and local law enforcement officials in order to ensure that the offender does not have contact with children.

Any information that the School District receives regarding a sex offender from a source other than the Sex Offender Registry, and which is maintained independent of the requirements of Megan's Law, will be available from the District, upon written request to the District Office, in accordance with the Freedom of Information Law.

HEAD LICE PROCEDURES

Schools often experience problems with head lice when students return from extended vacation periods. If you have any reason to believe that your child may have come into contact with head lice during this vacation period, please consider checking your child's hair carefully before he/she returns to school.

The following is a listing of the procedures followed at Belfast Central School in regard to head lice.

- 1. Upon receipt by our health office personnel of reliable, confidential information, students in various classes may be checked for the possibility of head lice infestation.
- 2. Upon the discovery of head lice or nits (lice eggs), the school sends notification to all parents with children in the affected classroom(s), indicating that such a condition exists, along with recommendations for dealing with the situation. We trust that this information is helpful to you, and that you may then play a role in minimizing the possibility of contagion.
- 3. Upon the discovery of head lice or nits (lice eggs) for the third time in the same family in a given school year, county health authorities may be contacted and asked to intervene to help to remedy this situation. The family involved is informed that contact has been made.

YOU CAN HELP!

1. If you discover that your child has head lice and treat your child at home, please notify our health office that this has occurred. We will confidentially check your child upon his or her return, and we may then check the other children in your child's classroom. Please check your child's hair regularly.

2. If you feel that you have reliable information regarding possible lice infestation in any child in our school, you might also consider notifying our health office. The information will be treated confidentially.

If you have any questions at all about any aspect of head lice, please contact the Health Office.

Thank you for your continued cooperation.

HEALTH OFFICE

If a student becomes ill or injured in school or during a school activity, she or he should report to the school nurse, who will then make an assessment. When students are ill, they may not leave the building without permission. If the nurse is not in, students are to report to the Main Office. All students must be signed out before leaving school.

DENTAL HEALTH CERTIFICATES

Dental Health Certificates are recommended and kept on file for grade Pre-K, K, 2nd, 4th, 7th and 10th.

HEALTH PROBLEMS

If your child has any health problems, please let the school nurse know. This information will only be shared with those who need to know. If students have had illnesses or injuries over the summer, please inform the nurse.

We should all (well all Americans) should be proud of what we have and how much freedom we get where our women can be free and so can men and children even if our skin is different. We are all the same





Tax Information

The Belfast Central School Board of Education is scheduled to set the tax rate for the 2018-19 school year and the August 14th board meeting. This information will be included in the October newsletter.

Payment of taxes may be made during the month of September with no penalty or in October with a 2% penalty. No taxes will be collected in November at the school, by mail or at Allegany County Treasurer.

Pesticide Notification

The Belfast Central School District utilizes an Integrated Pest Management Plan that emphasizes the use of non-chemical solutions when pest removal from the district buildings or grounds is necessary. This plan is available for inspection in the district of office. This plan promotes proper storage of food items and to prevent any possibilities of unwanted pests. If it becomes necessary to eliminate pests, traps, environmental modifications, and/or mechanical means are utilized whenever possible. Occasionally, chemical pesticides may be used for serious or unsafe pest infestations for which other non-chemical means are either inappropriate or ineffective. You have the right to be informed prior to any pesticide application made to the school grounds and buildings. In certain emergencies, pesticides may be applied without prior notice.
