## Dear Belfast Community,

The BCS Board of Education and administration reviewed the District Facility plan, reviewed the building condition survey, and worked with staff members to identify work to be completed in the proposed capital improvement project. The proposed project will include window replacements for virtually the entire building. Unfortunately, window replacements were removed from the last two capital improvement projects because of the cost of other project items. As a major emphasis of the proposed project, new windows will increase energy efficiency throughout the building.

The proposed project will be critical to maintain a steady debt service for the district to have a limited impact on the BCS annual budget. The district will be paying off a previous building project. The proposed project will address the physical needs of the district, while maintaining a steady balance of building aid and debt service.

The Belfast Central School is eager to share this proposed plan with our students, families, and community. We hope you are as excited as we are to consider upgrades to the playground, athletic field, classrooms, as well as structure and safety improvements! We look forward to seeing everyone on Wednesday, October 26 in the Conference Room (South Street, Main Entrance) at 5:30 p.m. to learn all about it.

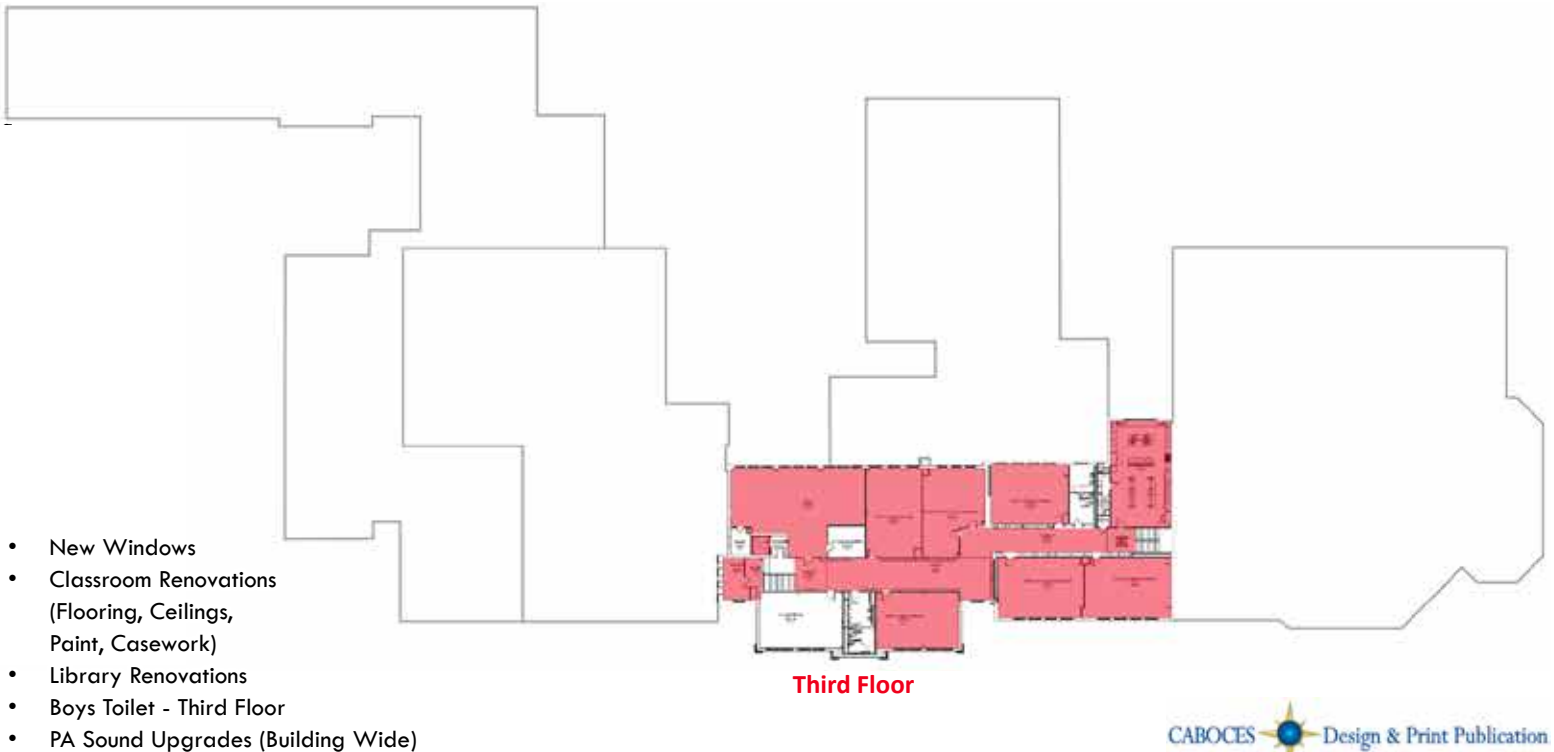

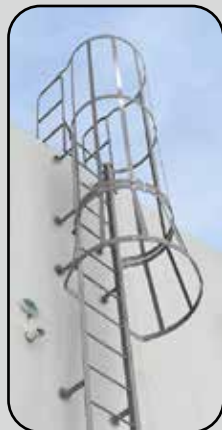
