[Rights Accorded Under Education Code Section 221.8:](#) The following list of rights, which are

based on the relevant provisions of the federal regulations implementing Title IX of the Education Amendments of 1972 (20 U.S.C. Sec. 1681 et seq.), may be used by the department for purposes of Section 221.6: (a) You have the right to fair and equitable treatment and you shall not be discriminated against based on your sex. (b) You have the right to be provided with an equitable opportunity to participate in all academic extracurricular activities, including athletics. (c) You have the right to inquire of the athletic director of your school as to the athletic opportunities offered by the school. (d) You have the right to apply for athletic scholarships. (e) You have the right to receive equitable treatment and benefits in the provision of all of the following: (1) Equipment and supplies. (2) Scheduling of games and practices. (3) Transportation and daily allowances. (4) Access to tutoring. (5) Coaching. (6) Locker rooms. (7) Practice and competitive facilities. (8) Medical and training facilities and services. (9) Publicity. (f) You have the right to have access to a gender equity coordinator to answer questions regarding gender equity laws. (g) You have the right to contact the State Department of Education and the California Interscholastic Federation to access information on gender equity laws. (h) You have the right to file a confidential discrimination complaint with the United States Office of Civil Rights or the State Department of Education if you believe you have been discriminated against or if you believe you have received unequal treatment on the basis of your sex. (i) You have the right to pursue civil remedies if you have been discriminated against. (j) You have the right to be protected against retaliation if you file a discrimination complaint.

### **Is there a statute of limitations for filing an alleged incident of harassment or**

### **discrimination?**

Consistent with the School's Uniform Complaint Procedures policy ("UCP"), any parent, guardian, individual, organization has the right to file a written complaint of discrimination, harassment, intimidation, and/or bullying on the basis of a protected characteristic within six months from the date the alleged incident occurred or the complainant first obtained knowledge of the facts of the alleged incident. The UCP sets forth procedures regarding whether a complaint can be filed beyond the statute of limitations.

### **How are discrimination complaints investigated?**

Complaints filed with School are conducted pursuant to its UCP. Under School's UCP policy, School has 60 calendar days from office receipt to investigate the complaint and to send a letter with findings to relevant parties.

During the investigative process, School shall contact complainant and other applicable parties to request documents and information. School provides an opportunity for the complainant to present evidence or information to support his/her allegations.
