

Dual Enrollment Tuition Cost for 2024-25 School Year

Starting August 21, 2024, payment for dual enrollment courses open and will close on September 4, 2024. The cost is \$43.00 per credit hour. Payments in the form of cash or checks (payable to Cave Spring High School) for the **exact** amount can be submitted to the bookkeeper during the dual class. Payments with debit/credit cards can be paid using the new Kev School Solutions School Cash online account (<https://roanokecounty.schoolcashionline.com/>), a fee will be applied to these payments.

Students must notify their school counselor if they wish to drop the Dual Enrollment Course. Last day to drop and receive a refund for Fall semester course is September 25, 2024, and for yearlong course is October 15, 2024. Last day to withdraw and receive a "W" from Fall semester course is November 20, 2024, and for yearlong course is February 10, 2025. These dates will be confirmed by August 1, 2024. Tuition will not be reimbursed after the drop date.
