



#### **ITERATIVE TIMELINE**

#### **Our configuration should...**

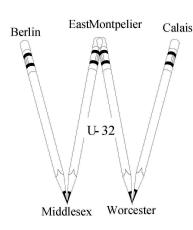
- Allow class sizes that meet Education Quality

#### Prioritized modeling:


- A middle level program for grades











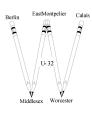

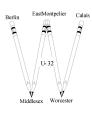




