# Flushing Middle School Targeted Title I Parent Involvement Policy

### **Part I: Policy Involvement**

- In order to maximize parent involvement, there will be flexible opportunities for parents to be engaged. There will be PWC, family and curriculum nights in the evening. Additionally, there will be Schoolwide planning meetings throughout the school year. Parent/Teacher Conferences are held in the evening, however, individually scheduled conferences occur when it is convenient for the parent. If there is an interest by a parent

group to meet anytime during the day, the principal will make the necessary arrangements. As a result, there will be a great deal of flexibility to bring parents into FMS to meet or engage in classroom activities during and after the school day.

Flushing Middle School values and respects the relationship with our parents. Parent involvement will be part of the professional development plan (see attachment). Workshops will include the value of parental contributions to the FMS program and how to reach out to parents, as partners, to strengthen it. Staff will attend workshops and implement new ideas for improving parent communication. Some focus will be on how to utilize the district website to post classroom newsletters and parent resource materials and look for ways to build ties between parents and FMS.

FMS encourages a continuum of involvement from the elementary setting to the high school setting. Transition meetings take place at both the elementary level for students entering 7th grade and then again at the high school level for students entering 9th grade. Parents who attend these transitions meetings are provided with information that pertains to the school, curriculum and activities that parents can be involved with. FMS also provides a continuum of service for students who may be medically placed in a homebound setting, students with behavioral issues may be placed in a home-based program and also students have the opportunity to participate in what is essentially an online educational setting. Within the programs, parental involvement is crucial and highly encouraged.

All ESL and migratory families will be communicated with in the language that best supports their understanding of school activities. (GISD has an interpreter that can offer assistance here.) ongoing school activities and communications, with support, will be provided accommodations (personal contact with administration, alternative opportunities to access school information) to meet all of their educational information needs. All of these families are identified in our district enrollment protocol. Flexible meeting times will be made available in order to ensure their participation in activities that will increase their capacity to assist their children when they are at home.
